### STATEMENT OF INTENT

This bill aims to increase penalties for littering by 20 percent and allocate new revenue raised from that increase to N.H. Fish and Game. The fine increase would yield only about \$5,000 per year, while costs associated with adapting the change would cost roughly \$75,000 total. Additionally, the majority was uncomfortable with a fine increase based on a percentage rather than a clear dollar amount as has long been the standard of the New Hampshire legislature. Based on these concerns, the majority believes the bill should be found inexpedient to legislate.

Dear Chairman Abbas and members of the House Criminal Justice and Public Safety Committee:

I am writing to make you aware of a concern the Judicial Branch has with regard to the proposed effective date of House Bill 1571. The current draft has a proposed effective date of 60 days after its passage. Under RSA 14:9-a "[e]ach law affecting judicial practice and procedure, or establishing or eliminating criminal prohibitions, civil causes of action or remedies, or limitations of actions, shall take effect on the January 1 following passage." Because this law would affect judicial practice and procedure, RSA 14:9-a provides that it should be effective no sooner than January 1, 2023.

The additional time is needed for the Judicial Branch to implement the collective changes that will be made to laws during this legislative session that impact criminal and civil cases. After each legislative session, the Judicial Branch must update the uniform charge table and the Judicial Branch's Odyssey database, modify or create new forms, make necessary changes to the e-filing system, and notify and train judges and staff on the hundreds of changes that affect the court system. Implementation of these changes must accurately reflect the changes in law and be properly programed into the case management database and e-filing system. Given the number of changes that must be implemented, it takes several months to complete this effort.

The Judicial Branch respectfully requests that the bill be amended to change the effective date to January 1, 2023 which will allow the Judicial Branch sufficient time to implement all of the changes described in the bills that are passed in this session.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 New Paragraph; Rules of the Road; Littering Penalty. Amend RSA 265:102 by inserting after 2 paragraph IV the following new paragraph:
  - V. Beginning January 1, 2022, the commissioner shall increase the fine for violations of this section by 20 percent and credit 20 percent of all fines collected from violations of this section to the account created in RSA 206:35-f.
  - 2 New Paragraph; Litter Control Law; Littering Penalty. Amend RSA 163-B:4 by inserting after paragraph II the following new paragraph:
  - III. Beginning January 1, 2022, the commissioner shall increase the fine for violations of this section by 20 percent and credit 20 percent of all fines collected from violations of this section to the account created in RSA 206:35-f.
  - 3 New Section; Dedicated Littering Fines. Amend RSA 206 by inserting after section 35-e the following new section:
    - 206:35-f Dedicated Littering Fines. The state treasurer shall establish a separate account to which shall be credited all moneys collected pursuant to RSA 163-B:4, III and RSA 265:102, V. The moneys in said account shall be used to support conservation officers. Said funds shall be nonlapsing and are to be expended for the purposes of this section as determined by the executive director with the approval of the commission.
- 18 4 Effective Date. This act shall take effect 60 days after its passage.

### **METHODOLOGY:**

This bill increases littering fines by 20 percent and dedicates the increased revenues to the Fish and Game Department to support conservation officers. According to the Department of Safety and Judicial Branch, based on recent littering fine collections, this change would increase revenue directed to the Fish and Game Department by less than \$5,000 per year. It is unknown how much in each year the Fish and Game Department may expend these funds.

To implement the changes in this bill, the Department of Safety estimates one-time system programming costs, to implement the changes in this bill, of approximately \$70,000, anticipated to be incurred in FY 2022. Similarly, the Judicial Branch expects one-time programming costs of approximately \$5,000.
