**Rep. McGuire** introduced the bill and spoke in favor. She said this was a recommendation of the Committee to Study Changes to the State Building Code. She explained the provisions of the bill such as updated the NFPA building code to the 2018 version, issues of sprinklers, arc-fault issues, circumstances under which a contractor can use either code version, forwarding local changes to the state board for information, requirements for periodic reviews of the building code. She took Committee questions. She added that an update to the state fire code had been intended but was inadvertently omitted from the bill. She said she would be drafting an amendment.

**Sean Toomey**, State Fire Marshall, spoke in favor. He explained how his office was involved in the development of the bill and explained the changes enumerated in the bill.

**Steve Rancourt**, Executive Director of the Electrical Contractors Business Ass'n, spoke in favor. He described the development of the bill and how this bill made various updates and corrections. He took Committee questions.

**Philip Sherman**, NH Building Code Review Board, spoke in favor. He explained the importance of the bill and provided additional details, expressed concern about the length of the grace period and the overlap with SB 433. He took Committee questions.

William McKinney, President of the NH Building Officials Ass'n, spoke in support. He expressed similar concerns as previous speakers. He took Committee questions.

**Ari Pollac**k, an attorney with Gallagher, Callahan & Gartrell, PC, as lobbyist for the NH Home Builders, spoke in favor. He described how certain compromises were incorporated into the bill.

**Chris Skoglund**, Director of Transition, Clean Energy NH, spoke in favor. He said he appreciated the energy component of the updated code.

#### Testimony on HB1681, relative to the state building code.

Dear Chair McGuire and members of the Committee,

Clean Energy NH (CENH) is a non-profit member-based organization. We are New Hampshire's leading clean energy advocate that is dedicated to supporting policies and programs that strengthen our state's economy by encouraging a transition to renewable energy and promoting energy efficiency.

**CENH supports adoption of HB1681.** This bill amends the definition of the state building code in RSA 155-A:1, I to include each of the chapters of the 2018 International Codes developed by the International Code Council, including the 2018 International Energy Conservation Code (IECC), as amended by the NH Building Code Review Board (BCRB). CENH supports adoption of the full suite of codes approved by the BCRB and offers the following information for the committee's consideration on building energy efficiency, which was highlighted as the state's cheapest and cleanest energy resource in the Governor's 2018 State Energy Strategy.<sup>1</sup>

Energy for heating, cooling, and electrical use in residential and commercial buildings accounts for about half of all energy consumed in the state. By reducing building-energy consumption, energy-efficiency measures have a direct, positive impact on public health and the quality of our natural environment. Modern building-energy codes are recognized as one of

the most cost-effective measures to reduce energy demand in the commercial and residential building sector.<sup>2,3</sup>

The adoption of the 2015 IECC by the state in 2019 resulted in a significant improvement in the energy performance of new buildings and major renovations. This increase in energy efficiency, for both HVAC and electricity use, provided an immediate energy-cost savings to building occupants and businesses. An analysis conducted by the US Department of Energy projected that residential buildings in New Hampshire, including both single and multi-family dwellings, would experience a 20.8 percent reduction in energy consumption if built to the 2015 IECC when compared to the 2009 IECC.<sup>4</sup>

The reduced energy consumption equated to an average annual avoided-energy cost of \$542 across single and multi-family homes in the southern tier of the state, and an average annual avoided-energy cost of \$693 in the northern tier. The analysis found that the energy-cost savings would result in cash positive situations within three months and would pay for the energy-efficiency measures in just three to four years. Over the life of a 30-year mortgage, homeowners were projected to realize \$8,575 in avoided-energy costs in southern New Hampshire and \$10,258 in northern areas.

Adoption of the 2018 IECC would maintain that level of energy performance and energy cost savings. As energy prices rise, as we have seen this year across all fuels, the avoided-energy cost associated with the 2018 IECC will only continue to increase. Energy codes, therefore, provide energy and economic security to building occupants, as well as the state as a whole.

Achieving these benefits is contingent on installing the appropriate measures during initial construction or major renovations. Not only do owners and occupants realize benefits from day one but incorporating energy efficiency measures at the time of construction is one of the most

cost-effective strategies for reducing fuel and utility costs otherwise borne by the consumer.<sup>7</sup> Every building that is constructed in an inefficient manner is a lost opportunity to keep more of our energy dollars in state and retrofitting a building later costs more than building it efficiently from the start.

By adopting the 2018 IECC into state statute, the legislature establishes a floor for all new buildings needed to meet, guaranteeing significant benefits for the life of those buildings. In addition to saving money for owners and occupants, the reduced energy demand can reduce energy costs for all New Hampshire ratepayers by delaying or eliminating the need for additional electric generation facilities or transmission upgrades. In turn, those saved energy dollars may be spent on goods and services that more directly support the local economy.

In previous code adoption cycle, concerns were raised about the cost to implement the 2015 IECC compared to the existing code at the time, the 2009 IECC. Much of that cost increase was a result of the significant gain in efficiency between the two codes as New Hampshire had not adopted the 2012 IECC; the increased cost of code compliance was a result of New Hampshire moving up two codes. The 2018 IECC, however, requires a much more modest increase in energy efficiency compared to the 2015 IECC, and therefore not result in significant costs to implement.

For the reasons described above, CENH asks you to find that HB1681, relative to the state building code, ought to pass.

The provisions of any other national code or model code referred to within a code listed in this definition shall not be included in the state building code unless specifically included in the codes listed in this definition.
