STATEMENT OF INTENT

This bill as amended would establish five Executive Council districts that are constructed to keep as many counties together as practicable. In this proposal, seven of the state's ten counties remain whole within council districts. District 1, for example, incorporates five entire counties: Coos, Carroll, Grafton, Belknap, and Sullivan counties, whereas in SB241, District 1 would include some or all of the towns in seven different counties. District 2, which currently slithers across the width of the state from Hinsdale and Charlestown in the west, to Somersworth and Dover in the east, would become a much more compact district under this amendment and encompass Merrimack and Strafford counties and the northwestern part of Rockingham. District 3 remains similar to the existing district, though three towns are moved to balance population shifts. District 4 becomes more compact. The only town that would not share a border with Manchester is Derry. District 5 would encompass the entirety of Cheshire County and the vast majority of Hillsborough County, including Nashua. 

MINUTES OF THE SPECIAL COMMITTEE ON REDISTRICTING APRIL 14, 2022

Chairman Barbara Griffin called the meeting to order at 10:05 AM in Rooms 201 and 203 of the Legislative Office Building. She asked everyone to join her in the Pledge of Allegiance.

Other than the regular members of the committee, Rep. Claire Rouillard sat in for Rep. Travis O'Hara, Rep. Pat Long sat in for Rep. David Cote and Rep. Kat McGhee sat in for Rep. Marjorie Smith.

Chairman Griffin recognized Senator James Gray to introduce SB 240, which redistricts the state senate. After his presentation, Rep. Lucy Weber expressed concern that her home county, Cheshire, would be divided into four senate districts. Sen Gray responded that was the result of balancing the shifts in population and the deviations. Rep. Matt Wilhelm asked why Ward 1 in Manchester was separated from the rest of the city. Sen Gray responded that it was done to avoid having incumbent senators run against each other. Rep. Connie Lane pointed out that incumbents had been taken into consideration for the state senate, but not for congress. Sen. Gray reminded Rep. Lane that a person doesn't have to live in a congressional district to represent it, but they do have to live in a state senate district to do so.

Chairman Griffin then recognized Sen. Gray for the purposes of introducing SB 241, which redistricts the executive council. Sen Gray explained that the population deviation, before the new maps were drawn, was 2.7 %. The new maps have a deviation of half that. He specifically stated that the boundaries of the new districts might appear to be gerrymandered, but that drawing maps can be messy and the senate had strived to keep the population in each district as equal as possible. Gerrymandering had been avoided. Rep. Weber said Vermont border towns that were considered weren't relevant to the overall effort. Sen Gray said that the consideration of those towns had been a request at public hearings. Rep. Weber further stated that the north country might not be very well represented in the new district one. Sen. Gray responded that it would be up to the voters there, as to whom they elected and as to where the person they elected lived. Rep. Weber asked if the maps could have been drawn differently. Sen. Gray explained that there were many ways to draw maps. Sen. Gray further said that all factors were taken into consideration in the drawing of the maps. Rep. Wilhelm asked why a floor amendment had been adopted over the original committee report on the maps. Sen. Gray responded that it was the wish a majority of the senate to do so. Rep. McGhee asked how the maps presented in the bill compared to other, fairer maps. Sen. Gray asked Rep. McGhee in response what did "fairer" mean? Many of those maps, which purported to be "fairer", had too large of a deviation. Rep. Weber noted that keeping counties together appeared unimportant, the way the districts were drawn. Sen. Gray pointed out representing multiple counties, as he does in his senate district, can be beneficial. Rep. Lane said that

fairer districts could mean they were more competitive. Sen. Gray explained fairer could also mean they were gerrymandered. Rep. Paul Bergeron asked if the council had to be redistricted, given that it already had an acceptable population deviation. Sen. Gray said that the numerous concerns that had been expressed about the layout of district two had been a big factor in doing so.

Dear House Special Committee on Redistricting,

I want to thank the committee for the opportunity to comment on the proposed Senate and Executive Council maps. I sincerely hope that you will take my comments and the comments of other Granite Staters into consideration before you finalize your decisions.

My Republican parents raised me to believe in the power of the vote, and in the importance of civic participation. As I grew and my understanding of politics changed, my political alliances shifted more to the left. This led to ardent and at times heated debates around the dinner table! My family often disagreed about policy, but we were united in our belief that participation by voting was an essential civic responsibility and a fair and just way to determine the leadership of our town, our state and our country.

Today, I find myself doubting that our elections are fair. I am deeply disturbed and disheartened by the majority party's proposed Senate map, SB 240 and Executive map, SB 241. This map has been amended; but it is not improved. I am urging all my Republican and Democratic friends to speak out about these maps.

According to the Senate election data from 2020, the NH senate races have the potential to be competitive. In 2020 49.8 % of the vote went to Democrats, and 50.2% Republicans. If the breakdown of Republican and Democratic voters holds true through the 2022 election, you would expect the Republicans to capture slightly over 50 % of the 24 seats.

Instead, Senator Gray and the majority have taken the already gerrymandered and unfair map created in 2010 and made it worse. They have succeeded in splitting and packing districts in a way that will assure that Republicans gain more than their fair share of representation. Under this plan, the Republicans will more than likely capture 15 seats leaving the Democrats 9. This does not reflect the actual breakdown of voters in the state. In addition, this map ignores communities of interest; it is clearly drawn for the sole purpose of partisan gain.

The majority plan for the Executive Council SB 241 has the same problems. It takes a bad map drawn in 2010 (that even the Republican Governor recognized needed to be fixed,) and makes it worse.

If you support these clearly gerrymandered maps, you run the risk of losing all credibility with voters and increasing the divisions already existing between parties in this state.

Voters want competitive districts, and we know that competitive races bring out the best candidates and increase voter participation.

Voters want the members of their senate, Republican and Democratic, to work together to solve problems. Please work together and solve this problem now! I ask that the this committee reconsider the maps currently proposed and support the maps created by the independent nonpartisan group Map-a Thon.



The Democrats' proposal for the Executive Council districts has five relatively competitive districts, with District 1 as a very competitive district. This map overall has a slight lean towards Republicans but is overall very competitive. The map appears to have been constructed to keep counties together and does an excellent job at this by keeping 7 of the 10 counties together. In doing this it does a competent job of keeping High School SAUs together, but it was clear that this was not the initial intent of this map. The compactness of these districts is very good with a score of 51 from DRA.



Chair Ms. Barbara Griffin, Members of the Redistricting Committee, thank you for taking time to read my testimony concerning SB241.

To quote a proverb: two wrongs don't make a right

The fact that someone has done something unjust or dishonest is no justification for acting in a similar way. This proverb is being used about the proposed redistricting of the Executive Council, specifically District 2.

District 2 was not redrawn well ten years ago, and the proposed map is worse. Using the Town of Littleton and the City of Keene as an example; they should not be in the same district, and neither are satisfied being lumped together.

Just because gerrymandering has been done before doesn't make it a standard. Repeating myself from previous testimonies: the legislature does not choose their voters and the voters must choose who they want to represent them.

SB241 must have amendments to eliminate the gerrymandering. District 2 is packed with Democrats. District 4 is packed with Republicans.

NHPR reported yesterday morning about the congressional redistricting. Chair Griffin and Redistricting Committee, **fair maps are needed**.

N.H. Supreme Court names special master, sets dates in redistricting suit by Josh Rogers

The New Hampshire Supreme Court has named a special master and set court dates to resolve a lawsuit over congressional redistricting should Republican lawmakers and Gov. Chris Sununu remain at an impasse over a new congressional map for the state.

The Supreme Court said assigning a master for the case, Stanford Law School professor, Nathaniel Persily, and setting a timetable for hearings, are "preliminary steps" that "in no way precludes the legislature from enacting a redistricting plan."

The lawsuit triggering the court's actions was brought by former New Hampshire House Speaker Terie Norelli and several other plaintiffs last month. They allege holding the 2022 elections under current maps would violate the Constitution due to population changes over the past decade.

Their suit was filed last month, shortly after Sununu threatened to veto the map backed by the Republicans in the Legislature.

Sununu had long made clear his distaste for that map, which would move about 25% of New Hampshire voters from one district to another and tilt the 1st District more Republican and the 2nd District more Democrat.

Sununu said enacting the map would be to effectively guarantee a Republican win in the 1st District, and a Democrat in the 2nd District. New Hampshire's 1st District, in particular, has seen both parties win elections over the past two decades. Democrats have held the 2nd District since 2012.

"The proposed Congressional redistricting map is not in the best interest of New Hampshire, and I will veto it as soon as it reaches my desk," Sununu said last month, after the map cleared the state Senate. "The citizens of this state are counting on us to do better."


Sununu later proposed his own map, which no lawmaker has since endorsed. Both sides remain at a standstill, with no public timeline for negotiations.

Under the Supreme Court's timetable, parties to the case -- including the plaintiffs, the House, the Senate, and Secretary of State, as well as any intervenor -- must file briefs by April 25.


The Court set a May 4 hearing for oral arguments on "preliminary issues," followed by a hearing before the special master on May 19.

Oral arguments on any map created by the Special Master would take place May 24.

Dear Members of the House Redistricting Special Committee,

I urge you to reject the redistricting maps: Senate (SB 240) and Executive Council (SB 241). Both maps reflect political gerrymandering, drawn to favor partisan interest while failing the needs of the state.

Citizens across New Hampshire, such as I, learned a lot about political gerrymandering this year, spoke at hearings, and submitted testimony striving for fair maps. The non-partisan NH Map-a-thon Project demonstrated what is possible and, indeed, preferred: competitive districts that reflect the practical needs of our communities and regions and the interests of all voters.

The Senate and Executive Council maps are partisan maps, giving substantial advantage to Republicans, although we live in a purple state. I see only four competitive seats out of 24 in the Senate maps. How can that be! I live in District 8, which will be more skewed than before, giving a more significant advantage to the incumbent Republican.

The Executive Council map has gone from bad to worse. The 2011 map, once described by the Governor as "funky," is now shameful, designed to help the politicians in power. I live in District 1, drafted (in the amended SB 241) to thwart a former Councilor, who served from 2019 to 2021, from running from his current hometown of Hanover. For Republicans living along the western part of the state they've been thrown under the bus, moved into a non-competitive Democratic district.

I am writing to voice my opposition to SB 240 and 241, concerning the apportionment of state senate districts and executive council districts respectively. The State Constitution also places a great deal of trust in the legislators of the General Court to perform their duties in the service of the people and for the general good, rather than for personal or partisan gain. I am concerned that the districts proposed in these bills were constructed to protect incumbents and to promote national partisan interests rather than to ensure community representation or otherwise advance principles of good government.

Unfortunately, despite having public comment sessions, the process by which these bills were drafted and the principles underlying them are opaque. The justifications for the choices made tend to be weakly defended in floor debate after the bills have been proposed, if they are defended at all, with no supporting evidence from the drafting process.

The people of New Hampshire deserve a redistricting process that is transparent and designed to promote good governance, not political interests. Until the public can see what research went into the bills, and what principles underlie the design process, I cannot support SB 240 or SB 241.

Re SB240 and SB241, Senate and Executive Council redistricting

Here in New Hampshire the non-partisan League of Women Voters has been involved in the fight for fair elections and for the Fair Maps that make them possible since 2004, when we adopted a position in support of an independent redistricting commission. In 2019 and 2020 the NH senators and representatives actually passed such legislation with bi-partisan support, but the bills were vetoed.

It's 2022; we are still committed to Fair Maps. Our members and many other New Hampshire residents care about redistricting. We attended and testified at the listening sessions in the counties last fall, and we are signing in or testify on the specific redistricting plans.

But at this point I personally am discouraged. What the House and Senate Special Committees on Redistricting have said and what they have done simply do not match.

"It's all about the numbers" Congressional map:

Last August the House committee's chair in a public hearing said "It's all about the numbers." Yes, redistricting is about making districts as nearly even in population as possible, so that each person's vote has the same weight as every other person's vote. But we must ask, if "it's all about the numbers" why would the committee recommend and the legislature pass a Congressional map that has a greater population difference between the two proposed districts than an alternative plan to shift the district lines so that only one town would be in a different district and the difference between the two districts would be only 50 people?

Communities Of Interest:

Last November the chair of the Senate Special Committee on Redistricting declared his committee's work done for now because they wanted to respect the House map's grouping of Communities Of Interest [respecting Communities Of Interest means grouping small towns when necessary for House seats so that such things as shared school districts, healthcare providers, and fire/police protection would be preserved in the district groupings.] The Senate Redistricting Committee implied it cared about such things and would apply them to the Senate and Executive Council maps they would create.

Executive Council maps as passed by the Senate:

But when those maps finally appeared in January, the Executive Council map was the exact one that has been in use since 2011 because, as the chair said, "The numbers work out." Those 2011 maps were not drawn with Communities Of Interest in mind, as we all know. 2011 maps were drawn in secret by a small group of legislators from one party so that four of the five districts would more likely elect

Republicans. This was accomplished by "packing" as many Democrats into District 2 as possible. That map has been criticized and mocked as the gerrymandered dragon ever since.

Hue and cry from the public, and the Governor is sniffing the proposed plans to see if they pass the gerrymander smell test. Then the Senate amends its own plan and proposes an Executive Council map that changes the outlines of district 2 significantly. It is now more Democrat-leaning than even the 2011 map. The Senate did this by including in District 2 the five college towns of Hanover (Dartmouth), Plymouth, Keene, Henniker (New England College) and New London (Colby Sawyer College). District 2 as proposed stretches from the Coos/Grafton border east to Holderness, curves around and south almost to Manchester, then down to the Massachusetts border.

As if that "packing" of Democrats were not enough to give the Republicans the advantage in nearby districts, the new map's District 1 no longer includes the hometown of the Democrat who twice won that seat (in 2014 and 2018) and who said last October he would again challenge the Republican incumbent Executive Councilor from District 1. Free ride for that incumbent! And an easy win for any Democrat from District 2.

The effect is an Executive Council map that has one nearly guaranteed Democrat district, one very strongly Republican district, and three districts that lean Republican by anywhere from 3 to 7 percentage points (see Mapathon analysis).

"It's all about the numbers" Senate map:

If "it's all about the numbers" why is the Senate redistricting map less competitive than ever in recent memory? Why are only four of our 24 Senate seats considered party "toss-ups" by a non-partisan analysis? How could the numbers dictate a partisan lean of 15 seats Republican to 9 Democrat when the voter turnout in 2020 was almost equal between Republicans and Democrats? How could the partisan "lean" be up to 40% in seven districts (Districts 3 and 5 lean strongly Republican; Districts 4, 5, 10, 15 and 22 lean strongly Democrat) unless there is something other than population numbers dictating the district lines?

Senate districts were drawn to partisan advantage in 2011, as shown in the NHPR study published in 2016. The charts from that study are in the addendum. They have gotten even more skewed in this map under your consideration. https://www.nhpr.org/the-exchange/2016-04-20/redistricting-in-a-swing-state-n-h-s-party-politics


What is the effect upon voting?


We may get to the point where the only election that really matters in choosing our legislators is the party primary. Typically turnout for the fall primaries is 15%. Will our legislature be chosen by just a tiny fraction of committed party members?


A number of other election law bills this year were proposed to "restore the public's confidence in our election system." But when legislative districts are drawn to predetermine the party that will emerge victorious, then only a tiny fraction of the ballots cast in all elections really matters, and those are, for the most part, cast in the party primaries. So how does that restore confidence in our elections? Are we looking at the "Grand Scheme For Depressing Voter Turnout" when we see partisan gerrymandered maps working their way through the legislature?

We are holding you, the legislators, accountable for this. You are here with the votes of Democrats, Republicans, and "undeclareds." We expect you to respect the interests of all in creating Fair Maps.

TESTIMONY in Opposition of SB 241

Dear Rep Griffin and Members of the Special Committee on Redistricting:

My name is Olivia Zink, Executive director of Open Democracy Action, a pro-voter, nonpartisan nonprofit based in Concord. I live in Franklin NH

First, I'd like to say a word about the Map-a-Thon Technical & Mapping Team. There was a time when redistricting maps could be created, and the public would know nothing about how or why it was created. No more. Due to the talents of our engineers, data analysts, and GIS mapping specialists, we know how and why maps are designed the way they are. So when we determine whether a map is competitive and fair for both parties, we know what we're talking about. And when we draw our own maps, we also tell you exactly how and why we draw our maps, and share the analysis with the public. And our understanding about how mapping should be done is rooted in redistricting best practices and communities of interest whenever possible. You have before you a report comparing the majority, minority and Map-a-Thon proposals.

The majority in the state Senate passed a new Executive Council map with a floor amendment, without a single public hearing on the proposal.

District 1 underwent significant changes, losing most of the communities in the Western part of the state including Claremont in Sullivan County and Hanover, Lebanon, and Littleton in Grafton County. It retains all or almost all of Coos, Carroll, and Belknap Counties. The district now extends farther into Strafford County, gaining the cities of Rochester, Somersworth, and Dover, as well as the college town of Durham.

While District 2 changes shape significantly, it maintains its overwhelmingly Democratic partisan lean. Instead of running from Vermont to Maine, it now runs from the Massachusetts border to the bend in the Connecticut River at the top of Grafton County. The district gained the cities of Claremont and Lebanon, as well as the towns of Hanover, Littleton, Peterborough, and more. It now encompasses almost the entirety of Grafton County as well as the town of Carroll in Coos. It lost its entire portion of Strafford County, with the Eastern edge of the district now stopping in Concord.

District 3 remained exactly the same as it has been for the last decade, and District 4 remains nearly identical, just gaining the towns of Barnstead and Strafford from District 2. District 5 remains very similar to the current version as well, with the biggest change coming from losing the Democratic town of Peterborough.

I'd like to now turn to Governor Sununu's March 9, 2021 comments on New Hampshire Public Radio's The Exchange about the redistricting and specifically the Executive Council map.

NHPR's Question: "We received a lot of questions about redistricting. Here's one from Anne: Will you insist that the legislature's redistricting committee uses a fair and transparent process for drawing the maps and also says, will you reject their work if it turns out to be gerrymandered and or has not allowed for sufficient public comment?"

Sununu: "The answer is yes and yes. It has to be transparent. In our entire state, I think there are a couple of districts you could point out that are really funky. Everyone could point to Executive Council district two. And I agree. That's got to be fixed. It's a weird one. It's like a snake lying across the middle of the state. Very bizarre. But I think for the most part -- the House and the Senate districts -- I can't think of any that are really out of whack. We'll look at the population. The House has their process and they put this committee together and it has to be done in a bipartisan way and be transparent. I always say with redistricting, it's got to pass the smell test. You've got to be able to look at the map and say, OK, at first blush, this makes general sense. We're not, like, twisting around here and there. Whatever we do, it has to be fair, it has to be balanced."

Senators, SB 241 does not meet any of the Governor's criteria. It is not fair or balanced, and has to be fixed. I would add that the NH Senate map was really out of whack in the last redistricting cycle and SB 240 is far worse now. The smart, competitive choice that's in the best interests of the voters is the Map-a-Thon's map. But in lieu of that, we would urge you towards an amendment, which would serve ALL the voters of New Hampshire.



The Democrats' proposal for the Executive Council districts has five relatively competitive districts, with District 1 as a very competitive district. This map overall has a slight lean towards Republicans but is overall very competitive. The map appears to have been constructed to keep counties together and does an excellent job at this by keeping 7 of the 10 counties together. In doing this it does a competent job of keeping High School SAUs together, but it was clear that this was not the initial intent of this map. The compactness of these districts is very good with a score of 51 from DRA.




