ANALYSIS

This bill authorizes the New Hampshire Towing Association and JESUS aCROSS the Border to issue decals for multi-use decal plates.

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT authorizing certain organizations to issue decal plates.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Paragraphs; Mutli-Use Decal Plates; Authorized Organizations. Amend RSA 261-B:9 by
2 inserting after paragraph XVII the following new paragraphs:

3 XVIII. The New Hampshire Towing Association.

4 XIX. JESUS aCROSS the Border.

5 2 Effective Date. This act shall take effect 60 days after its passage.
