### STATEMENT OF INTENT

This bill proposes to eliminate the requirement that absentee ballots be inserted into outer envelopes, unless such ballots were mailed to the town or city clerk. The bill would have also allowed the clerks to open the outer envelopes prior to election day which would give the clerk the opportunity to attach the application and potentially allow applicants time to cure defects. During the hearing on this legislation, concern was expressed that visually impaired voters would possibly be disenfranchised. That would be because there is an additional affidavit that must accompany their ballot and which must be completed and signed by the person who assisted them. That affidavit is an additional piece of paper in the outer envelope and it could get lost if the envelope was opened prior to election day. An agreement entered into between the State of NH and several groups representing visually impaired individuals (those experiencing "print disabilities") on October 1, 2021, specifically required the State of NH to accommodate the visually impaired, which this bill could undermine. Further, any preprocessing of absentee ballots raises questions of ballot security in terms of how such preprocessed ballots are stored. Depending on when an absentee ballot was returned, all voters would not get an equal opportunity to cure the defects of their ballot.

## STATEMENT OF INTENT

Completed absentee ballots submitted by voters to their town or city clerks (other than those submitted by overseas voters) are enclosed in a signed, affidavit envelope which are then sealed within a larger return envelope. This bill would add space on the affidavit envelope for the voter to include his or her address, which is not required at the present time. Currently, when a town or city clerk receives an absentee ballot from a voter, the clerk is required to attach the voter's absentee ballot request form to the outer return envelope in preparation for delivering the absentee ballots to the polls on election day. Under the provisions of this bill, the clerk would be authorized to remove the affidavit envelope from the outer envelope and attach the absentee ballot request form directly onto the affidavit envelope. Similarly, if a voter hand-delivers his or her completed absentee ballot to the clerk, the voter can simply submit the ballot in the affidavit envelope. There is no requirement that the voter insert the affidavit envelope into another larger envelope before handing the sealed ballot to the clerk. As the prime sponsor of this bill noted, as long as the ballot stays in the sealed affidavit envelope, there is no reason for the outer envelope, and taking the affidavit envelope out of the return-mail envelope will save election officials considerable time doing so at the polls on election day.

#### Senator James Gray - Dist. 6

- Big success last election of pre-process Absentee Ballots. Well received.
- Absentee Ballot, open outer Envelope, identify signatures, ability of voter to correct if any errors on ballot.

TESTIMONY

- Why outer envelope? Need a place for the stamp and address. But in person AB, they don't need outer envelope. This way clerk can secure the ballot and ability to correct if necessary.
- Not needed for AB process. Disability people would like form to be attached to application, staple to it. Clerk said to include address which is included in Bill.
- We have injunction with court to check signatures.
- Court says give person ability to go back and correct if needed.
- As moderator I would look for reasons to accept versus reject affidavits.

#### Karen Rosenberg & James Ziegra (Staff Attorney) - Disability Rights Center NH

- There may be risk for votes not counted. Concern as written.
- Program -accessible AB Ballot sent to them and separate affidavit. Print out both put ballot in envelope.
- SOS separate outer envelope concern because some can't sign out envelope.
- Oversight with bill voters instructed outer envelope and affidavit come separately.
- There's no way to attach this. Clerks when processing AB, affidavit may get lost, vote may not count. Address this concern
- I brought one paragraph Amendment for this Bill.

#### Rep. Griffin

- Question: Any provision for Pre Processing on that procedure?
- Answer: Just don't want affidavit separate from AB Ballot.

#### Rep. Hayward

- Question: What you describe to me, is it required as a RSA or better served as an exception by SOS?
- Answer: Could be in SOS manual for local guidance on Absentee Ballots; the concern is if not codified Election, clerks are not trained to look for this application. Section IV attaching AB to Ballot.

#### Rep. Hamblet

- Question: I'm confused doesn't it have to be in pre processing ballot?
- Answer: Perhaps I misspoke and clerks open outer envelope. I'm concerned affidavit might get lost

#### Rep. Griffin

My town will not be pre processing, feel it creates more problems.

#### Rep. Muirhead

- Separate AB Affidavit
- It's in outer envelope. Private
- Your amendment proposes ambiguity what to do is already in RSAs.
- Answer: Statues have not been addressed

### Patricia Lovejoy - Sr. Deputy SOS'

• Answer: What last speaker mentioned on ability for someone usually impaired. Clerks are being informed to keep print affidavit with it.

#### Rep. Griffin

- Underlying statue we're amending is not in effect.
- Answer: You submit AB by mail, open outer envelope. Clerk would not XX vote to come in Clerk opens envelope would find this affidavit
- When someone using this process, they are not able to do the envelope process. Printed offput in affidavit envelope, no ability to process. SOS does not have this, but would now be able to.
- Affidavit person or assisting person print, put into outer envelope to Clerk. When clerk opens AB Ballot, inside envelope slit open look at affidavit envelopes.
- If you're voting in person AB, don't need outer envelope.

#### Rep. Griffin

- Clerk allowed as it is now to open outer envelope. They don't look. The problem their trying to address by this Amendment SB365 not in law currently, on Election Day, slitting open envelope.
- The issue becomes, if it is looked at before Election Day, as I understand it -the affidavit, printed separately there is no place in law to keep it with envelope.
- If pr-processing between time pre process and election, affidavit misplaced problem?

#### Patricia Lovejoy

Answer: Last Election, pre-process many towns. They found separate affidavits envelope
problems. Some just forgot to sign it. Easy to contact person few days to connect. If you
open everything on Election Day, ability for voter to cure is a problem.

#### **ANALYSIS**

This bill removes the requirement that absentee ballots be placed in outer envelopes unless such ballots are mailed to town or city clerks. The bill also allows clerks to open outer envelopes to allow applicants time to cure defects.

III. Return envelopes of size sufficient to contain the preceding envelope addressed to the town and city clerks of the state in which absentee voters shall return their ballots, if such ballots are returned by mail. On the envelopes shall be printed "Enclosed is the ballot of an absentee voter" and, at the top thereof, 4 blank spaces with the words "Name, Voting Address, Ward, Town or City" appropriately printed thereon. Absentee ballots returned to town or city clerks in person shall not be required to be placed in such outer envelopes.

2 Absentee Voting; Refusal to Certify; Procedure. Amend RSA 657:16 to read as follows:

657:16 Refusal to Certify; Procedure. If he or she refuses to certify the application, the town or city clerk shall notify the applicant in writing within 7 days to that effect. The town or city clerk shall provide the applicant with an absentee ballot and a notice that the ballot will not be counted unless the applicant submits the documents necessary to complete an absentee registration. The applicant shall be advised in writing what documents, if any, have been received in proper form and which the applicant must submit. If the applicant submits such documents via mail, he or she shall do so by enclosing them in the outer envelope that contains the absentee ballot envelope. An applicant hand delivering such documents need not enclose them in the outer envelope. The town or city clerk shall mark the absentee ballot application, the absentee ballot affidavit, and the outer envelope, if applicable, with the words "Not Registered." Upon receipt of [and a mailed outer envelope marked "Not Registered," the clerk shall open the outer envelope. If the applicant returns the required documents with the absentee ballot by the date set for correcting the checklist under RSA 654:27 and RSA 654:28, the town or city clerk shall forward the registration forms to the supervisors of the checklist and, if the applicant is found to be qualified, the applicant shall be registered and his or her absentee ballot shall be processed in the same manner as the absentee ballot of a previously registered voter. All documents received after the deadline for correcting the checklist under RSA 654:27 and RSA 654:28 shall be processed as election day registrations under RSA 654:7-a. If the ballot is returned without the required documents in proper form, the ballot shall be marked in the manner set forth by law for successfully challenged absentee ballots and preserved in accordance with RSA 33-A:3-a. The clerk shall preserve the application of any applicant who is not registered as a voter until the time set by law for the destruction of the ballots after the election at which time the application shall be destroyed. Any justice of the superior court has jurisdiction in equity upon such notice as he or she may order to require that the name of the person making application for an absentee ballot be placed upon the checklist or registered as a member of any party and be sent an absentee ballot.

- 3 Absentee Voting: Procedure by Voter. Amend RSA 657:17, I to read as follows:
- I. After marking the ballot, the voter or the person assisting a blind voter or voter with a disability who is unable to mark his or her ballot shall enclose and seal the same in an inner

envelope. The voter shall execute the affidavit on the envelope. A person assisting a blind voter or voter with a disability who needs assistance executing the affidavit shall sign a statement on the affidavit envelope acknowledging the assistance. If the voter or the person assisting the blind voter or voter with a disability who needs assistance is mailing the absentee ballot to the town or city clerk, the voter or the person assisting the blind voter or voter with a disability shall enclose and seal the inner envelope with the affidavit in an outer envelope. The voter or the person assisting a blind voter or voter with a disability shall then endorse on the outer envelope the voter's name, address, and voting place. The absentee ballot shall be delivered to the city or town clerk from whom it was received in one of the following ways:

- (a) The voter or the voter's delivery agent may personally deliver the envelope, in which case the voter or the voter's delivery agent need not enclose the affidavit envelope in the outer envelope; or
- (b) The voter or the person assisting the blind voter or voter with a disability may mail the ballot and affidavit envelope within the outer envelope to the city or town clerk, with postage affixed.
  - 4 Absentee Voting; Procedure by Clerk. Amend RSA 657:18 to read as follows:
- 657:18 Procedure by Clerk. Upon receipt of an outer envelope purporting to contain an official absentee voting ballot, the clerk of the city or town shall, subject to RSA 657:16, open the outer envelope and attach thereto the application for an absentee ballot submitted by said voter and record the information pursuant to RSA 657:15. [All-such envelopes] The affidavit envelopes shall be preserved unopened until election day.
  - 5 Processing Absentee Ballots. Amend the introduction to RSA 659:50, I to read as follows:
