Rep. John Lewicke for Science, Technology and Energy. This bill is enabling legislation to allow cellular service providers to work with municipalities to expand service to areas that are presently unserved or under served. As amended, the bill creates a Wireless Deployment Initiative and Grant Fund. It will create no cost to the state. 14	Hampshire. A grant program using a competitive award process is essential to a wireless
15	infrastructure deployment initiative throughout New Hampshire. This fund would invest in capital
16	assets designed directly to support work, education, safety, and health care-related services.
17	2 New Subdivision; Wireless Deployment Initiative and Grant Fund. Amend RSA 12-O by
18	inserting after section 64 the following new subdivision:



Senator Jay Kahn – This bill is motivated by the fact that you can drive anywhere in NH and find dead spots. Cell service may touch many communities but spotty service. Whether federal money, state funds down the road, or partnerships. It is enabling legislation, not providing funding yet. This bill establishes a fund in broadband fund which was established in HB 2 last year. Working with providers. Rather than establishing multiple purposes, this is simply a wireless deployment initiative. One small town can receive 911 calls but can't respond. Broadband fund – Business & Economic Affairs taking the lead, waiting for result from this bill. Vose – no amendment language today, will come, maybe by end of day. Sets up a wireless matching grant initiative. Thomas – By setting up this fund, does this mean one time grant for government, would providers match provide enough customers to make it a going concern? Answer – pursue with providers. Some areas unserved with not much revenue, others like Derry hae holes to fill. Harrington – Line 3 " a municipality is an area lacking cell phone service – Could municipality apply for the grant? Yes. It needs to recognize unserved and served inconsistently. Harrington - what is criteria - only one location unserved? A lot needs to be sorted out with rulemaking process, setting what criteria will be for award. Cali-Pitts – We provided legislation whereby municipalities could bond for broadband - not enough customers to make it worthwhile. Who would be responsible for infrastructure and maintenance? Answer – with providers. Service is not to a point of delivery. Town will participate. Rep. Parshall – Marlborough – elected to do broadband. This is different – not to a specific user, not limited to one municipality. Town control through zoning, permitting process. Cali-Pitts – service to customer, correct? Answer - Yes. Vose - Amendment - in Dept. of Business And Economic Development there will be a wireless Fund. Lewicki – People should not be on cell phones while driving, will this encourage bad behavior? Answer – not to have hands on cell phone, but Bluetooth technology allows hands free. McGhee – We had a bill earlier this session on relieving carriers of last resort on premise of alternate services, this bill makes clear still not entirely true? Answer – previous bill also included broadband. This will help cellular. It will help universal service. McGhee – younger generation doesn't have landlines, don't connect unless for computer connectivity. Importance of wireless indicated. Yes. Vose – NH will receive somewhere around \$150 million Federal finds for Broadband? Could wireless also try? Answer = don't know. Rules are in process of being written. Parshall – Concern is that young people using wireless services, we need to ensure 911 service is available throughout state. Would this be a priority in bill? Answer – rule development will determine. Merner – Coos county – You can't hard wire – hilly, roomy. Hope money can come to wireless. Pimental – concern – rulemaking who is going to make rulemaking. Some towns can't do without grant money. How do we keep towns asking for money when they don't need it? Answer – process will need to be developed.

Owen Smith, AT&T. Supports wireless grant fund. A letter from CTIA submitted – for wireless providers – for bill. Wireless record year during Covid 2020. 65% or more wireless only. Here in NH about half. We appreciate intent, worked with him on the amendment, make original bill more defined. A separate wireless fund. We have become dependent with Covid. Wireless had 25-30% growth overnight. Federal funds unclear whether can use for wireless. 5G can meet speeds, 4G / LTE can't. Invested \$120 Million on network over last 2 years, well over 50 Cell sites. Still towns that need better cell coverage. Nelson is one. Parshall - Concern place like Nelson no return on investment, but 911 important. Concern places like Nelson to continually be underserved. Intent of bill is good? Could bill be tweaked to help this? Answer- Bill written that way. Grant would provide all capital costs - \$400,000. Ongoing operating expenses, blend into all pf the other sites. Cali-Pitts. This bill – who would actually apply to this fund? Answer – provider. It is being amended. Wireless different - you need to own spectrum, so provider must apply. Broadband, provider could work with municipality. Berezhny – Is FirstNet intended to cover all of NH? Mandate with FirstNet build up network for First Responders – ATT network, FirstNet separate, some shared. FirstNet broadband. No mandate to cover 100% _ We cover 95% - all line of sight. Harrington - Prefer per wording in bill rather than rules. Way bill written says municipality and . or provider can apply, but amendment will make it clearly the provider. Vose – Amendment will be clear. Parshall – Do I understand economically feasible for 4G LTE instead of 5G to make it economically feasible? 4G will eventually be shut down.

RE: Support for a Wireless Deployment Grant Initiative

Dear Chair Vose and Vice Chair Thomas,

On behalf of CTIA[®], the trade association for the wireless communications industry, I write in support of the creation of a Wireless Deployment Grant Initiative and its respective fund. CTIA and our members applaud the State's leadership in recognizing the importance of broadband, the important need to close the digital divide in New Hampshire and the role that wireless plays.

The Importance of Wireless

Americans' reliance on wireless service cannot be overstated and, as New Hampshire looks to close the digital divide, the State should ensure that wireless broadband networks are part of the overall solution. Americans continue to use wireless broadband networks to consume data at tremendous rates. In 2020, wireless data traffic had another record year, topping 42 trillion megabytes—a 207% increase since 2016. From 2010 to 2020, Americans drove a 108-fold increase in data traffic on mobile broadband networks.¹

Americans, particularly low-income Americans, are increasingly opting for wireless solutions for their communications needs. According to the National Center for Health Statistics, in the last six months of 2020, 65.8% of adults and 75.5% of children lived in households with wireless-only voice service.² Studies show that many low-income Americans have chosen mobile broadband as their single broadband solution; in fact, wireless is currently the only broadband connection for over a quarter of low-income households.³

As recent events have shown, connectivity is paramount and the wireless industry fights every day for its consumers by working to upgrade and enhance wireless networks. Since 2016, wireless providers have invested nearly **\$140 billion** in network infrastructure. Over the life of the wireless industry, capital investment now totals over **\$601 billion** to improve speeds, coverage, and quality.⁴ In New Hampshire specifically, the wireless industry contributes over **\$1 billion** to the State's GDP annually.⁵ This is particularly noteworthy since nearly half (1/2) of all New Hampshire households are wireless-only for voice service.⁶

SB 395 appropriately recognizes the important role of wireless technology by establishing the Wireless Deployment Grant Initiative and creating a dedicated fund for eligible projects in areas that lack mobile wireless coverage. The Department of Business and Economic Affairs is then tasked with promulgating rules relative to the grant application process and distribution of funds.

In closing, the pandemic has further made it clear the importance of broadband to consumers in our increasingly connected society; and, consumers have shown a clear preference for mobile connectivity. SB 395 represents a solution addressing what New Hampshire residents actually want.⁷ SB 395 appropriately recognizes the broader role that wireless plays in the broadband ecosystem.

For these reasons, CTIA applauds the Committee's efforts for the creation of a Wireless Deployment Grant Initiative and its respective fund.

New Paragraph; Department of Business and Economic Affairs; Broadband Matching Grant

IV. A municipality that is located in an area that is determined to lack adequate cell phone 3 4service shall be eligible to apply for a grant under this section to provide such service through a communications provider that is capable of serving the area in which the municipality is located. A $\mathbf{5}$ 6 cell phone service provider that serves an area lacking adequate cell phone service shall, upon 7approval of governing body of the municipality to be served, also be eligible to apply for a grant 8 under this section. For the purposes of this paragraph, "adequate cell phone service" shall mean cell 9 phone service that meets federal standards for speed, latency, reliability, and consistency in quality 10of service.

11 2 Effective Date. This act shall take effect 60 days after its passage.
