Sen Rosenwald Sponsor Support The bill clarifies that ultrasound is not required for all pregnancies under the Fetal Life Protection Act.

Ian Huyett Cornerstone Action Support See TapeI won't repeat the arguments about this bill as we've all heard them before. The House has passed HB 1609 which adds some exceptions to the Fetal Life Protection act, which means the FLPA is even more moderate than the Massachusetts ban in place until 2020 which had no such exception. If that exception becomes law, the viable babies, will be killed under it with impunity.

Kayla Montgomery Planned Parenthood Support The FLPA went into effect in January and contains a requirement for an ultrasound ford all abortion. Ultrasound is not medically required for most abortions. We support this clarification. This bill contains language already passed by the House in HB 1673 and HB 1609. We urge you to support it again.

Rep Stapleton Sull 5 Support SB399 provides the clarity we need in the Fetal Life Protection act. It's time we protect life in the third trimester. Allowing these viable babies to be killed is a travesty and I'm glad NH has taken action to outlaw that killing.

*Sara Hoell Self Support Please do not change this bill into one that would change the Fetal Life Protection Act. Babies in the womb should be protected. They don't differ from born babies except in size, location, environment or their level of development. None of these are a reason to deny them their inalienable right to life.

*Karen Monasky Self Support I oppose any attempt to amend the Fetal Life Protection Act in a way that would make it unenforceable. We should continue to provide its protection to viable pre-borns. I had an abortion. The pain of having a life torn out of your body is one you can't understand. The FLPA is not extreme. I urge you to pass SB399 and keep these modest protections in place.

Laura El-Azem Self Support I've talked to many in my community and most people know what the FLPA does and they support it. The FLPA moved NH from allowing abortion at any time for any reason to protecting typically viable babies. With the saturation coverage of the ultrasound requirement in media, I support this clarification.

*Kathy Peternel Self Support I oppose any attempt to repeal or amend the Fetal Life Protection Act. See Written

Greg Handy Self Support I am father of six. I am here to support you in your moral duty before God who says "Thou shalt not kill". The Roe v Wade decision in 1973 is against the law of God and the Constitution, my father told me then that it would get worse. We would see death of the elderly and other human rights atrocities, Today, the University of Pittsburgh is doing research using aborted baby parts, which means these babies were murdered alive. He describes various abortion procedures in graphic terms. Abortion always involves killing a living baby and, very often, in ways that were condemned by the Nuremburg Code. I urge you to do your moral duty and always support the right to life.

Russan Chester Self Support The abortion process is different than people know. Not having an ultrasound in a late-term abortion is a recipe for serious problems, A late-term abortion is dangerous to the mother. I had an abort and, 15 years later, that abortion has serious consequences for me. If a woman dies during an abortion in NH, the provider isn't required to notify the coroner. If abortion clinics truly provide full information about the abortion, very few would go in that direction. If you identify the thing growing inside the mother, abortion becomes a crime against humanity. If you call it a bunch of cells, not so much McLean: Do you think the bill goes too far in removing ultrasound requirements? Ans: I hadn't read the amendment and my testimony is toward the original bill.

J. R. Hoell Self NH Constitution Part I Article 2 contains no reference to the age at which people acquire the right to life. The Fetal Life Protection Act sets a standard that at least is a start toward honoring that inalienable right

RE: Please vote OTP on SB 399 – relative to certain requirements of the Fetal Life Protection Act requiring an ultrasound examination – as amended by the Senate.

I am Karen Monasky, a retired Occupational Therapist with degrees in biology and occupational therapy. I am also a mother to three – twin sons and a child whose life ended in an abortion clinic over 30 years ago. I'm here to urge the committee to vote "ought to pass" on SB 399 as amended by the Senate. By doing so, you would be strengthening an already sound late term abortion ban in the state that protects viable late term children just weeks before their birth. I oppose any attempt to amend the law in committee in a way that would render it unenforceable and incapable of defending even a single child.

Much has been made of the need to give women absolute say over whether the child they carry lives or dies. But few speak for that child, who, through no fault of their own, is killed before even being able to take a single breath outside the womb. A child's right to live can't only be based on whether they are convenient or wanted. Certainly, we can balance reasonable protections for viable preborn while still providing women ample opportunity to seek an abortion if that is their decision.

To hear those who oppose any restrictions, you would think women always make loving, supported, and knowledgeable decisions to terminate the young lives they carry. That was not my experience. As a young woman, like so many, I was faced with an unexpected pregnancy with a father who did not want the child. Unsupported, afraid, and panicked, I scraped up the money for an abortion. I walked in alone. No one had told me the violence of what was to come. If you haven't felt the pain of having life torn out of your body by force, you couldn't understand. There was no connection, no compassion from the doctor who never introduced herself or even acknowledge me before painfully violating my body and ending the life of my child. And this was in my first three months of pregnancy. We need to take a moment and think about these fully formed children in the last trimester and what has to happen to forcibly end their lives.

We argue on the margins of extreme examples and ignore those children who have a true chance at life. A 24-week ban with exceptions for the health of the mother is not extreme. And, for those women who still want to abort their late term children, there are bordering states that would be happy to accommodate them, just as NH no doubt did when we had abortion on demand for any reason up to the moment of birth. I urge the committee to pass SB 399 as currently amended by the Senate and keep these modest protections in place for those who can't defend themselves.

Good morning and thank you for hearing my testimony in support of SB 399 as amended by the Senate.

This is the second time this session that I have come before the House Judiciary Committee. I have also testified regarding HB 1673. Considering the similarity between these two bills, that written testimony is included as well.

My name is Katy Peternel, I live in Wolfeboro with my husband, we raised four daughters there. I have a Bachelor of Science in Nursing.

I stand before you today as a woman who has had far too many experiences surrounding life issues. As an adoptee; a birth mother; the grandmother of a beautiful 5 month old grandson from an unplanned, unwed pregnancy; as a friend of women who have shared their stories of abortion; as an attendee of retreats to heal the suffering of post-abortive women; and the mother of a son who was delivered early at 23 weeks gestation; I think I have a very valid opinion on the Fetal Life Protection Act and attempts to amend or repeal it.

Of all my experiences, I think the most pertinent to today's hearing is the emergent delivery of my son at 23 weeks. In order to save one life, as opposed to losing two, he was delivered via c-section, followed by a hysterectomy. The surgery to save my life lasted 8 hours and required the transfusion of 4 units of blood. This decision was not one my husband and I took lightly and I was willing to die to save the life of my son.

The night before the surgery, I will never forget lying in the hospital bed, feeling my son kicking and moving around. He was very active. While I lay there, I kept silently asking him to please stop moving. Please stop moving.

After the surgery, they brought the body of my 23 week old son to me. Although I was in the stupor of anesthesia, I can still, eighteen years later, see that perfectly formed body, an entire human being, a baby only one week younger than the narrow ultrasound requirement in SB 399.

When you vote on SB 399 as amended by the senate, please think about what a 24 week gestation baby looks like and vote to support the bill.

My name is Sarah Hoell, and I want to thank you for taking the time out of your busy schedule to read this letter.

My hope in this letter will persuade you not to turn bill SB 399 into a gutting bill for the FLPA (Fetal Life Protection Act). I understand many of those in support of abortion want to remove the FLPA. Abortion is seen as a morally correct act since it protects women's rights.

As a woman, I am in full support of rights for my sex. The issue with abortion, however, is not over women's rights as often portrayed. Many different arguments raised distract from the core issue. When does an embryo become human?

(To be clear, when I use the word human, I'm referring to someone equal to the rest of humanity in value and has the right to life.)

If an embryo is not a human, there is no issue with abortion. If the embryo is human, then abortion is murder. Every other piece of the matter is secondary to this one question. Once it's resolved, any other matter in regard to abortion can be easily answered.

Five elements change between conception and birth regarding the embryo, size, level of development, environment, degree of dependency, and degree of consciousness.

Size: How does size give human life value? Humans range in different sizes, but it does not affect the value we have or the rights we possess as American citizens.

Human value is greater than physical appearance.

Level of Development: Born babies are less developed than children, children are less developed than teens, etc; When does the level of development make someone else more valued?

Environment: Someone's environment does not change their value. Someone cannot travel to any location in the universe, and their life becomes less valuable. To say a child's value hinges on the journey of eight inches is ridiculous. Why bother with a C-section if they are not valuable until outside the womb?

Degree of Dependency: The comatose and disabled are all dependent on others. Born babies are dependent on their guardians, if not more so than an embryo.

Degree of Consciousness: Consciousness does not impact value. Someone in a coma is not less valuable. Someone with a severe mental disorder is not less valuable.

In the end, what makes a human value is that they are human. There are no extra criteria for a human to have value. The minute someone tries to place one on an embryo, there will always be another human that is an exception.

When did being human no longer be enough to have the right to life?

Abortion is not protecting women's rights, nor is it moral. I hope tomorrow you will let BS 399 pass without modifying it to remove more of the FLPA. In the future, I hope your committee will continue to fight for the rights of those who cannot speak for themselves.

The House has passed HB 1609 which adds some exceptions to the Fetal Life Protection act, which means the FLPA is even more moderate than the Massachusetts ban in place until 2020 which had no such exception. As of January 1, 2022, all patients seeking abortion care in New Hampshire are first required to have an ultrasound conducted by a health care provider, regardless of the stage of pregnancy and regardless if it is medically necessary.

We urge the Senate Judiciary Committee to vote "Ought to Pass" on SB 399, as it would narrow the ultrasound requirement's scope to near 24 weeks, rather than at every stage of pregnancy, prior to accessing abortion in New Hampshire.

The ultrasound mandate provision was passed as a part of New Hampshire's newly-enacted 24-week abortion ban, signed into law through the state's budget process. Specifically, RSA 329:44 states:

Except in the case of a medical emergency as specifically defined in paragraph III, no abortion shall be performed, induced, or attempted by any health care provider unless a health care provider has first made a determination of the probable gestational age of the fetus. In making such a determination, the health care provider shall make such inquiries of the pregnant woman and perform or cause to be performed all such medical examinations, imaging studies, and tests as a reasonably prudent health care provider in the community, knowledgeable about the medical facts and conditions of both the woman and the fetus involved, would consider necessary to perform and consider in making an accurate diagnosis with respect to gestational age, provided, however, that the health care provider shall conduct an obstetric ultrasound examination of the patient for the purpose of making the determination.

Although the RSA identifies an "obstetric ultrasound examination" to determine the gestational age, in order to meet this requirement at the earliest stages of pregnancy, a transvaginal (or internal) ultrasound is necessary. Prior to January 1, 2022, providers could work directly with patients, particularly those with a history of sexual trauma or assault, regarding whether an ultrasound was necessary prior to accessing abortion; now that the provision has been enacted, a patient must have

an ultrasound in order to access abortion. This mandate is not consistent with best medical practices and threatens the ability of providers to deliver patient centered, trauma informed care.

Additionally, this ultrasound mandate directly impacts patients seeking medication abortion, which can be used up to 11 weeks of pregnancy. According to The American College of Obstetricians and Gynecology, "For patients with regular menstrual cycles, a certain last menstrual period within the prior 56 days, and no signs, symptoms, or risk factors for ectopic pregnancy, a clinical examination or ultrasound examination is not necessary before medication abortion."

After the state budget was signed into law, Planned Parenthood of Northern New England adapted its policies and procedures in all three states (Maine, Vermont, and New Hampshire) to ensure that every patient had an ultrasound prior to accessing abortion. Although New Hampshire's new law does not specify penalties against providers who perform abortion care without an ultrasound, Planned Parenthood of Northern England complies with all laws and regulations — and the current law requires an ultrasound prior to all abortion care.

SB399 is a step in the right direction by removing the invasive, burdensome, and often medically unnecessary ultrasound requirement. We urge the House Judiciary Committee to vote "OTP" on SB 399.



Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Fetal Life Protection Act; Prohibitions; Ultrasound Examination Requirement. Amend RSA 329:44, I to read as follows:
- I. Except in the case of a medical emergency as specifically defined in paragraph III, no abortion shall be performed, induced, or attempted by any health care provider unless a health care provider has first made a determination of the probable gestational age of the fetus. In making such a determination, the health care provider shall make such inquiries of the pregnant woman and perform or cause to be performed all such medical examinations, imaging studies, and tests as a reasonably prudent health care provider in the community, knowledgeable about the medical facts and conditions of both the woman and the fetus involved, would consider necessary to perform and consider in making an accurate diagnosis with respect to gestational age, provided, however, that the health care provider shall conduct an obstetric ultrasound examination of the patient for the purpose of making the determination. This subdivision shall be construed to require the performance of an ultrasound only if the provider either knows that the fetus has a gestational age of at least 24 weeks or is conscious of a substantial risk that the fetus has a gestational age of at least 24 weeks.
 - 2 Effective Date. This act shall take effect upon its passage.

METHODOLOGY:

This bill repeals RSA 329:43 through 329:50, relative to the fetal health protection act. Since the bill removes a felony offense from statute, it may decrease costs for the judicial and correctional systems. There is no method to determine how many fewer charges may be brought as a result of the changes contained in the bill. However, the entities impacted have provided the costs associated with felony cases below.

It should be noted that a person needs to be found indigent and have the potential of being incarcerated to be eligible for indigent defense services. Historically, approximately 85% of the indigent defense caseload has been handled by the public defender program, with the remaining cases going to contract attorneys (14%) or assigned counsel (1%). Beginning in March of 2021, the public defender program has had to close intake to new cases due to excessive caseloads. Due to these closures, the contract and assigned counsel

program have had to absorb significantly more cases. The system is experiencing significant delays in appointing counsel and the costs of representation have increased due to travel time and multiple appointments.

With respect to the Judicial Branch, the fiscal impact is indeterminable. In the past the Judicial Branch has used averaged caseload data based on time studies to estimate the fiscal impact of proposed legislation. The per case data on costs for routine criminal cases currently available to the Judicial Branch are based on studies of judicial and clerical weighted caseload times for processing average routine criminal cases that are more than fifteen years old so the data does not have current validity. A new case study is being conducted and updated estimates will be available in the future.
