SB 454 - AS INTRODUCED

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Two

AN ACT establishing a committee to study the information collected by the division of vital records administration as part of the live birth worksheet.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	1 Committee Established. There is established a committee to study information collected as
2	part of the live birth worksheets under RSA 5-C:19 and RSA 5-C:20.
3	2 Membership and Compensation.
4	I. The members of the committee shall be as follows:
5	(a) Two members of the senate, appointed by the president of the senate, one from the
6	majority party and one from the minority party.
7	(b) Two members of the house of representatives, appointed by the speaker of the house
8	of representatives, one from the majority party and one from the minority party.
9	II. Members of the committee shall receive mileage at the legislative rate when attending to
10	the duties of the committee.
11	3 Duties.
12	I. The committee shall study:
13	(a) The specific, individually identifiable information included on the worksheets;
14	(b) How that specific individually identifiable information is used by the department of
15	state's division of vital records administration and the department of health and human services;
16	(c) The process for de-identifying and aggregating the data for use in statistical
17	analyses;
18	(d) The specific privacy and security protections of individually identifiable data
19	applicable under state and federal law;
20	(e) To what extent the mother may elect to decline to share the data;
21	(f) Any federal requirements to share individually identifiable data; and
22	(g) Any other related information the committee believes relevant.
23	II. In completing the study, the committee shall solicit input from the department of state's
24	division of vital records administration and the department of health and human services, as well as
25	any other entity the committee finds relevant.
26	4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from
27	among the members at the first meeting. The first meeting of the committee shall be called by the
28	first-named senate member. The first meeting of the committee shall be held within 30 days of the
29	effective date of this section. Three members of the committee shall constitute a quorum.

1 5 Report. The committee shall report its findings and any recommendations for proposed 2 legislation to the president of the senate, the speaker of the house of representatives, the senate 3 clerk, the house clerk, the governor, and the state library on or before October 15, 2022.

4 6 Effective Date. This act shall take effect upon its passage.
