

Summary of Testimony Presented:

Rep. Suzanne Smith

- HB 1188 forms a five-year study commission to review the statutes for OHRV use and recommendations for potential future legislation.
- 57 bills related to OHRV bills have been signed into law.
- Sales and use have grown exponentially. NH Fish & Game report many accidents and most are due to the inexperience of riders.
- A study commission would reveal the positive and negative effects on the state's economy.
- In August of 2021, a group of stakeholders consisting of Executive Councilor Joe Kenney, legislators, members of law enforcement, NH Bureau of Trails, NHDOT, and the President of the NHOHRV Association brainstormed about what to do regarding OHRV use in the state. Councilor Kenney suggested a long-term study to identify issues. HB 1188 came out of that discussion.
- The bill studies current OHRV statutes. Fish & Game and law enforcement will help to enforce already existing laws in New Hampshire.

- Large studies that took place in the past could have been helpful with OHRV use but those studies required a lot of money so the studies weren't done.
- Rep. Smith said putting Governor's on rental OHRVs could be helpful to help enforce speed limits.
- 18 members would be listed on this commission so that stakeholders and members would be represented. Fish & Game and the NH Auto dealers Association are included as well. Landowners would be represented by the TOA and Farm Bureau.
- Sen. Sherman asked if OHRV use would be limited to the state or if an amendment would be needed to expand use to the state and local economy. There could be a big benefit but with significant push back, like in Gorham. It may be broad enough to incorporate both state and local economies.
 - o Rep. Smith said the bill would be broad enough without an amendment.
- Sen. Ward asked how much funding might be needed for this commission.
 - o Rep Smith said she was not sure. There may be legislation that the commission introduces to cost money. There had been studies that are in limbo now due to questions about funding. She said she would need to look into where to get funding.
- Sen. Watters asked if there was an issue about adding a duty to study the need for electric charging infrastructure at trail heads.
 - o Rep. Smith said she was not opposed. There were electric OHRVs are available, but they are not used as much.
 - Sen Watters said the electric charging stations would be good for riders and NHADA.

Rep. Egan

- Rep. Egan testified in support of HB 1188.
- The bill establishes a commission to help protect riders, be respectful to landowners, and good for economy.
- It is important for the safety for riders and the impact on the industry. This is better done under a commission.
- It would help Fish & Game create a safety program that educates riders to be better prepared when riding OHRVs.
- Law enforcement division of Fish & Game, NH Auto Dealers, and the NH Snowmobile Association agreed that a commission could outline what is needed for further legislation and assist with safety issues.

Abby Evankow, Gorham resident

- Mrs. Evankow thanked Rep. Smith for introducing the bill.
- It is important for stakeholders to have a voice but there is no voice for abutters to OHRV trail properties. Having one seat for a year-round landowner should be necessary when talking about stakeholders.

- There are three seats given to the OHRV lobby. That is out of line for how NH residents and out of state visitors who use the trails.
- From the New Hampshire business review, 350,000 residents hike or walk, 240,000 bike, 225,000 paddle, 140,000 fish, and 50,000 hunt compared to the yearly OHRV registration of 36,000. OHRV use is the smallest of the trail users.
- Giving 3 of the 18 seats to the OHRV users makes the commission unbalanced.
- The statewide comprehensive outdoor recreation plan lists the most popular activities as running, fishing, cycling, hiking, and camping. OHRV usage is not in the top five most popular activities.
- Sen. Birdsell said when looking at the amended version of by the house, one
 member is appointed jointly by the NH Timberland Owners Association and NH
 Farm Bureau, one member of the public appointed by the NH Association of
 conservation commission and one appointed by the North Country Council,
 couldn't those three be equated to be made sure that they were made into seats
 for abutters.
 - o Mrs. Evankow said if it was specified, yes. However, right now, you can be a member of the Timberland Association and not live on the class VI road. The Timberland and Farm Association are different than homeowners.
- Sen. Sherman asked who the best would be to pick for an abutter. Would a singular group be able to pick someone.
 - o Mrs. Evankow said that she appreciated not having the size of the commission bigger than it already is. The North Country Council may be an option to pick an abutting residential homeowner, but she wasn't sure.

Richard Parsons, Representing NH Off Highway Association

- Supportive of the bill and it is important to pass the bill.
- HB 1182 was a previous commission to take a look at OHRVs but it wasn't nearly enough time. A 5-year commission is the best approach.
- Electric vehicle charging stations being added is appropriate. Many in the industry see electric OHRVs as the future.
- Issues with the number of membership had come up and 18 members can be difficult. Having an odd number might be better.

Matt Leahy, Policy Director of the Society for the NH Forest

- Mr. Leahy supports the bill.
- He said he viewed the bill as a good forum for different interested parties.
- It would allow a comprehensive look at long-term issues with OHRV usage.

Sen. Birdsell

- The amendment is to address language that the state police had brought up. The police interpreted the language that the NHSP would be responsible to pay the towing fees.
- The amendment cleans up the language on the towing bill.
- Section IV would now say "history of criminal convictions" and renumbers the bill accordingly.
- Instead of recovery and storage, the amendment now says impoundment, recovery, transport, and storage.
- The biggest change is on page 2, II. It strikes "the towing and storage of the vehicle shall be at the expense of the state police."

- The RSA is now changed to RSA 262:31-a
- Sen. Birdsell spoke with the sponsor to make sure they were okay with the amendment.

Captain John Hennessey, Field Commander of the NH State Police

- Captain Hennessey outlined some changes that the state police would like.
- Captain Hennessey wanted the language of section 4 and section 9 regarding the state police tow list to mirror each other when it came to criminal records, drivers, and business owners.
- NHSP is towing and storing vehicles and the cost being incurred by the state police would be concerning.
- Captain Hennessey said the NHSP would be towing vehicles in the interest of public safety. Anywhere from 100 to 1000 vehicles are towed per year and the NHSP would be bankrupt if the NHSP was responsible for all of the towing.
- Sen. Birdsell said there were certain criteria that the NHSP is still responsible.
 - o Captain Hennessey said that would be in certain circumstances. It would be in search of crime with a search warrant or looking for criminal evidence. The NHSP would handle that cost instead of bringing the vehicle to a towing impoundment facility.

Senator Birdsell,

Thank you for being the catalyst on this issue.

Richard and I spent some time today working on a compromise for House Bill 1109. This is the off highway recreational vehicles use on class IV, class V, and class VI roads bill.

I used your amendment (amend. #2022-1541s) as the base. The proposed changes are below.

In drafting this we focused on the property access issue I testified on at the public hearing. Our rationale for focusing on this issue recognizes HB 1188, the OHRV study bill, will look at bigger picture issues (i.e., the approval process for new trails on roads, etc.). This amendment will give immediate relief (recognizing the HB 1188 study is a 4-year process) to abutting landowners losing access to their property due road damage and gives towns another tool for managing their roads.

We removed the reference to damage on the abutter's property as that is handled in existing statute. This is something the NHTOA worked on in 2017, with the modification of RSA 215-A:19, X where individuals damaging private property are obligated to restore the property and could be subject to treble damages.

We kept your original enabling language (uses the term "may adopt"). This does two things. It obligates the landowner to prove to the selectmen the road is being damaged, and action must be taken. Second, it avoids any question of mandates/infringements on municipal authority.

As mentioned above, this amendment gives the town a tool to limit damage to the road during sensitive times of the year (i.e., mud season). More importantly, because this is not changing the designation or use of a road, which requires a public hearing, this tool can be deployed quickly if a road is being damaged. This tool can also be limited in scope (i.e., limiting access during mud season). This bill also gives landowners a clear pathway to seek protection of a road.

Lastly, because a landowner can still access their property, this does not conflict with existing road law and preserves a landowner's right to access their property. If a landowner does access their property and damages the road, there are already laws in place for the town to seek repairs against that landowner.

New amendment language

Amend the title of the bill by replacing it with the following:

AN ACT relative to the authority of a city or town to limit the use or operation of an OHRV on certain ways.

Amend the bill by replacing all after the enacting clause with the following:

1 Operation of All OHRVs; OHRV Operation on Sidewalks, Class IV, Class V, and Class VI Roads. Amend RSA 215-A:6, IX to read as follows:

IX. Pursuant to RSA 215-A:15, and following a duly noticed public hearing advertised at least 14 days in advance in a public location in the city or town and notification to abutters by verified mail pursuant to RSA 21:53, city or town councils and boards of selectmen may authorize the use of sidewalks and class IV, class V or class VI highways and bridges, or portions thereof, for use by OHRVs. The operation of OHRVs may also be allowed on sidewalks adjacent to class I, II, III, or III-a highways pursuant to RSA 236:56, II(e). Operators of OHRVs using said roads, or portions thereof, shall keep to the extreme right and shall yield to all conventional motor vehicle traffic. The bureau, or its designee, shall so post such highways where authorized. If an abutter can show damage or deterioration to such a road that limits their ability to access their property resulting from recreational use, the governing body of the city or town may adopt regulations to close or limit the operation or use of a way in order to mitigate damage or deterioration. Following a duly noticed public hearing, except in the case of an emergency closure, such city or town authorities may change the allowable usage of a class IV, class V, or class VI highway by OHRVs by giving notification to the supervisor of the bureau and removing any signs that no longer apply. The petitioner shall bear the expense of verified mail notification to abutters of property for which OHRV use is sought under this paragraph.

2 Effective Date. This act shall take effect 60 days after its passage.

Dear Madame Chairwoman and Members of the Committee:

Thank you for this opportunity to submit testimony in support of House Bill 1188, legislation establishing a commission to study OHRV use in the state.

The Forest Society does not host ATV trails on land that we own, due to the damage they can cause to the soils and root systems that enable tree growth as well as to the network of hiking trails on our properties. However, we also recognize the increased use of OHRVs are viewed as an important part of the State's tourism economy, especially in the North Country.

This growth has raised concerns among other groups regarding the effect the increased use is having on landowners living near popular trails in addition to those to natural resources. Unfortunately, the disagreements between users and non-users over those issues is not serving either side well. Given these on-going conflicts, we believe now is the time for the State to initiate an overarching review of the OHRV system. The passage of this legislation will accomplish that step.

In our view, it is possible to find common ground among all of those with a stake in this discussion, including OHRV enthusiasts, landowners, communities impacted by OHRV activity, other non-motorized recreationists who use trails, and communities and businesses seeking the economic reward of hosting OHRV trails.

Reaching this common ground will require good planning, ongoing effective communication among a wide variety of interested stakeholders, effective education of OHRV riders, a process for resolving specific conflicts when they arise, and visible law enforcement. We support HB 1188 because it will establish the framework that we believe will lead to those outcomes.

Multiple People Injured in ATV Rollovers in Berlin and Gorham

Berlin/Gorham-- On Saturday September 11, 2021, NH Fish and Game responded to three separate ATV and UTV rollovers in the course of three hours. Two crashes occurred in Jericho State Park in Berlin and the final one occurred on the Presidential Rail Trail in Gorham.

The first incident occurred at approximately 11:30 on Brook Road in Jericho State Park. Michael Ryan, 31 of Gloucester, MA was operating his rental ATV on Brook Road, 2nd in a group of three rental machines. He came around a downhill corner on Brook Road and hit his brakes, causing him to lose control of his machine, which rolled over and pinned him against the ground.

After a 911 call was placed, an emergency response was initiated by Berlin Fire and EMS and NH Fish and Game Conservation Officers. Upon evaluating his injuries, first responders determined that Ryan needed more urgent immediate care, and so a call to the Dartmouth-Hitchcock Advanced Response Team (DHART) helicopter was placed and they responded to pick up Ryan at Androscoggin Valley Hospital after he was transported there by Berlin Ambulance. He was later transported by DHART helicopter to Dartmouth-Hitchcock Medical Center in Lebanon with serious injuries.

After interview of the riding party and Ryan himself, unreasonable speed and inexperience are considered the primary factors in the crash. Ryan admitted to officers that he had been operating too quickly before he crashed.

The second crash that Fish and Game responded to occurred around 2:00 PM on Moose Road in Jericho State Park. Nicole Levesque, 36, of Milton, NH was following another ATV on Moose Road. According to witnesses and evidence at the scene, Levesque got the wheels of her ATV caught in a rut in the trails which caused her to get pushed into a ditch where the machine rolled over onto her causing a severe injury. Another ATV operator from a different party found Levesque and called 911. An emergency response consisting of Berlin Fire and EMS and a Conservation Officer was initiated. After evaluation of Levesque's injuries, it was determined that once again, they would need to get her to more immediate urgent care, so responders requested that the DHART helicopter respond. Levesque was transported from the scene to Androscoggin Valley Hospital by Berlin Ambulance, where she was picked up by the DHART helicopter for transport to Dartmouth Hitchcock Medical Center. Investigators consider operator inexperience to be the primary cause of this crash. Upon clearing the previous crash scene, the Conservation Officer was immediately notified of another ATV rollover, this time on the Presidential Rail Trail in Gorham. Gorham Fire and Rescue and the Conservation Officer rushed to the scene to assist the patient, identified as Henry Sanschagrin, 74, of Gorham, NH.

It was determined that Sanschagrin was operating his UTV on the rail trail and decided to pull off the side of the trail to let another ATV pass. While doing this he accidentally pulled too far to the right which caused his UTV to roll over down an embankment.

Oncoming ATVs stopped to assist Sanschagrin and his wife, who was in the passenger seat, and called 911. Sanschagrin and his wife were transported to Androscoggin Valley Hospital for evaluation for any injuries by Gorham Fire and Rescue.

The final crash of the day occurred on Farr Road in Pittsburg when an ATV operator identified as Karen Lane, 59, of Jaffrey, NH rolled her ATV over, reportedly to prevent hitting a gate. Due to the fact that there were three other ATV crashes, plus a SAR rescue mission going on and only 3 Conservation Officers on duty in Coos County, they did not respond to this crash. Pittsburg PD assisted by covering this crash. Lane was transported to Upper Connecticut Valley Hospital in Colebrook, where DHART was called to transport the patient. Speed and inattention are the contributing factors in this crash.

Investigators do not consider alcohol or drug intoxication a factor in any of these crashes. NH Fish and Game would like to remind operators to always operate within their limits and obey all posted speed limits and slow down while enjoying New Hampshire's numerous ATV trails.

UTV Crash with Injury in Berlin

Berlin – On the afternoon of Friday, September 10, 2021, a New York man sustained significant injuries after rolling over his rented UTV in a sand pit beside Brook Road in Jericho Mountain State Park.

It was determined that at approximately 2:45 PM, Joseph Egenberger, 43, of Rocky Point, NY lost control after accelerating into a right turn within a sand pit. As Egenberger attempted to navigate a sloped section of the turn, the UTV rolled onto its side. Egenberger sustained injuries in the rollover crash and a 911 call was immediately placed from the scene to request medical assistance.

A response from Berlin Fire Department, Berlin EMS and Conservation Officers began. Berlin Fire Department and EMS personnel responded into the scene utilizing their UTV and ATV. Egenberger was assessed and subsequently transported from the crash scene via UTV to an awaiting Berlin EMS Ambulance. He was then transported to Androscoggin Valley Hospital for further evaluation and treatment of his injuries. Concluding an investigation of the crash, Conservation Officers believe the primary factor of the crash to have been excessive acceleration. Egenberger was ultimately issued a summons for operating an OHRV to endanger.

Good morning. Chairperson Birdsell & the Senate Committee on Transportation

If here to speak in support of HB 1188 because establishing a commission to study OHRV use in the state is paramount to respecting out landowners, protecting our riders and promoting tourism economy in a logical manner.

An example of why a Commission is needed, at my recommendation earlier this House Session I had my HB 1498 (relative to establishing a safety training program for off highway recreational vehicles and snowmobiles) before the Committee on Resources Recreation and Development. We were all in complete agreement with a 21-0 vote of Interim Study in establishing a safety program for off highway recreational vehicles and snowmobiles, as the importance of safety for riders and impact on the industry needs to be refined in the bill's execution of safety program activations. A Commission could do that utilizing all stakeholders to best benefit NH.

The Fish & Game department touches many NH resident and visitors who are outdoor enthusiasts with motorized vehicles, enjoying all four of our seasons. And the ability to have riders be better prepared when the riding on new trails or in new riding territories, is essential to helping F&G mange their ridership. A safety program will go a long way in serving this community with increased safety and education. HB 1498 was developed in consultation with the Law Enforcement Division of Fish & Game, the NHOHRV Assoc. and the NH Snowmobile Assoc. The the Fish & Game Director would use a Commission outlined in HB 1188 to hold a series of meetings with the community, industry and the Committee to determine what is needed for further legislation.

With your support of HB 1188, a Commission to Study OHRV's can address safety issues that could be better studied, dealt with in along with other pending legislation and receive further agency AND industry input. Thank You
