This bill converts the governing boards of recreational therapists and respiratory care practitioners to advisory boards under the authority of the executive director of the office of professional licensure and certification.

Summary of testimony presented in support:

Rep. McGuire:

- Rep. McGuire introduced the bill as requested by OPLC to convert some of the smaller boards to advisory boards rather than regulatory boards.
- These boards have small numbers in the profession and they have a hard time finding members and meeting regularly.
- The House amended the bill to specify the areas where OPLC has oversight, which is largely administrative.
- The advisory boards are focused on the technical and professional areas.
- This bill also adds an alternate to the boards.

Senator Carson asked how the transfer of duties will happen.

Rep. McGuire explained that administrative board functions were transferred to OPLC a few years ago when OPLC was formed.



Dear Hon. Chair Carson:

The Office of Professional Licensure & Certification ("OPLC") wishes to express its support of HB 1446. OPLC is the agency responsible for providing support to approximately fifty occupational licensing boards with independent regulatory authority. OPLC also directly regulates four professions with advice of advisory boards. This bill proposes to change the governing boards of recreational therapists and respiratory care practitioners to advisory boards.

For an occupational licensing structure to be successful, the State should leverage expertise of professionals in those occupations, as well as individuals who are experienced in administrative law and procedure. Members of regulated professions may be experts in their fields, but they are often not experts in administrative law and procedure; state officials may have vast experience in administrative law and procedure but know little about the regulated profession. Accordingly, the two must work together in a harmonious relationship to achieve the State's mission of protecting the public, while complying with all aspects of state law.

This structure breaks down when one body is not able to, or not consistently able to, perform its role in this relationship. There are several OPLC boards that either do not have a quorum or are struggling to consistently maintain a quorum, which has significantly impacted licensure and the State's ability to protect the public. OPLC believes most of these issues are because our healthcare boards are comprised largely of individuals who are part of our healthcare workforce, and who are so desperately needed on the front line, not necessarily in board meetings. OPLC believes that changing these boards to advisory boards would permit board members to freely provide their expertise concerning potential regulatory changes and other matters, even if the board lacks a quorum, while ensuring that business can continue in the absence of board meetings. This is because, under the proposed bill, the agency would be permitted to act even in the absence of a board quorum.

When OPLC was considering which boards should potentially move to an advisory model, the governing boards of recreational therapy and respiratory care practitioner came to mind, as the boards have struggled to hold meetings due to lack of a quorum. The governing board of recreational therapy has not met since May 2021. Similarly, the governing board of respiratory care practitioners has not held a meeting since May 2021.

OPLC simply wishes to protect the public by ensuring qualified applicants can be licensed in a timely fashion and that the State can effectively regulate this profession, which includes ensuring applicants meet minimum standards through licensure and responding to complaints. OPLC has watched healthcare board members struggle to take time out of their busy lives to attend board meetings. OPLC appreciates their service. OPLC also understands that they are often needed elsewhere; OPLC is concerned that, if meetings are not held consistently, some individuals may be improperly licensed or not licensed in a timely manner, and complaints will not be addressed. OPLC believes that moving certain boards to an advisory model would permit the State to leverage the board members' expertise, while ensuring that the State performs the duties it is required to do to protect the public.
