Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 New Paragraph; Duties of Commissioner; Department of Education; Current Rules and Statutes. Amend RSA 21-N:4 by inserting after paragraph X the following new paragraph:
- XI. At the beginning of each session of the biennium, providing a physical copy of, a copy on a portable data storage device of, or an Internet link to the New Hampshire education laws annotated and department rules to the house and senate standing committees that oversee education policy, and to make such copy available to all superintendents of New Hampshire schools in any format. A member of the house of representatives or senate may request the New Hampshire education laws annotated and department rules in any format.
 - 2 Effective Date. This act shall take effect 60 days after its passage.

Summary of testimony presented:

Representative Linda Tanner - Sullivan, District 9

- Representative Tanner introduced HB 1521-FN.
- In 2020, annotated statute books were not made available.
- As we are a citizen legislature with no offices or staff, the annotated book is invaluable.
- She likes things in paper format, not from the internet; on the internet, she would only see a particular bill and not annotations.
- Most House members have their vellow books on their desk in Committee during public hearings.
- They cherish these books which is the reason why she filed this bill.

- The books were received this year, however, delivery is inconsistent.
- The costs of the books are approximately \$10,000 from the department of education. This is a guestimate only.
- The annotation is helpful because it shows the different ways that a law has been amended and when it was amended.
- Senator Hennessey asked Representative Tanner about the wording of the bill. Senator Hennessey asked if Representative Tanner knew when the books become available as there is a lag time from OLS finalizing legislation and printing/being book ready.
 - o Representative Tanner is not familiar with the publication side, however, she thinks it can be done pretty fast.
- Senator Hennessey shared that she thinks there is lag time to get them in the right place online.
- Senator Hennessey asked Representative Tanner why all superintendents were added to the language of this bill.
 - o Representative Tanner said there is a lot of pushback on public school superintendents and accusations about what they are/are not doing. Superintendents should have access to the annotated laws and rules. Digital format is provided.
- Senator Kahn asked Representative Tanner how many bills are in the House Education Committee this session.
 - o Representative Tanner said she believes there are 120 bills. It has been overwhelming this year.
- Senator Kahn asked Representative Tanner if the immense workload before the House this session is related to the intent of this bill.
 - o Representative Tanner said she does not think the volume has much to do with the need for this book as a reference. The lag time between sessions is when they actually look to bills they would like to introduce for the next session. Then, the new books come out in January.
 - o Even if they only had 20 bills, she would want this book.
- Senator Ward asked Representative Tanner if the lack in access to this book in 2020 was the impetus for this bill.
 - o Representative Tanner said yes. They had a study committee on this bill.

David Alukonis - Director, NH Office of Legislative Services

- He made himself available for questions.
- They contract for the creation of these books.
- They use West Publishing through Thomson Reuters.
- These books are going away over the next few years. Thomson Reuters do not want to publish these books anymore.
- He thinks these books cost roughly \$100 per book.

- Departments such as Fish and Game and DMV have said it is no longer prudent to provide these books.
- Depending on the type of product at hand for these books, it would have to be a separate negotiation. LexisNexis publishes also and they annotate the books themselves.
- The legislature has a copyright on statutes, however, they do not hold copyright on the annotations.
- Agencies contract with various publishers.
- The Secretary of State does their own work which they print themselves.
- Senator Ward asked Director Alukonis if he is implying that we will no longer have these books.
 - o Director Alukonis said yes. He is not sure why they are in the business of doing this.
 - o He had a similar discussion with his counterpart in Virginia. They also said it has been difficult to find someone to publish.
- Publishers make money on the West Law licenses which are online.
- Senator Hennessey asked Director Alukonis if the department were to give an updated link instead of print, when would it be updated by.
 - o Director Alukonis said it depends. For example, Veto Day was in January this year, not in November like normal. Their publishers could not finalize things until the former session had ended, which is after Veto Day. Our IT team also plays a role in this. He received a number of complaints regarding the delay of the publication of this information.
 - o We are at the will of the publishers which is Thomson Reuters. In the past, he looked into having it updated more frequently. He was told it can be done but with limits.

Diana Fenton - Attorney, NH Department of Education

- While she also likes this book, Director Alukonis' testimony is accurate in that the publisher is getting out of this business.
- There were a multitude of reasons in 2020 why the department stopped providing that book. It was a cost and publishing issue.
- Previously, the books were quite voluminous where, sometimes, the content did not directly relate to education. For example, there were references to homicide in the book one year.
- They did a fiscal note on this bill. The cost of the book is about \$112 each. They anticipate the cost will only increase.
- The publisher does not intend to publish these in the future.
- The department's rules are on the website and available through various links. Some are published. For instance, the code of conduct.
- Given their long list of rules, they do not publish them on a consistent basis.

- Senator Hennessey asked Ms. Fenton how hard it would be to have a link to a Google Drive or an online database on the website for this information.
 - o Ms. Fenton said she personally accesses this information through the General Court website. However, the rules are on the department's website as well.
- Senator Hennessey asked Ms. Fenton for clarity on publishing.
 - o Ms. Fenton said all rules are available electronically and are published by OLS. The department sometimes supplies paper copies of the rules upon request. It is not a matter of practice as each section of rules has an expiration date.
- Senator Kahn asked Ms. Fenton if she would bring back to the department the interest in accessing those rules through a more direct link on the homepage of the department's website.
 - o Ms. Fenton said that is possible as they are always looking at ways to make access easier and better.
