Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Average Daily Membership in Attendance; Fiscal Year 2022. The commissioner of the
2 department of education shall compare the average daily membership in attendance (ADMA),
3 defined in RSA 198:38, for each district and town for school year 2019-2020 and school year 2020-
4 2021. The greater enrollment shall be used to calculate the cost of an opportunity for an adequate
5 education under RSA 198:40-a for the fiscal year ending June 30, 2022.

6 2 Effective Date. This act shall take effect upon its passage.

This bill requires the Department of Education use the greater of school year 2019-2020 or 2020-2021 average daily membership in attendance (ADMA) for determining education grants in FY 2022. Under current law, the ADMA that would be used to calculate FY 2022 payments would be from the 2020-2021 school year. Based on this proposed change, the Department has provided the following summary of this bill's impact:

Summary of testimony presented in support:

Senator Hennessey, Prime Sponsor:

- Due to the COVID pandemic, our schools have seen a big shift in what they are expecting in funding for school funding. The school formula for the 2021-2022 school year takes into account the average daily membership of the kids attending school this current school year, and the number of free and reduced lunch forms turned in this school year. Because of COVID, many schools have seen either a drop in average daily membership due to home-schooling, or parents could not stay home from work for remote learning sessions, putting the student(s) in another home-school setting or a private school. Additionally, the federal government did not require free and reduced lunch forms to be completed this year, thus many families have not completed the forms. School

- systems have been urging all parents to complete these forms, but have been unsuccessful. Parents do not understand the impact it has on school funding.
- This bill aims to help school districts' budgets for the next school year by removing the COVID impact on our school funding formula. The formula would be based on the higher of this school year's average daily membership number compared with next year's.
 - The LBAO has provided a breakdown of the impact by city/town. The total impact is \$45.67 million.
 - SB 135-FN-LOCAL is very important. These monies will go back to our cities and towns, as well as help our taxpayers with the cost of education.

Senator Kahn:

- An adjustment in the daily number of dependents is absolutely necessary. This has been a very disruptive year for all, including families in schools. Hopefully, this is a once-in-a-lifetime phenomena to which the Legislature can adjust the current state funding for schools.
- The Legislature also has a need to address longer term funding needs for public schools, as well.
- This bill will reduce the cost of adequacy aid from FY 2021 to FY 2022. But, have we done what we need to do for FY 2022 to help support our public schools, particularly in the neediest communities?

Paul Grenier, Mayor, City of Berlin:

- This is a common sense approach to a situation that was not of anyone's doing.
- All summer and fall, students in remote learning or a hybrid model, have received lunches. However, parents do not understand that signing a form for free and reduced lunch also triggers other issues dealing with education funding. "It's free anyway--why fill out the forms?" This is burdening the rest of the taxpayers if it continues to go unaddressed.
- This bill is not a cure all, but it is a recognition of a problem not of their doing.

Reverend Jay MacLeod, St. Andrew's Church, New London and Epiphany Church, Newport:

- This bill will help all schools in New Hampshire, especially working class kids and communities.
- Hopefully, there will be no decline in state education aid in the coming year.
- The aid will not be affected by declining attendance, due to the pandemic. School districts will need the money for their budgets.
- Towns like Newport get hit with a double whammy. Their pupils receive an inferior education, and their parents and neighbors pay a far higher property tax rate than in wealthier towns.
- Revered MacLeod supports any bill that will help our pupils, parents and teachers, and help to level the playing field between wealthy and working class districts.
- SB 135-FN-LOCAL will at least prevent a steeper decline in state support for education.

Jeff McLynch, Project Director, NH School Funding Fairness Project:

- The aim of SB 135-FN-LOCAL is clear, as it seeks to protect against the COVID-19 pandemic's possible impact on school finances.

- The need for the bill's enactment is urgent, as communities across New Hampshire are already weighing difficult budgetary decisions for the coming year.
- This bill recognizes the student counts we are seeing now are not likely to reflect the situation schools will face this fall, and offers a reasonable alternative to calculate state aid.
- While passage of the bill is certainly vital, it could be made stronger still, in order to preserve the progress that the Legislature made under the current budget in bolstering state education aid and targeting it to those cities and towns most in need. The current budget includes additional aid, which is intended to assist cities and towns with higher concentrations of low-income students; and fiscal capacity disparity aid, which is designed to help municipalities with comparatively low property values. Those two forms of aid take steps towards addressing some of the flaws inherent in New Hampshire's approach to funding schools, and as such, ought to be extended and maintained until more comprehensive reforms are adopted. The bill should be amended to extend these two forms of aid for another two years.
- Due to the pandemic and the termination of additional aid and fiscal capacity disparity aid, state education aid in total is expected to fall by some \$90 million in the coming year. Such a drop would force many cities and towns to turn to significant property tax increases or severe spending cuts as they set their school budgets for the next academic year. Passage of SB 135-FN-LOCAL in its present form would obviously help to reduce the likelihood and the potential scale of such rates increases, but the maintenance of additional aid and fiscal capacity disparity aid would reduce them still yet further.
- Communities are preparing for the possibility there might not be legislative action. The city of Keene, for example, is projecting a 6 percent increase in its property tax as part of its overall budget.
- The COVID-19 pandemic has tragically taken the lives of more than one thousand Granite Staters, disrupted the New Hampshire economy, and upended our daily lives in ways large and small. We should not allow it to continue to have adverse consequences for our schools and the children and families they serve.

Neutral Information Presented:

Caitlin Davis, Director, NH Department of Education:

- School districts submit to the DOE twice a year, every year, free and reduced lunch counts of all students in school. School districts are responsible for collecting free and reduced lunch applications from families, and qualifying children for either free and/or reduced lunch meal programs. There are a variety of different programs across schools throughout the state. Most have the same qualification factors, which are 185 percent of the federal poverty limit, and 135 percent of the federal poverty limit for both free and reduced lunch price meal options. The free and reduced lunch data is used for a variety of

- different state and federal calculations, including municipal aid and adequacy, as well as various Title formula calculations.
- This year specifically, and actually starting at the end of last year the US Department of Agriculture, which oversees the free and reduced lunch meal program, provided school districts the authority to waive the qualification requirements for free and reduced lunch meals, meaning that school districts did not need to receive an application back from a parent to qualify and provide a free and reduced lunch meal. This was advantageous to school districts during the pandemic. These waivers are ongoing currently.
 - A problem has resulted in that school districts have been unable to receive this information back.
 - The benefit that parents see from the free and reduced lunch meal application is the actual free or reduced lunch meal that is provided to the student. And with that benefit being provided without having to do any additional work, many parents have not provided that information back to the school districts. Consequently, school districts have not been able to collect the applications. The applications are required to be eligible for all of these additional categories. To many this is confusing. The waiver is merely to provide the free and reduced lunch meal, but it is not to provide any free and reduced lunch data for the purpose of any federal or state aid calculations. The federal and state aid calculations still rely on the actual number of applications the schools have received back.
 - This bill would allow the DOE to modify the calculation. The Department maintains it would need this legislation. It cannot automatically use last year's data because it knows it is a better data set.
 - The fiscal note on the bill details last year's data versus this year's data. The ADMA for last year would be used for payment for the entire year. DOE also believes this would be for all areas of aid, including base aid, free and reduced lunch aid, third-grade reading aid, and special education aid.
 - Senator Morse explained the intention of this legislation was to return the school districts back to normal, and not introduce anything new at this point in time. Ms. Davis agreed.
 - Senator D'Allesandro inquired if the towns were expecting the Legislature to make changes that would accommodate the problem that occurred moving forward, by going back to a time when we had better data upon which to rely. Ms. Davis believes school districts have been reviewing the various legislative proposals.
 - For the November 15th estimate, DOE used the current data, resulting in many calls from school districts requesting the use of a different data set. DOE maintains they have no authority to do so without further legislation, and urged the districts to call their local Senators and Representatives. Senator D'Allesandro has received some of these calls.
