Summary of testimony presented:

Senator Ruth Ward - Senate District 8

- Senator Ward introduces SB 234.
- This bill was requested by a NH resident.
- The question is how we can get information to our kids who need help quickly.
- One way to accomplish this is by having the National Suicide Prevention number easily accessible on student IDs.
- UNH is already in the process of implementing this. One campus already has the hotline on their ID cards and the university is working to ensure all

campuses have this hotline available.

- This bill does not require schools to have ID cards. But the schools that already have ID cards, must add the suicide prevention hotline.
- This bill is simple, straightforward and will help students.

## Elliot Gault - Legislative Director, Office of Governor Chris Sununu

- Governor Sununu supports this bill.
- Our nation's youth are not insulated from struggling with mental health.
- Last month, the U.S. Surgeon General issued an advisory on the Youth Mental
- Health crisis further exacerbated by the COVID-19 pandemic.
- Mental health challenges are the leading cause of disability and poor life outcomes in young people before the pandemic.
- Up to 1 in 5 children ages 3-17 in the U.S. have a mental, emotional, developmental or behavioral disorder.
- The Governor's Office has made mental health initiatives a priority. For instance, the launch of the state's rapid response system in January 2022.
- The rapid response program includes mobile crisis support and a 24/7 crisis call center.
- The state is also investing in hospitals to provide acute mental health care for children.
- This bill would provide another easily accessible route for youth to find critical help.
- Senator Kahn asked Mr. Gault if he knows the mobile crisis center's hotline number. Mr. Gault said he does not, but can get back to the committee.
- Senator Kahn asked Mr. Gault if the mobile crisis center's hotline is the same as the national hotline. Mr. Gault said he believes it is.
- Senator Kahn suggested that the national hotline and the campus hotline be included on ID cards, as students could be anywhere during a time of crisis. Senator Kahn is not certain how many hotlines exist to include on an ID card.
  - o Mr. Gault said the bill, as written, uses "or" as some campus hotlines already exist for when students are on campus. Mr. Gault is aware of UNH including their campus crisis hotline.

## Martha Dickey

- Supports the bill.
- Her son tragically died of suicide in 2017. He was 19.
- According to the CDC, between 2007 and 2018, the national suicide rate among young people, ages 10-24, increased by 57%. It is hard to pinpoint the exact cause of this rising percentage.
- The COVID-19 pandemic has only exacerbated this crisis.
- Other states have already taken steps to make the National Suicide Prevention hotline more accessible to students and youth.
- When she heard about these initiatives, she decided she needed to do something in NH.

- SC, IL, and AZ are just a few of the states that have taken legislative steps to add the National Suicide Prevention hotline to their student IDs. CA has required this by law since 2019.
- This bill could be life-saving by showing support to students who are vulnerable.
- While her son had graduated prior to his death, his student ID card was still in his wallet on the morning he took his life. Had the hotline been on his student ID card, he might not have taken his own life.
- It is our duty, as community members, to ensure that these resource are readily available.
- A teen reaching out and asking for help takes immense courage and strength.
- Speak with your teens/kids and listen.
- This bill provides hope. If one life is saved, we have done our part.

## Holly Stevens - Director of Public Policy, NAMI-NH

- Support this bill.
- The increase in suicide rates is real.
- A chart, included in her testimony, shows the second leading cause of death for youth ages 10-14 and 15-24 is suicide.
- This chart creates a picture about how important it is to do anything we can to prevent suicide.
- 18.8% of high school students seriously thought about attempting suicide and 8.9% attempted suicide.
- This bill is a small change to simply add the hotline to the back of the card.
- If passed, this bill would take effect on July 31, 2022, and the national '988' phone number will be in effect. At that time, that would be the best number to use as anyone who calls in would be linked to the state's mobile crisis teams.
- As of January 1, 2022, the '833' interim phone number went into effect which mobilizes the mental health crisis teams in NH.
- Riverbend, a community mental health center, has forwarded their after-hours line to the '833' hotline.
- As of mid-July, 2022, there will be one number nationwide to access services.
- Senator Hennessey asked when the '988' goes into effect, will we still have the '833.' Ms. Stevens said no, we will transition to the '988' number only.
- Senator Hennessey asked if Ms. Stevens had an opinion on the "either/or" question about having multiple hotlines on a student ID. Senator Hennessey also asked if a student is not feeling support on campus, would they be more apt to call the campus hotline or the national hotline.
  - Ms. Stevens said she is unsure if she can answer that question as a person would be in a time of crisis. The '988' line will be the '911' likenumber for mental health crisis services. Therefore, it would not make sense to not include '988' on IDs.
- Sen. Prentiss asked Ms. Stevens about the "either/or" question and if the national helpline or campus hotline or both should be included on IDs.
  - Ms. Stevens said she is not certain as she does not know the parameters

or accessibility of these varying numbers, i.e. are all numbers 24/7 or are some sent to voicemail after hours.

- Folks need '988' for a live person who can put them in touch with a mobile crisis team to provide an assessment.
- Sen. Prentiss noted that there was a time when we did not have '911' and we had to dial a 7-digit number. '911' proved to be much more expedient and she sees '988' working out similarly.

## Testimony



Good morning, Chairman Ward, and members of the Committee. My name is Martha Dickey, I live in Northfield. Thank you for allowing me to speak today in favor of Senate Bill 234, relative to requiring student identification cards to include the National Suicide Prevention Lifeline.

On September 14, 2017, we lost our son, Jason, to suicide. A day that will haunt us for the rest of our lives. Jason was 19 years old at the time of his death. He loved his friends and family and made everyone around him happy. He will always be loved and missed.

According to the CDC, between 2007 and 2018, the national suicide rate among young people aged 10-24 increased 57 percent. It's hard to pinpoint why the rate has gone up, but everybody has their challenges, and that has never been more obvious than during this pandemic.

As teen suicide rates continue to rise, other states are trying to make it easier for students to reach out for help, by putting it right in the palm of their hand. When I read about this, I knew I had to bring the concept forth here in New Hampshire.

Newly passed laws in South Carolina, Illinois and Arizona are putting the National Suicide Prevention Lifeline number on student ID cards. California has required the lifeline to be on student IDs since 2019, and several other states currently have similar bills before them as well.

I believe that passing a similar law here in New Hampshire will be lifesaving. Showing this level of support to students who may feel vulnerable or unsupported is important and I believe that this will truly change people's lives.

Even though Jason was already graduated from high school, he kept this high school ID card in his wallet and it was with him that morning when he took his life. I can't help but think that if

this ID had the National Suicide Prevention Lifeline number in it, maybe he would have called it that morning.

These resources must be made readily available. It is our duty as parents, educators, health professionals and law makers to help prevent teen suicide. To know that a teen reached out and says "help me" - that's a sign of courage and tremendous strength. To infuse hope that there is someone on the other end of the telephone, whether they call or text, gives a kid a chance to know that they're a call away from talking to a trained expert. No matter what a person is going through, there is always hope. Speak with your teens, talk to them and don't just talk. Listen.

I've said before that if even one life is saved, you've done your part to help. I appreciate your thoughtfulness regarding the bill before you, and sincerely hope that you will consider passing it. Thank you for your service to the state of New Hampshire and for your time today.

Dear Chair and Committee Members:

Thank you for the opportunity to testify today. My name is Holly Stevens, and I am the Director of Public Policy at NAMI NH, the National Alliance on Mental Illness. NAMI NH is a non-profit, non-partisan, grassroots organization whose mission is to improve the lives of all people impacted by mental illness and suicide through support, education and advocacy. On behalf of NAMI NH, I am here today to speak in favor of SB 234, requiring student identification cards to include the National Suicide Prevention Lifeline.

Over the past decade, already high suicide rates have been rising in the United States and in New Hampshire. Attached to this testimony is a chart detailing the leading causes of death in the US. This chart is the product of the National Center for Injury Prevention and Control at the Centers for Disease Control and Prevention. It shows that the second leading cause of death for 10–24-year-old individuals is suicide. This is the exact age range that this legislation is targeting.

Additionally, according to Health Affairs, between 2007 and 2018, suicide increased 57.4 percent in 10–24-year-olds. In one survey of high school students, one in three youth reported persistent feelings of sadness or hopelessness and one in five had seriously considered suicide.<sup>1</sup> More precisely, results from the 2019 Youth Behavioral Risk Factor Surveillance System show that 18.8% of high school students seriously considered attempting suicide and 8.9% attempted suicide.

SB 234 offers a simple solution that has the potential to save lives. Suicide phone lines provide timely and constant access to a resource that provides support and comfort to those who are actively suicidal. Printing the National Suicide Prevention Lifeline on the back of a student identification card is a great way to assure that this age group has access to this very important resource. For these reasons, NAMI NH urges the committee vote to recommend ought to pass for SB 234.

Dear Members of the Education Committee,

I would like to express my support for Senate Bill 234, an act requiring student identification cards to include the National Suicide Prevention Lifeline. This bill would require public schools that issue student identification cards to include the National Suicide Prevention Lifeline or their own mental health support helpline on those cards. This requirement would also apply to institutions of higher learning within the state.

Sadly, our nation's youth are not insulated from struggling with their mental health. Just last month, the U.S. Surgeon General issued an advisory on the Youth Mental Health Crisis further exposed by the COVID-19 pandemic.<sup>1</sup> According to the advisory, mental health challenges were the leading cause of disability and poor life outcomes in young people before the pandemic, with up to 1 in 5 children ages 3 to 17 in the United States having a mental, emotional, developmental, or behavioral disorder. The pandemic's ongoing disruption to the lives of children and adolescents has only exacerbated those pre-existing challenges.

Last October, national health professionals and experts declared a National Emergency in Child and Adolescent Mental Health citing increases in emergency department visits for mental health emergencies from prior to the pandemic.<sup>2</sup>

Since taking office, I have made mental health initiatives a priority and it has been an all-handson-deck effort over the last several years to make it a reality. Some recent successes include the January 1, 2022 launch of the state's rapid response system to ensure individuals in mental health crisis have timely and appropriate medical care. The Rapid Response program includes mobile crisis support and a 24/7 crisis call center for mental health, behavioral health, and SUD crises. As the pandemic exacerbated mental health challenges for our youth, we moved quickly to supplement mental health supports by funding a Jesse Lewis Choose Love mobile tour, which provided Social and Emotional Learning to youth throughout the State. The State spent millions to promote youth activities outside of the classroom, and to provide access to mental health supports through summer camps. Finally, this year the State is making an historic investment by acquiring Hampstead Hospital to provide acute mental health care for children and youth.

In addition to these initiatives, there is always more that can be done. The small change in this bill helps ensure another easily accessible place for New Hampshire's youth to find information to access critical help. The National Suicide Prevention Lifeline provides suicide prevention support as well as help for those in emotional distress.

To be clear, this bill will not require grades six through 12 public schools to issue student identification cards if a school district does not already do so. It would simply require them to include the helpline information if they choose to issue student identification cards.

To that end, I respectfully request the committee to consider my letter of support when deliberating the merits of this bill.
