Summary of testimony presented:

Senator Jay Kahn - Senate District 10

- Senator Kahn introduced SB 353.
- The professional standards board reports to NHDOE and provides guidance for the department.
- This issue of length of appointment of members was brought to his attention by Steve Appleby of NHDOE.
- These recommendations seem appropriate and fairly minor to address the number of years that people can serve on the board.
- The bill also references the destruction and maintenance of records of hearings that become before the board.

Steve Appleby – Division Director, NH Department of Education

- This bill cleans up language in statute.
- The effort to clean up the language is to be in line with terms used in the field, i.e. instructional specialist.
- This bill has also enabled a third consecutive term for board members, when possible.
- Over the years, the board has found that two, three-year terms result in folks just beginning to understand the intricacies of the rules, and then they rotate off the board. Then, you lose expertise.
- They also have subcommittees, that span over a number of years, that cover complicated issues. Members leaving right as they begin to fully understand a subject is problematic.
- There is a language cleanup from "chairmen" to "chairperson."
- This bill also requires only one report per year now.
- For the bureau credentialing, record retention is sometimes quite onerous. At one point, they had 70 filing cabinets.
- The bill would only require them to store 25 years of records. This would reduce the materials that the department has to store and maintain. This would save time and money.
- He has never received a request that went back more than a few years; 25 years is a prudent timeline.
- Currently, the department has 57 years of history.
- Senator Kahn asked about records retention and if there are is a comparable/benchmark on how long records should be retained. Mr. Appleby said he is not sure he could provide a benchmark.
- The professional standards board is advisory in nature and not a rulemaking body. Their charge is to study and recommend changes to licensure rules for educators in our state.
- Once state board receives input, they have the option of adopting, changing, or sending back recommendations. Thus, any information that goes back to the state board, the state board retains that information as well.
- Any recommendation that comes out of the professional standards board, goes to the state board, which then becomes a part of their archive. The state board archive goes back very far.
- We do have access to many records through the state board; not requiring both boards to maintain records is reasonable.

- Senator Ward asked Mr. Appleby what the difference between an instructional specialist and an advanced teacher.
- Mr. Appleby said instructional specialists are folks who teach the teachers on their skills through a supportive role. For example, think a reading/writing specialist who teaches an elementary reading teacher. They try to categorize as certain endorsements apply to some and not all.
