This bill would repeal RSA 141-c:1-a, which provides that "Every person has the natural, essential, and inherent right to bodily integrity, free from any threat or compulsion by government to accept an immunization. Accordingly, no person may be compelled to receive an immunization for COVID-19 in order to secure, receive, or access any public facility, any public benefit, or any public service from the state of New Hampshire, or any political subdivision thereof." The law currently provides protection from over-reaching mandates by government on its people and the majority of the committee believes this law has served the state well with no negative consequences and should remain in effect.

# Testimony In Favor Of HB 425-FN "AN ACT repealing the statute relative to medical freedom in immunizations."

There is no natural, legal or constitutional right to spread any communicable disease, especially not a respiratory virus like COVID-19 which has killed over 1.14 million Americans. The pandemic has slowed down a little since I introduced an identical bill almost exactly a year ago, when the death toll stood around 900,000. "Only" a quarter of a million Americans have died from COVID in the last 52 weeks. But even a quarter of a million is a horrific loss of life. The pandemic is the worst catastrophe in US history in terms of loss of life, even worse than the Civil War.

The worldwide death toll is 6.78 million and counting.

The COVID vaccines may not be 100% effective or 100% safe, but they are very good. There is a lot we still don't know about the virus, but we do know for sure that it is extraordinarily contagious and dangerous. There are now some treatments for it, but there is no cure.

I represent Durham, which is the home of UNH. Like other colleges and universities, UNH took a very aggressive approach to fighting the pandemic, beginning with masking up and social distancing, and continuing with testing for the virus. When the COVID vaccines became available almost exactly two years ago, UNH did everything in its power to make sure that everyone in its close-knit student body, as well as the faculty and staff, gets immunized. If UNH was a private school, it could have simply enacted a rule requiring everyone on campus who can be vaccinated to actually get vaccinated. However since UNH is a public institution, it was and still is forbidden by RSA 141-C:1-a from taking that step. This makes no sense.

Our public colleges and universities have the same responsibilities as any other institution when it comes to protecting their students and their employees from COVID-19. They should have the right to require vaccinations, if that is what is needed. The same goes for noneducational government institutions, as well.

**Testimony for HB 575** 

Relative to vaccine and pharmaceutical products purchased, promoted, or distributed by the state and its political subdivisions House Health, Human Services and Elderly Affairs Committee February 16<sup>th</sup>, 2023

#### The NH Department of Health & Human Services (DHHS) opposes HB 575.

Chairman MacDonald and Members of the Committee,

My name is Dr. Ryan Tannian, and I am a registered pharmacist and Chief of the Bureau of Infectious Disease Control with the NH DHHS' Division of Public Health Services (DPHS). I am also joined by Dr. Benjamin Chan who is an infectious diseases physician and the NH State Epidemiologist. We are here to speak in opposition to HB 575 relative to vaccine and pharmaceutical products purchased, promoted, or distributed by the state and its political subdivisions. If enacted, HB 575 will have potentially wide-ranging negative and unintended consequences for NH DHHS, other state agencies, counties, cities, towns, schools, and many other partners, as discussed below.

First, the proposed legislation is unclear and lacks sufficient detail to know what is intended by requiring "human clinical trials." There are different types of studies and different outcomes that can be measured. Some studies are conducted to evaluate safety of a pharmaceutical product, while others might focus on measuring the effectiveness; some studies evaluate both. There are also different ways to measure the effectiveness of a product. **The wording in the proposed legislation is vague with unclear intent.** 

The most significant consequence of this proposed legislation is that NH DHHS and various other governmental and quasi-public partners would not be able to purchase, promote, or distribute potentially many different routinely recommended and life-saving vaccines or other medical therapies. The Department believes this legislation was proposed because of concerns about the COVID-19 bivalent vaccine formulations. The updated COVID-19 bivalent vaccines followed a process similar to the approval of annual influenza vaccines. A comprehensive collection of trials studying COVID-19 vaccine safety and effectiveness were reviewed by the FDA and CDC before the COVID-19 bivalent vaccines became available in September 2022. These included human clinical trials of previous monovalent vaccine formulations, and human clinical trials of different bivalent vaccine formulations, including beta-variant bivalent vaccines and BA.1 bivalent vaccines. The significant amount of data that had accumulated on COVID-19 vaccine safety and effectiveness is summarized in a NH Science Brief that was published by NH DHHS in September 2022 shortly after COVID-19 bivalent vaccines became available. Subsequent real-world vaccine effectiveness studies have since confirmed the superior immune response and protection of bivalent vaccines (compared to the original monovalent formulation) against COVID-19 and severe disease.

Because the COVID-19 bivalent vaccine authorization followed similar processes and criteria for how the updated influenza vaccine is approved each year, if HB 575 is enacted, it is likely that NH DHHS and our

partners would be unable to purchase, promote, or distribute the annual influenza vaccine for patients and staff, including at county nursing homes or correctional facilities, New Hampshire Hospital, Gelncliff Home, the New Hampshire State Veteran's Home, and the Manchester or Nashua Public Health Departments. This is contrary to the mission of these individual organizations and DHHS.

Also, depending on how this proposed legislation is interpreted, there are other routine childhood and adult vaccines that periodically get updated for which there isn't always new "clinical trial" data that reports vaccine efficacy. Rather, some vaccines are approved and recommended by inferring vaccine effectiveness through comparison of immune system responses to show that a new vaccine produces an antibody response that is similar, or "non-inferior," to an older version of the vaccine. This is very similar to what was done during the initial bivalent vaccine roll-out. Updated Pneumococcal vaccines in children (e.g., Prevnar 13, Vaxneuvance) is one example. If this proposed legislation passes availability of these types of routine vaccines, that prevent invasive life-threatening bacterial infections, could be adversely impacted.

HB 575 will also likely lead to higher patient costs for some childhood vaccinations. NH DHHS is able to purchase childhood vaccines at a reduced cost through our Vaccines for Children (VFC) program, and then distribute them to healthcare providers so that the cost of childhood vaccines can be minimized for families. If NH DHHS and other partners are unable to purchase, promote, or distribute certain vaccines (like the COVID-19 or influenza vaccines), then cost to individuals, communities, and the overall healthcare system will increase. Although COVID-19 is the leading cause of death by infectious or respiratory diseases in children, the Department does not intend to make COVID-19 or influenza vaccinations a requirement for school attendance.

An additional unintended consequence of HB 575 is the effect on an FDA provision known as expanded access, also referred to as compassionate use. Compassionate use is a mechanism in which patients with serious or immediately life threatening diseases or conditions gain access to medical products, to include drugs, biologics, or medical devices, which are outside the scope of the clinical trial after meeting certain criteria. These are products undergoing clinical trials, but in specific desperate situations they can be used under "compassionate use" when no alternative therapy options are available. Situations involving compassionate use include when patients suffer from conditions such as muscular dystrophy, ALS, and certain types of cancer.

Lastly, HB 575 specifies "voluntary" human clinical trials, and DHHS is unable to identify the intent or reason for such a provision. As specified in Federal Law, 21 CFR § 50.20, the use of involuntary human subjects in clinical trials is prohibited and is considered unethical. Also, HB 575 would "recognize the public health aspects to drugs and food under RSA 125:10 and RSA 125:10-a" and the intent of this statement and consequences are unclear.

In summary, we are opposed to HB 575 because the wording is vague and intent is unclear. This will likely lead to many unintended consequences, decrease access to vaccines and other therapeutics, and increase healthcare costs. There is already a robust federal regulatory and approval process to assess both the safety and effectiveness of vaccines and other therapeutics.

#### **METHODOLOGY:**

This bill repeals RSA 141-C:1-a, which states that no person shall be compelled to receive an immunization for COVID-19 in order to receive public benefits from the State of NH or any of its political subdivisions. The Department of Health and Human services anticipates no fiscal impact to that Department as a result of the bill.

Currently, RSA 141-C:21 makes it a misdemeanor for anyone to violate any provision of RSA 141-C. Accordingly, to the extent that an individual would otherwise be charged with violating RSA 141-C:1-a, this bill may result in a reduced number of charges being brought. There is no method to determine the fiscal impact on expenditures. However, the entities impacted have provided the potential costs associated with misdemeanor penalties below.

It should be noted that a person needs to be found indigent and have the potential of being incarcerated to be eligible for indigent defense services. Historically, approximately 85% of the indigent defense caseload has been handled by the public defender program, with the remaining cases going to contract attorneys (14%) or assigned counsel (1%). Beginning in March of 2021, the public defender program has had to close intake of new cases due to excessive caseloads. Due to these closures, the contract and assigned counsel program have had to absorb significantly more cases. The system is experiencing significant delays in appointing counsel and the costs of representation have increased due to travel time and multiple appointments.

Many offenses are prosecuted by local and county prosecutors. When the Department of Justice has investigative and prosecutorial responsibility or is involved in an appeal, the Department may be able to absorb the cost within its existing budget. However, if the Department needs to prosecute significantly more cases or handle more appeals, then costs will increase by an indeterminable amount.
