Testimony in Support of HB45 Representative Heath Howard (Strafford-4) January 19, 2023

The state of New Hampshire has a serious problem when it comes to what our workforce will look like in the next 15 years. Our public university system is one of the most expensive in the entire country and our students are paying the price at almost \$30,000 for in-state tuition and fees.¹ This disincentivizes students from attending in-state universities and contributes to our state's brain drain. High school grads are leaving our state for cheaper options and the out-of-state students are often unable to stay here. New Hampshire is the second oldest state and our workforce will be entering retirement soon, while at the same time we are also unable to retain students.² Unfortunately I could not find official data on this, but a private study published in 2021 saw that, upwards of 75% of high school grads could be leaving the state for higher education.³ So if our workforce is going to be retiring soon and our students do not want to stay here what are our options because if we do not start looking at solutions for this clear problem then our state will suffer. If you join me in supporting the creation of this study committee then we can clarify statistics and create a plan that will benefit our students and our state.

HB 45 - AS INTRODUCED

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Three

AN ACT establishing a committee to study student loan forgiveness in New Hampshire.

Be it Enacted by the Senate and House of Representatives in General Court convened:

Committee Established. There is established a committee to study the status of student loan
 forgiveness in New Hampshire.

3 2 Membership and Compensation.

I. The members of the committee shall be as follows:

5 (a) Three members of the house of representatives, appointed by the speaker of the 6 house of representatives.

(b) Three members of the senate, appointed by the president of the senate.

8 II. Members of the committee shall receive mileage at the legislative rate when attending to 9 the duties of the committee.

10 3 Duties. The committee shall study student loan forgiveness in New Hampshire and how to 11 ensure equality and economic justice in its application.

12 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from 13 among the members. The first meeting of the committee shall be called by the first-named house 14 member. The first meeting of the committee shall be held within 45 days of the effective date of this 15 section. Four members of the committee shall constitute a quorum.

16 5 Report. The committee shall report its findings and any recommendations for proposed 17 legislation to the speaker of the house of representatives, the president of the senate, the house 18 clerk, the senate clerk, the governor, and the state library on or before November 1, 2023.

19 6 Effective Date. This act shall take effect upon its passage.
