**Statement in support of Ought to Pass with Amendment:** The committee heard of multiple documented cases of NH students being vaccinated without parental consent, and even against the explicit wishes of their parents, at vaccine clinics held at NH schools. The intent of this bill is to prohibit the holding of such clinics during normal schools hours when students may possibly be errantly rounded up into the process to receive vaccinations. Nothing would prohibit the holding of such clinics outside of these prohibited hours. Also, in testimony from the Department of Health and Human Services, we heard that these clinics are held in such a manner as to fulfill federal requirements for various mass-casualty and biowarfare certifications, such that separate training events need not be held. While the committee recognizes the advantage of time and money savings, we feel it wholly inappropriate in this case. To even potentially distract any persons involved in such critical events as vaccination of children with the additional duties of federal box checking, seeking certifications, or additional onerous requirements that so often accompany federal mandates. The members of the committee in support of this bill supports the bill with or without amendment.



I am writing in opposition to House Bill 539.

As a Registered Nurse, Substitute School Nurse and a grandmother of school age children, I understand the critical importance of vaccines to protect our children from serious illness and even death.

Additionally, I have served as a vaccinator at school based vaccine clinics through my regional public health network for over 15 years. I have seen firsthand the tremendous value these clinics have for the community. These school based clinics provide access to vaccines to children whose families are unable to take time off from work or have transportation to have their children vaccinated somewhere else.

It is difficult to understand why the legislature would prohibit schools from conducting this valuable community public health service during school hours or within two hours of the beginning or end of the school day. This bill also requires a parent or guardian be present for a child to be immunized at a vaccination clinic at a public school. Again, there are families in our community that are unable to take time off from work to be present or do not have a means of transportation to go to the school for a vaccination clinic. Most of our children rely on public school transportation to get to and from school.

All of the school based vaccination clinics are conducted through the regional public health networks, in coordination with the local school nurse and administration, under the auspices of the Department of Health and Human Services. All members of the school based vaccination clinics must meet strict training and exercise requirements. This includes written parent/guardian consent for all vaccines given.

This bill unnecessarily decreases and limits access to vaccines that protect our children and their families from serious illness. This bill takes away local control by prohibiting this important public health service in every public school in every community in NH.

Thank you for your time and consideration in this matter. I hope you will oppose HB 539 for the welfare of our children.

I am writing on behalf of the NH Nurses Association to oppose HB 539. Many of our members volunteered at state run vaccine clinics during the height of the pandemic. Many of these clinics were school located sites which were invaluable in providing protections to some of our most vulnerable citizens. Limiting access to school located vaccination clinics has the potential to drastically reduce the availability of vaccines in the community which will increase vaccine preventable illness among the school aged population and their families. We urge the committee to oppose this bill. I have included the position statement from the National Association of School Nurses which outlines for the committee the important benefits of this valuable resource.

#### NASN POSITION

It is the position of the National Association of School Nurses (NASN) that reaching high vaccination coverage of school-age children, as outlined in Healthy People 2030 (U. S. Department of Health and Human Services [USDHHS], 2021a), is an essential public health objective. The National Strategic Plan for the United States 2021-2025 highlights the importance of increasing the availability of vaccines and removing barriers to access in non-traditional healthcare settings. School-located vaccination (SLV) can enhance other emerging non-traditional vaccination sites (USDHHS, 2021b). The registered professional school nurse (hereinafter referred to as the school nurse) is in a critical position to create awareness, influence action, and provide leadership in the development of SLV programs.

#### **BACKGROUND AND RATIONALE**

SLV has a long history in the United States and has successfully contributed to lower morbidity and mortality due to vaccine-preventable diseases (Park et al., 2021). In 1875, New York City used schools to deliver the smallpox vaccine. Schools were again utilized in the 1950s to deliver the Salk polio vaccine. In 1969, schools held vaccine clinics to administer the rubella vaccine, in the 1990s to conduct hepatitis B catch-up clinics, and again in 2009 for varicella and H1N1 vaccines (Mazyck, 2010; Hodge & Gostin, 2002).

The school is an ideal place to reach 55.5 million children from all cultures, socioeconomic groups, and age groups who attend each day; further, the school is conveniently located in a familiar and trusted community environment (National Center for Education Statistics, 2022a, 2022b). Studies

The threat to our children from vaccine preventable diseases is real and growing. Today, the serious threat of Bird Flu A (H5N1) becoming another pandemic is growing. This variety of flu is very contagious and is much more deadly than the annual flu. The case fatality rate is over 50%. As of Jan, 6, 2023 the A(H5N1) virus has been reported in 21 countries with 868 cases and 457 deaths. If this virus continues to spread globally we could have a catastrophe. There is a vaccine for influenza A(H5N1), however not enough to vaccinate the nation. If this virus does hit the U.S, we will need to guickly produce more vaccine and immunize the population very guickly to save millions of lives. To prohibit public elementary and secondary schools from conducting vaccination clinics during school hours would greatly hamper the ability to quickly and efficiently protect our children. Every parent would need to sign a consent form to have their child immunized, parents can refuse the vaccine for their child. However, for those who want to have their child vaccinated this allows them to do so without having to take time of work and make a special and unnecessary trip to get their child vaccinated. Please do not punish parents and children who want to be protected from vaccine preventable diseases for no logical or scientific purpose. We have held vaccination clinics for decades in schools for polio, measles, chicken pox, German measles etc. This is the most efficient and cost effective means of protecting our children, especially during a public health emergency. Please do not take this important public health tool away, you may live to regret doing so when the next public health emergency arrives.

# **Timothy Sennott**

I am writing in staunch opposition to HB539 - another knee-jerk, textbook agenda-borne bill that would prohibit public schools from conducting vaccination clinics during school hours. School sponsored clinics, conducted in accordance with local boards of public health, afford opportunities for many public school children to have access to services that, due to circumstances beyond their control, they may not otherwise have. Many children throughout the state of New Hampshire are reliant upon the services provided by the public school system, and punitive measures such as HB539, cast in response to isolated incidents that should be addressed directly, rather than through broad strokes legislation emboldened by a simple majority, punish only the children whose life circumstances are beyond the purview of their own actions. School sponsored clinics, usually conducted at the top of the cyclical flu season and immensely advantageous to children whose wellchild visits fall deep into the season, are conducted only under the permissive signature of parents or legal guardians. Failures that may arise in such a system are not within the purview of the state legislature, and should be addressed and rectified directly by the proper authority within the municipalities and townships in which they occur. This bill has the distinct scent of a local issue being punitively legislated to death within the halls of the New Hampshire State House, and this committee would do well to deem it inexpedient to legislate.

# Linda Mattlage

I am a retired APRN who volunteered to give flu shots at multiple schools over the years as a member of the Medical Reserve Corps. These immunizations were always administered with parental consent. This is a convenience for parents and in no way restricts their rights because they have to consent for their child to receive the immunization. HB 539 is not necessary and has the potential to diminish public health.

I am an RN who participates in school based vaccination clinics. These are an effective and safe way to vaccinate our children. Parents are invited to attend the clinics to be with their child, and often do attend.

## Anna Hullinger

This bill, should it be passed, would directly impact the State of NH. These clinics provide families an opportunity to vaccinate children without dismissing them from schools and interrupting parents time off. I oppose this bill because these are optional clinics that families can utilize in the school setting by reducing interruption to learning and work. Thats less burden on PCP or doctors' offices and those who might be needing to vaccinate for things like the flu with families that have multiple children. Specifically citing those who might be in rural communities where getting 1, 2, or even 3 children into the doctors could take several hours over a few days to accomplish. These are optional for families, and no one is being forced to utilized theses services. They are vital for rural communities and those who have transportation and access issues.

This bill does not help families who have trouble accessing health care due to work hours or other obstacles. Clinics help keep our children healthy. Vaccines do as well, unless you are interested in going back to the bad old days of polio, measles, mumps, rubella and chickenpox.

Due to illness, my plan to attend to testify is now a written testimony.

As a former school nurse in inner city elementary schools, I can tell you it was controlled chaos on good days. Due to children's wellness screens and medical needs, school nurses attempt to meet those needs expeditiously to get the child back to the learning environment as soon as possible. Going to the school nurse interrupts the child's learning and charging the schools with additional obligations will not help to improve academic proficiencies.

When I imagine what a vaccination clinic school environment might look like, my first thought is how would the child be closely monitored for any adverse effects once the vaccine was administered. A busy classroom teacher cannot be expected to monitor the children for unusual vaccine side effects. They are not healthcare providers.

Yes, immunization records are at schools but we always are in the process of retrieving records for both existing and new students. There is always the possibility that an unneeded vaccine be given if records are not precise. And, lastly, there are reports that two NH children have been given a vaccine without parent permission. Reportedly, the governor was made aware of one case. The thought of the controlled chaos scenario returns. Let's keep vaccinations the parent's responsibility under the care of the child's provider.

In my opinion, the child's well being would be better served in the primary care provider's office because the patient's medical records and vaccine histories are available. Parents can also bring their child to a local pharmacy and supervise the child afterwards.

Maintaining the current status in effect enhances both learning and wellness and are what I consider best practices.

I am a school nurse at a NH Middle School. We have approximately 430 students, 6-8th grade. Yearly, with the support of our school community, NH Public Health and our families, we are able to vaccinate roughly 100 students at our influenza clinic. Some students receive their vaccine at a pharmacy or MD office, but the convenience of having a clinic at school is priceless for some families. We have also offered Covid clinics as well as booster clinics at our middle and high schools. Being a public school in a large, diverse district, having these clinics during school hours is a great way for students to access services they might not be able to access otherwise. These clinics are coordinated well, with constant communication with Public Health. The group we work with prior to, and on the day of the clinic are professionals who do an amazing job with our students. I feel that doing away with this medical access would be a disservice to our student population and their families.

## Jennifer Tuthill

This bill is imperative to stop the forced vaccination and/or vaccination clinics in schools. NO child should ever be vaccinated with anything without the knowledge of and permission given by their parents. It is extremely important these oversights are prevented and stopped!

Vaccination clinics in public schools perform a valuable public health function to ensure that our population is immunized against endemic diseases. For families whose children are constrained from getting their "shots" by money or time, the Clinics provide a simple easy way to ensure that their children are safe and unlikely to spread disease. I OPPOSE this bill.

### Testimony for HB539: relative to vaccination clinics at schools

### Rep. Jim Kofalt (prime sponsor)

### Tuesday, February 7, 2023 (House Education Committee)

This bill would prohibit K-12 public schools in New Hampshire from hosting vaccination clinics during school hours. It would also stipulate that if vaccination clinics are held outside of school hours, that a parent or guardian must be present with their minor children at the time a vaccine is administered.

There are several reasons why this is important:

- First, there is fundamental conflict between the current practices in place at school-based vaccination clinics and the principle of informed consent.
- Second, it detracts from the core mission of our schools. I have personally spoken with numerous parents who will not send their children to school on a day when a vaccination clinic is being held, because they do not trust that their children will not be vaccinated.
- Third, there are serious safety concerns arising from the possibility that students being vaccinated could experience adverse affects, which could potentially even be life-threatening.

I will address each of these in turn, but first, I would like to share a story about what happened in Brattleboro, Vermont in November of 2021. Dario Politella was contacted by the principal at his son's school, urging him to provide a consent form to allow his 6 year-old son to receive the COVID-19 vaccine at an upcoming clinic to be hosted by the school. He declined, telling her that he did NOT want his son to get the vaccine.

Shortly after that conversation, Dario's son came home from school with a vaccine card. It had the correct first name, but someone else's last name. He was also wearing a nametag that matched that card. The school acknowledged that the boy had been vaccinated in error.

In May 2022, Dario and Shujen Politella filed suit against the school district and the state of Vermont. In December, a Superior Court judge dismissed their suit, ruling that the federal PREP Act exempts all parties from liability who are administering so-called "countermeasures" in response to a public health emergency. In other words, because of the PREP Act, no one can be held legally accountable for what happened to this family.

Informed consent dictates that a patient should understand what procedure is being proposed; they should clearly comprehend the risks, benefits, and alternatives; and their submission to a medical procedure should be voluntary. In the case of minor children, the right to informed consent rests with a parent or guardian.

The State of New Hampshire publishes a document entitled "Guidance and Standing Orders for Influenza Vaccinations." In two separate places, that document emphasizes the importance of obtaining consent. Page 16 includes the following statement:

Consent must be completed correctly. If the consent form is not completed in its entirety (i.e. missing an answer to a question, signed/dated by a parent/guardian, etc.), vaccination will need to be declined.

In September of 2022, the Nashua Department of Public Health conducted a flu vaccine clinic at the Birch Hill Elementary school in Nashua. At that clinic, they administered the flu vaccine to a 7 year-old

girl. The people responsible for conducting that clinic never received a signed consent form from the child's mother.

Several weeks later, at a meeting of the Committee to Study the Listing of Immunizations for Children, state Epidemiologist Dr. Benjamin Chan responded to questions about that incident, referring to it as a "never event." That's a medical expression used to describe situations that should simply never, ever happen, like amputating the wrong limb, operating on the wrong patient, or leaving a surgical sponge inside a patient following surgery. Medical experts say that what happened in Nashua should NEVER happen.

We were assured that incidents like this are rare, and that the state would be diligent in making sure that it did not happen again.

Several weeks later, it happened again. On October 3<sup>rd</sup>, the mother of a 5 year-old kindergarten student in Rochester returned her consent form to the school attended by her daughter. She did not sign the form, but wrote "[B.....] will not be getting this shot please. I do not consent." On the back, just under the signature line, she wrote the word "NO!" in large capital letters.

On October 18<sup>th</sup>, the Keaty Medical group conducted a vaccine clinic at the school, and administered the flu vaccine to that 5 year-old child.

The lesson here is that despite having policies in place affirming that parental consent is required, that every part of the form must be properly completed, and even that consent forms are only valid for 5 days; the organizations conducting these clinics simply cannot guarantee that they will be enforced. We know of at least these three cases, – two of which happened in New Hampshire. It seems likely that there are more cases which we don't know about.

There are ample reasons why a parent might not give consent to have their child vaccinated. The CDC website, for example, lists people who "can't get the flu shot." That list includes "individuals with severe, life-threatening allergies to flu vaccine or any ingredient(s) in the vaccine." Specific medical conditions that contraindicate the influenza vaccine include egg allergies, Guillain-Barré syndrome (GBS), or simply not feeling well.

Severe allergic reactions to the flu vaccine can occur. According to the CDC, "Life threatening allergic reactions to the flu shot are rare. These signs would most likely happen within a few minutes to a few hours after the vaccine is given."

Parents know what is best for their children, and they have the legal right to give or to withhold consent for their children to be vaccinated. Incidents like the ones I described earlier have eroded trust.

As I noted earlier, these vaccine clinics undermine the core mission of our schools, not only because they detract from learning time, but because they lead to kids being absent from school. I have personally spoken with numerous parents who will not send their children to school on a day when a vaccination clinic is being held, because they do not trust that their children will not be vaccinated.

The organizations conducting these clinics have demonstrated they cannot guarantee that children will never be vaccinated without parental consent. I ask you to vote for this bill so that we can protect the health and safety of *all* the children in our public schools, affirm our respect for the rights of parents to decide whether or not to have their children vaccinated, and focus on the core mission of our schools.

# Testimony in Favor of HB 539 Risa Evans, Contoocook, NH <u>Risae111@aol.com</u> 603-731-1733

I urge you to vote in favor of this bill for three reasons.

First, experience shows that mistakes are inevitable.

- Mistakes were made in Nashua, in Rochester.
- Mistakes were made in Vermont, (*Politella et al v. Windham Southeast School District et al*, No. 22-CV-01707, Vermont Superior Court, Windham Unit), where the school gave an unwanted C-19 injection to a six-year-old without parental consent, despite the child's own repeated protestations, including physical efforts to get away.
- Across the US, the Vaccine Adverse Events Reporting System (VAERS) includes reports of over 10,000 vaccine administration errors of various sorts since October 2021 for children ages 5-17 for COVID-19 injections alone.
- Mistakes were made.
- And no matter how well-intended we are, and regardless of the fail-safes we put in place, mistakes will be made again.

Second, because mistakes are inevitable, injuries are also inevitable.

- Most obvious are possible physical injuries to the children who receive unwanted, unconsented-to injections—hopefully mild but potentially severe and even deadly.
- Less obvious but no less important are spiritual injuries to children and parents whose sincerely held religious beliefs preclude introducing certain substances into the body and who experience unwanted vaccination as a desecration.
- Also less obvious, but equally important, are dignitary injuries—the type of injuries recognized by NH's simple assault statute, which precludes *any* unwanted touching, recognizing that such touching violates the fundamental right of personal bodily sovereignty.

Third, while mistakes are inevitable, and injuries are inevitable, remedies for those injuries are not.

- In the context of non-emergency vaccines, even if parents are able to obtain money damages through litigation, money cannot undo the types of injuries just described.
- Even worse, in the context of C-19 injections, there is effectively no remedy at all thanks to the Public Readiness and Preparedness Act ("PREP," 42 U.S.C. §§ 247d-6d and 6e).
- In the Vermont case, the judge dismissed claims of battery, negligent infliction of emotional distress, fraud, violation of the state healthcare bill of rights, and other state-law claims brought by the parents of a mistakenly-injected child, holding that PREP precludes *any* state-law remedy for C-19 vaccination errors.
- According to the judge, PREP nullifies all state laws protecting health and safety. In the words of the judge, PREP immunized all of the defendants against any state law claims of "MALFEASANCE."
- Under the VT case and others like it, PREP turns every C19 school clinic into a zone of lawlessness.
- Our kids deserve better. Please support this bill.

### COMPLAINT FOR DAMAGES BY JURY TRIAL

NOW COME the Plaintiffs, by and through counsel, Fitts, Olson, Giddings & Ferrara, PLC, who, upon information and belief, do respectfully and plausibly allege and aver, as follows:

### PARTIES:

The Plaintiffs are:

1. Tony and Shujen Politella, a married couple, living in the Town of Brattleboro, County of Windham and State of Vermont, severally, jointly, and on behalf of L.P., their son.

The Defendants are:

2. The Windham Southeast School District (hereinafter the "WSESD"), a publiclyfunded entity organized under Vermont laws to implement policies and budgets to provide, *inter alia*, for the safe education of students within its schools, and for centralized control and responsibility of all related functions and operations performed therein.

3. Patricia Walior, who was an Academy School teacher at all times relevant herein.

4. Amy Mejer, who was the Nurse at Academy School at all times relevant herein.

5. Jon Sessions, who was responsible for student safety at Academy School and at the vaccination clinic, at all times relevant to the allegations made herein, as Assistant Principal.

6. Kelly Dias, who was responsible for student safety and all activities at Academy School and at the vaccination clinic, at all times relevant to allegations herein, as Principal.

7. Mark Speno, who was responsible for safe school activities and operations across WSESD, including employee supervision and training pursuant to its effort to host a vaccination clinic at Academy School, at all times relevant herein, as School District Superintendent.

8. John/ Jane Does #1, #2, # 3, #4 & #5 (yet to be identified in Discovery under the Rules), who were employees of the State or volunteers at all times relevant to allegations herein.

9. State of Vermont, at all times relevant to the allegations made herein, did control, finance and control its Agency of Human Services, Health Department and Agency of Education regarding healthcare and education policy and goals (generally) and coordinated its vaccination clinic at Academy School, with respect to training and supervision of John/ Jane Doe #1, #2. #3, #4, and #5, and regarding its operating and financing agreements with WSESD (specifically).

10. Susan Slowinski, M.D., who was L.P.'s pediatrician and an attending physician at the State's school-based vaccination clinic at all times relevant to the allegations made herein.

11. Kelly Dougherty, who was responsible for staffing and operation of school-based vaccination clinics at all times relevant to this case, as Vermont's Deputy Health Commissioner.

### JURISDICTION AND VENUE

12. This Court's jurisdiction is exclusive under Vermont's Tort Claims Act, 12 V.S.A. §5601, and proper for 9 V.S.A. §2453 and 18 V.S.A. §122 private causes of action.

13. Venue is proper because all the events alleged herein occurred in Windham County, State of Vermont, where Plaintiffs are domiciled and the Academy School is located.

# FACTS (PART I)- REGARDING THE COMMERCE OF MASS VACCINATION

14. The State of Vermont Agencies of Education and Human Services entered an agreement ("MOU") to expand and promote public school-based healthcare services, statewide.

15. The State of Vermont and WSESD entered an Agreement to partner and host a vaccination clinic at Academy School, West Brattleboro, on Friday, November 12, 2021.

16. Pursuant to said Agreement, WSESD and/or Mark Speno, Kelly Dias, Amy Mejer and Jon Sessions, all or some of them, coordinated with Vermont's Human Services or Education Agency and other third-parties to host a school-based clinic in exchange for funding.

17. Kelly Dougherty knew of the Agreement regarding the Academy School clinic.

18. The Agreement contemplated that Mark Speno, Kelly Dias, Amy Mejer, Patricia Walior and Jon Sessions, entrusted by the community to care for its children, would promote the Academy School as hosting a safe and professionally managed clinic to increase its attendance.

19. Mark Speno, Kelly Dias, Amy Mejer, Patricia Walior and Jon Sessions, one or some of them, sent emails to parents in WSESD district, advertising the vaccination clinic.

20. The Agreement contemplated that Mark Speno, Kelly Dias, Amy Mejer, Patricia Walior and Jon Sessions would communicate with parents to promote how they should register children and consent to a vaccination, to participate in the School Vaccine Incentive Program.

21. This Incentive Program would provide funds to WSESD and the Academy School in proportion to the percentage of students enrolled at the school who were vaccinated.

22. The State's Agreement with WSESD contemplated that Amy Mejer or one of the Defendant Does will review parental consent forms and screen children for medical conditions.

23. Mark Speno, Kelly Dias, Amy Mejer, Jon Sessions and Patricia Walior, some or all of them, received training from Vermont Department of Health, particularly with respect to ensuring and documenting that only children having valid, express parental consent - and who were registered online - were positively identified to be vaccinated at the school-based clinic.

24. WSESD and Mark Speno, Kelly Dias, Amy Mejer, Jon Sessions and Patricia Walior were *de facto* servants and agents of the State, which leveraged their special relationship with parents and students to promote the clinic under an apparent safeguard of State oversight.

25. Academy School and WSESD were *de facto* landlords of the State's clinic.

26. The State recruited professionals such as Susan Slowinski and Does #1, #2, #3, #4 & #5, some of whom are licensed healthcare workers, to operate these school-based clinics.

27. John/ Jane Doe #1, #2, #3, #4 & #5 were State employees or Medical Reserve Corps personnel, staffing clinics in exchange for either current or future valuable consideration.

28. Kelly Dougherty, as Vermont's Deputy Commissioner of Health, was responsible for recruitment of staff to perform key functions at the clinics, such as vaccine administration.

29. Kelly Dougherty oversaw licensed medical professionals working at the clinic.

30. Susan Sowinski was a Vermont employee or a member of its Medical Reserve Corps, who agreed to staff the Academy School clinic in exchange for valuable consideration.

31. Susan Slowinski and Does #1, #2, #3, #4 & #5 received training regarding mass vaccination protocols from the Vermont Department of Health, with respect to parental consent.

32. Susan Slowinski and Does # 1, #2, #3, #4 & #5 were *de facto* agents of the State.

33. WSESD and the State worked hand-in-glove to coordinate the school-based mass vaccination clinic, with a common goal of generating revenue as pediatric healthcare providers.

34. The State had an obligation to WSESD, its employees, parents and students to direct its clinic's activities so as to avoid violating professional duties regarding medical care.

# FACTS (PART II)- REGARDING FAILURES AND DERELICTION OF DUTY

35. L.K., at all times relevant to allegations herein, was a five (5) year old boy who is too young to attend Academy School, and was NOT enrolled there. He is NOT party to this suit.

36. L.K.'s parents, by accessing the State's web-based registration portal, consented to his vaccination at Academy School, November 12, 2021. They are NOT parties to this suit.

37. L.P. (Plaintiff), at all times relevant to allegations herein was a six (6) year old boy, who was enrolled and did attend Academy School, since classes began in September, 2021.

38. L.P.'s parents (Plaintiffs) DID NOT access the State's web portal to register him, or provide consent for L.P. to receive any vaccination at Academy School, November 12, 2021.

39. On November 10, 2021, Mr. Politella brought L.P. to Academy School, where he attended in-person 1<sup>st</sup> grade class taught by Patricia Walior, who previously met L.P.'s parents.

40. Assistant Principal Sessions was greeting students outside as they arrived by bus.

41. Mr. Politella made a point of speaking with Mr. Sessions, to advise him that L.P. was not registered for the vaccine clinic that would take place Friday, because he had concerns.

42. Mr. Politella advised Mr. Sessions of the concerns he had regarding safeguards to protect L.P., who was not participating in the clinic, should he bring his son to school on Friday.

43. Mr. Politella told Mr. Sessions that L.P. did not have parental consent for a shot.

44. Mr. Sessions understood that L.P. was not registered for vaccination at the clinic.

45. Mr. Sessions, consciously disregarding the risk, misrepresented to Mr. Politella that L.P. cannot be vaccinated without consent, and it was safe to bring him to school, Friday.

46. Mr. Sessions, stating that student registrations were "not as many as we would have liked", quickly dismissed Mr. Politella's concerns, and then turned away and moved along.

47. On Thursday, November 11, 2021, Academy School was closed for Veteran's Day, and the Vermont Department of Health took occupancy to establish its vaccination clinic.

48. On Friday, November 12, 2021, the Academy School vaccination clinic opened.

49. Kelly Dougherty or Susan Slowinski were responsible for supervision, oversight and management of Does #1, #2, #3, #4 & #5 at the clinic regarding a variety of their functions.

The State had a duty to support its clinic with top-tier administrative, compliance and management capabilities, and to exercise due care in executing every function at its vaccine clinic to ensure that children, entrusted to WSESD for their education, were safe and unharmed.

51. Susan Słowinski knew both L.K. and L.P., (and their respective parents), from her defunct Brattleboro practice, "Just So Pediatrics", and recognized them at the vaccine clinic.

52. Kelly Dias, Patricia Walior, and Amy Mejer knew that Mr. Politella had spoken with Jon Sessions on Wednesday, regarding his concerns about L.P.'s inadvertent vaccination.

53. Kelly Dias, Jon Sessions, Patricia Walior and Amy Mejer, all knew that L.P. was not registered to receive, and should not get, any vaccination at the school-based clinic that day.

54. Susan Slowinski, Kelly Dias, Jon Sessions and Amy Mejer all knew that L.K.'s parents had registered him and that he had consent to be vaccinated at the school-based clinic.

55. Amy Mejer administered intake and outflow, and was responsible for confirming student identity, registrations and consent, and collecting and processing the related documents.

56. Susan Slowinski, Amy Mejer and some, or all, Does #1, #2, #3, #4 & #5, knew that they were, **in all circumstances and without exception**, legally obligated to confirm valid parental consent for the injection of an experimental vaccine into any minor under their care.

57. Susan Slowinski, Amy Mejer and some, or all, Does #1, #2, #3, #4 & #5, knew they were, in all circumstances and without exception, legally obligated to confirm the name, birthdate and identity of minors they medically treated, so as to only vaccinate the right child.

58. On Friday, November 12, 2021, Mrs. Politella took L.P. to the Academy School.

59. On Friday, November 12, 2021, L.K.'s mother took him to the Academy School.

60. L.K.'s mother spoke to Susan Slowinski regarding her responsibilities, that day.

61. Ms. Slowinski recognized L.K. from her "Just So Pediatrics" healthcare practice.

62. Amy Mejer verified that L.K. had his mother's consent to receive a vaccination.

63. L.K. was vaccinated by Does #1, #2, #3, #4 and/or #5, two or more of them, at approximately 10:15 AM, and was observed thereafter for any adverse reactions, until 10:30.

64. L.K.'s mother was given a card with the date and dosage of L.K.'s vaccination.

65. Thereafter, L.P. was in his 1<sup>st</sup> grade class, when John or Jane Doe #1 came, with Patricia Walior's full knowledge and assent, and took L.P. from his class to the vaccine clinic.

66. Ms. Wailor knew L.P.'s name, but made no effort to verify that he was the child whom John or Jane Doe #1 were seeking, prior to letting him be removed from her classroom.

67. John or Jane Doe #1 did not ask L.P. for his name, birth date or any identifying information, but erroneously hand wrote a label with L.K.'s name (not L.P's), and put it on L.P.

68. The erroneous label also identified "Walior 10:30", and a date of birth "5/23/16."

69. L.P., mindful that his parents had said "no" to the vaccination, verbally protested.

70. Heedless, John/ Jane Doe #1 ushered L.P. to the vaccine clinic and sat him down.

PTS, OLSON, GIDDINGS & FERRARA, P.L. C, 16 High Street Brattlebord, VT 05301 802-254-2345 71. Doe #2 offered L.P. a toy penguin, to distract him during the vaccination process.

72. Doe #2 took L.P., still protesting, to another seat, where his identity was not verified to confirm that his parents had registered him and granted consent for vaccination.

73. Doe #2 did not correctly identify L.P. as un-registered and lacking valid parental consent and escorted him to the vaccination area, where Does #3 and #4 waited to inject him.

74. Doe # 2 failed to compare L.P.'s name tag (proclaiming "L.K.") with any list of those children who had received a vaccination that day (which should have included "L.K.").

75. L.P., still protesting the injection because he knew that his parents had said "no", attempted to rise from the chair, and was restrained by Does #3 and #4, who laid hands on him.

76. Does #3 and #4 told L.P. he was "brave little boy" and injected him with vaccine.

77. Doe #3 or #4 bandaged the wound on L.P's arm, then took the toy penguin away.

78. L.P. was upset and Doe #3 or #4 repeated "It's okay, you're a brave little boy."

79. Doe #5 completed a card with L.K.'s name, showing date, lot and vaccine dose.

80. Later on, someone placed the card into L.P.'s school folder, inside his backpack.

81. L.P. was observed by Susan Slowinski and John/Jane Doe #1, #2, #3, #4, and#5, some or all of them, for fifteen (15) minutes post-injection, to identify any adverse reactions.

82. Susan Slowinski recognized L.P. as one of her patients from "Just So Pediatrics."

83. Doe #1 escorted L.P. back to his classroom without further medical supervision.

84. Thereafter, Kelly Dougherty was informed of a "mistake" at the Academy clinic.

85. After school, Ms. Politella picked up L.P. She saw the name tag with the wrong name, and assumed that he had played some make-believe games with friends at school that day.

86. L.P. told Mrs. Politella "Mommy, I got a shot today. They told me I was brave."

87. Mrs. Politella still assumed L.P. was playing his game, and joked along with him.

88. L.P. urgently explained to Mrs. Politella, "no Mommy, I really got a shot."

89. When Ms. Politella and L.P. got home, she unloaded his backpack and found the vaccine card. Then, she knew what the name tag meant, and she became emotionally distraught.

90. Under L.P.'s shirt, she found the bandage, and these emotions overwhelmed her.

91. Mrs. Politella, who was extremely distressed, did not want to upset her son, too.

92. She comforted L.P., telling him that he had not done anything wrong, at school.

93. L.P. woke up his father on Saturday morning, and then told him what happened.

94. Later that day, Kelly Dias called Mr. Politella to apologize for what happened.

95. Mr. Politella also returned a call from Kelly Dougherty, who reached out to him.

The motion is GRANTED.

RULING ON PENDING MOTIONS (Motion Nos. 2 and 3)

Plaintiffs Dario and Shujen Politella are the parents of six year old L.P. In an eight-count Complaint (filed May 13, 2022), they allege that various employees of both the Windham Southeast School District (collectively referred to as the "School Defendants") and the State of Vermont (collectively referred to as the "State Defendants"), acting in their official capacities, were negligent, and otherwise violated their state-protected rights when, without their permission, they administered to L.P. a COVID-19 vaccination during a school-based, statesponsored clinic. Primarily arguing that Plaintiffs' state-law causes of action are preempted by applicable federal law, the State Defendants, prior to filing a response to the Complaint, have moved to dismiss pursuant to V.R.C.P. 12(b)(1) and 12(b)(6), and the School Defendants, after submitting their Answer (filed June 20, 2022), have filed a motion for judgment on the pleadings pursuant to V.R.C.P. 12(c). For the reasons set forth below, the State Defendants' Motion to Dismiss (No. 2) and the School Defendants' Motion for Judgment on the Pleadings (No. 3) are both granted.

### I. Background

A court's review of either a motion to dismiss or a motion for judgment on the pleadings applies similar standards. Messier v. Bushman, 2018 VT 93, ¶ 9, 208 Vt. 261.

A motion to dismiss should not be granted unless there exist no facts or circumstances under which the nonmovant may be entitled to relief. ... On a V.R.C.P. 12(c) motion for judgment on the pleadings, the issue is whether, once the pleadings are closed, the movant is entitled to judgment as a matter of law on the basis of the pleadings. ... For the purposes of a motion for judgment on the pleadings, all well pleaded factual allegations Entry Regarding Motion Page 1 of 8

in the nonmovant's pleadings and all reasonable inferences that can be drawn therefrom are assumed to be true and all contravening assertions in the movant's pleadings are taken to be false. ... A defendant may not secure judgment on the pleadings if contained therein are allegations that, if proved, would permit recovery.

### Id. (citations and quotation marks omitted).

Accordingly, a motion to dismiss or for "judgment on the pleadings is designed to test the law of the claim, not the facts which support it." *Island Industrial, LLC v. Town of Grand Isle*, 2021 VT 49, ¶ 25, 260 A.3d 372 (citation and quotation marks omitted). "A defendant may not secure judgment on the pleadings if contained therein are allegations that, if proved, would permit recovery." *Id.* ¶ 10 (citation and quotation marks omitted); *accord Endres v. Endres* 2006 VT 108, ¶ 4, 180 Vt. 640 (mem.) (Motions to dismiss for failure to state a claim are disfavored and should rarely be granted.)

The Plaintiffs' salient and well-pleaded allegations are as follows. The Politellas are the parents of six year old L.P., who at all times relevant to the Complaint attended Windham Southeast School District member, Academy School, in West Brattleboro. *See* Complaint at ¶¶ 1, 37. On Friday, November 12, 2021, Academy School conducted a COVID-19 vaccination clinic which was organized and hosted by the State and School Defendants. *See, e.g.*, Complaint at ¶¶ 15, 48. It is undisputed that the Politellas did not consent to having their son, L.P., vaccinated. *See* Complaint at ¶ 38. Despite the Politellas' withholding of their permission, and their six-year-old's objections at the time of administration, it further appears undisputed that L.P. was mistakenly administered a COVID-19 vaccination on November 12. *See* Complaint at ¶¶ 109 ("Mark Speno ... sent a message to all parents in the District acknowledging that a child had been mistakenly vaccinated without consent at Academy School.") and 110 (Local paper published "Mr. Speno's apology: '[W]e are deeply sorry that this mistake happened'."); Answer at ¶¶ 109-10 (School Defendants claim insufficient knowledge and therefore deny Complaint ¶ 109 but admit ¶ 110). The Complaint contains no allegation of willful misconduct by any named Defendant.

As a result of the unauthorized vaccination of L.P., the Plaintiffs "have been traumatized, suffering mental anguish and additional educational expenses with the potential for future medical expenses." Complaint at ¶ 123. In addition, they "live with fear regarding unknown long-term adverse health effects that L.P., a young child -- having been subjected to risks associated with an investigatory vaccine of unknown safety profile, not fully understood and yet unapproved for children -- could suffer." Complaint at ¶ 122. In other words, the Complaint contains no allegation that any one of the Plaintiffs has suffered death or serious injury as a result of L.P.'s mistaken vaccination. Plaintiffs seek damages for their alleged injuries based upon the following theories: (1) violation of Vermont's Healthcare Bill of Rights, 18 V.S.A. § 1852(a)(5): (2) gross negligence; (3) negligent undertaking; (4) premises liability; (5) battery of a minor; (6) consumer fraud; (7) common law fraud; (8) negligent infliction of emotional distress. *See* Complaint at ¶ 124 *et seq*.

### II. Discussion

In their submissions, the parties have addressed extensively their views of the preemptive effect of the Public Readiness and Emergency Preparedness Act, 42 U.S.C. §§ 247d-6d and 247d-6e (hereinafter the "PREP Act"), particularly whether this act partially or completely preempts all state law claims. Upon review of a number of state and federal court decisions which have examined the preemptive effect of the PREP Act upon state law claims such as the Plaintiffs', this Court finds that the Plaintiffs' Complaint must be dismissed for failure to state a viable claim for relief.

Operation of the PREP Act may be summarized as follows:

Congress passed the PREP Act in 2005. This statute authorizes the federal Secretary of Health and Human Services ("HHS") to issue a declaration that "a disease or other health condition or other threat to health constitutes a public health emergency." 42 U.S.C. § 247d-6d(b). If applicable, the PREP Act provides immunity to "covered persons" from liability under federal and state law for "all claims for loss caused by, arising out of, relating to, or resulting from the administration to or the use by an individual of a covered countermeasure if a declaration under subsection (b) has been issued with respect to such countermeasure." *Id.* § 247d-6d(a)(1). The PREP Act requires a causal relationship between the injury or loss and the countermeasure. *Id.* § 247d-6d(a)(2)(B). If immunity applies, the injured person may seek compensation from the Countermeasures Injury Compensation Program ("CICP"), a federal regulatory program that covers some losses associated with use of covered countermeasures. *Id.* § 247d-6e.

The PREP Act provides one exception to immunity—when serious injury or death occurs through willful misconduct. In that situation the injured person or their survivors must file suit in the U.S. District Court for the District of Columbia and prove their injury by clear and convincing evidence. *Id.* § 247d-6d(c)(3), (e)(1). Furthermore the PREP Act includes an express preemption clause that reads, "no State or political subdivision of a State may establish, enforce, or continue in effect with respect to a covered countermeasure any provision of law or legal requirement that ... is different from, or is in conflict with, any requirement applicable under this section." *Id.* § 247d-6d(b)(8).

Khalek v. South Denver Rehabilitation, LLC, 543 F.Supp.3d 1019, 1023-24 (D. Colo. 2021).

Accordingly, the PREP Act does not completely preempt all state causes of action; rather, it operates as an immunity statute which in certain cases otherwise requires an injured person to seek compensation either through CICP or, in the case of alleged "willful misconduct," to opt to bring suit in the U.S. District Court for the District of Columbia and to prove his or her claim by "clear and convincing evidence." *See. e.g., id.* at 1025 ("Indeed, the primary method for resolving claims under the PREP Act is a regulatory program, the CICP, not a federal cause of action."). As one court recently observed:

[W]hen applicable, the PREP Act provides immunity to defendants on state law negligence claims. State law may be completely preempted when "it has been replaced

by federal law—but this happens because federal law takes over all similar claims, not because there is a preemption defense. ... Here, in addition to providing immunity, the PREP Act only supplies a limited cause of action for willful misconduct.

Parker Jr. Through Parker v. St. Jude Operating Company, LLC, 2020 WL 8362407, slip op. at \*6 (D. Ore. Dec. 28, 2020) (citations and footnotes omitted); cf. Padilla v. Brookfield Healthcare Center, 2021 WL 1549689, slip op. at \*6 (C.D. Cal. April 19, 2021) (comparing immunity under PREP Act to "a defense, not a necessary aspect of Plaintiffs' state law claims").

In this case, the Plaintiffs allege injury as a result of a countermeasure—COVID-19 vaccine administered by Covered Persons and pursuant to the PREP Act. As explained *infra*. because the PREP Act is patently applicable to Plaintiffs' stated claims, their Complaint must be dismissed.

In March 2020, the HHS Secretary declared the COVID-19 pandemic to be a public health emergency under the PREP Act. *See* Declaration Under the Public Readiness and Emergency Preparedness Act for Medical Countermeasures Against COVID-1, 85 Fed. Reg.15198-01 (March 10, 2020) (available on Westlaw at 2020 WL 1245193(F.R.)) (hereinafter "the Declaration"). "Covered persons" under the Declaration include the Defendants, as that term includes a state or local government program planner and a licensed health professional or other individual authorized to administer or dispense Covered Countermeasures. *See* Declaration at Section V. Furthermore, in relevant part, Declaration Section XI describes and defines "Covered Countermeasures" as follows:

Administration of a Covered Countermeasure means physical provision of countermeasures to recipients, or activities and decisions directly relating to public and private delivery, distribution, and dispensing of the countermeasures to recipients; management and operation of countermeasure programs; or management and operation of locations for purposes of distributing and dispensing countermeasures.

The definition of "administration" extends only to physical provision of a countermeasure to a recipient, such as vaccination or handing drugs to patients, and to activities related to management and operation of programs and locations for providing countermeasures to recipients, such as decisions and actions involving security and queuing, but only insofar as those activities directly relate to countermeasure activities. Claims for which Covered Persons are provided immunity under the Act are losses caused by, arising out of, relating to, or resulting from the administration to or use by an individual of a Covered Countermeasure consistent with the terms of a Declaration issued under this Act. Under the definition, these liability claims are precluded if they allege an injury caused by a countermeasure, or if the claims are due to manufacture, delivery, distribution, dispensing, or management and operation of countermeasure programs at distribution and dispensing sites.

Accordingly, it is unsurprising that the few courts which have considered the interplay between the PREP Act and a situation like the one presented in this case have concluded that the Act operates to bar state law claims. For example, in *Parker v. St. Lawrence County Public*  *Health Department*, 102 A.D.3d 140, 954 N.Y.S.2d 259 (N.Y. App. Div. 2012), a school nurse administered a flu vaccine to a kindergartner without permission. Parents alleged that administration of the shot constituted negligence and a battery on their child. Framing the "sole issue" as whether the PREP Act preempted plaintiffs' state law claims, the court concluded that it did, reasoning that "Congress intended to preempt all state law tort claims arising from the administration of covered countermeasures by a qualified person pursuant to a declaration by the Secretary, including one based upon a defendant's failure to consent...." *Id.* at 144 (citation omitted).

Similarly, days ago, in *Cowen v. Walgreen Co.*, 2022 WL 17640208 (N.D. Okl. Dec. 13, 2022), the plaintiff sued Walgreen drug store after an employee gave her a COVID-19 shot without permission instead of the flu vaccination she had requested. The court found plaintiff's remedy for her alleged injuries is solely through the CICP administrative program because the COVID-19 vaccine is a Covered Countermeasure under the PREP Act. Interestingly, the Oklahoma federal court further denied plaintiff leave to amend her complaint:

While it is true that other vaccinations or procedures might have also been administered, this does not change the fact that Plaintiff's injuries actually resulted from administration of the COVID-19 vaccine. The PREP Act therefore applies .... Plaintiff has provided no caselaw to support the it-could-have-been-a-different-vaccine argument, or to show that the PREP Act did not apply in a factually similar case. In its own research, the Court found none. Because Plaintiff's claims flow directly from the administration of a qualified countermeasure, there is no plausible way that amendment would alter the outcome.

*Id.*, slip op. at \* 3 (citation omitted).

Likewise, in *Storment v. Walgreen Co.* 2022 WL 2966607 (D.N.M. July 27, 2022), the court entertained a plaintiff's negligence claim arising from injuries she sustained from falling in a parking lot after she received a COVID-19 vaccination. As in *Cowen*, the *Storment* court considered the broad impact of the PREP Act when it is applicable:

Here, Plaintiff's Complaint alleges that she went to Walgreens for her COVID-19 vaccination, received such vaccination but then had no chairs to sit on for monitoring immediately following inoculation. ... Thus, she ultimately went to the parking lot to sit in her car but became dizzy and fell before she could get seated. .... This chain of events is unfortunate and certainly deserving of a remedy, but it cannot be divorced from the administration of a covered countermeasure—the COVID-19 vaccine she received. ... While it is true that other vaccinations or procedures might also leave customers dizzy, this does not change the fact that Plaintiff's injuries actually resulted from administration of the COVID-19 vaccine. The PREP Act therefore applies....

*Id.* slip op. at \*3 (citations and text omitted). As in *Cowen*, the *Storment* court dismissed the complaint with prejudice, noting "there is no plausible way that amendment would alter the outcome." *Id.* 

The parties have noted one decision in which a court has come to a contrary conclusion, *Tonkinson v. Walmart, Inc.*, 2022 WL 1266666 (Kan. Dist. Ct. April 26, 2022). In *Tomkinson*, plaintiffs claimed their 15-year-old child received a COVID-19 vaccine at a Walmart pharmacy, accompanied by her adult brother-in-law but without their parental consent. Rejecting the reasoning of the New York court in *Parker v. St. Lawrence County Public Health Department*, the *Tonkinson* court found that "[t] o the extent Plaintiffs have alleged facts regarding violations of parental rights, a right of privacy, duties to inform and to obtain legal consent, negligence, duties to refrain from misleading with regard to parental consent and records, and damages arising from such conduct regardless of the medical treatment or substance administered, those allegations are not covered by the PREP A[ct] immunity provision." *Id.*, slip op. at \* 11.

With respect, this Court finds the reasoning of the *Tonkinson* court unpersuasive and contrary to Congressional intent and directives. As outlined *supra*, when applicable, the PREP Act, and the remedies it outlines, provides immunity from other state law claims. The PREP Act's "immunity of covered persons" provision states, in part, that "the sole exception to the immunity from suit and liability for covered persons set forth in subsection (a) shall be for an *exclusive Federal cause of action* against a covered person for death or serious physical injury proximately caused by willful misconduct ...." 42 U.S.C. § 247d-6d(d)(1) (emphasis added). Moreover, "[d]uring the effective period of a declaration... or at any time with respect to conduct undertaken in accordance with such declaration, no State or political subdivision of a state may establish, enforce, or continue in effect with respect to a covered countermeasure any provision of law or legal requirement that ...is different from, or in conflict with any requirement applicable under this section ..." and which relates to the "distribution ... dispensing, or administration by qualified persons of the covered countermeasure ...." 42 U.S.C. § 247d-6d(b)(8). In this Court's view, these provisions indicate, *inter alia*, that negligence and similar state law claims are displaced in favor of liability for willful misconduct causing serious injury.

Finally, the Court finds most of the remaining cases upon which the Plaintiff relies inapposite because they involve allegations unrelated either to a "Covered Person" or a "Covered Countermeasure" within the scope of the PREP Act. For example, Plaintiffs bring to the Court's attention *Saldana v. Glenhaven Healthcare LLC*, 27 F.4<sup>th</sup> 679 (9<sup>th</sup> Cir. 2022), *cert. denied*, 2022 WL 1785186 (S.Ct. Nov. 21, 2022). They appear to believe that this decision supports their argument that, despite the applicability of the PREP Act, this Court may entertain their state law claims. *See* Plaintiffs' Supplemental Filing Regarding the Law (filed Nov. 30, 2022).

In *Saldana*, relatives alleged that a nursing home resident died from COVID-19 complications. They brought suit in state court against the nursing homeowner and operator, whom they claimed "failed to adequately protect Ricardo Saldana from the COVID-19 virus." They alleged state-law claims for elder abuse, willful misconduct, custodial negligence, and wrongful death. 27 F.4<sup>th</sup> at 683. After removal, the federal district court ordered remand to the state court, an action which the Ninth Circuit affirmed because the plaintiffs' claims involved California law and did not, on their face, raise questions of federal law. *Id.* at 689. The court of appeals reasoned that "[w]hether [one of several] claims is preempted by the PREP Act turns on whether any of the conduct alleged in the complaint fits the statute's definition for such a claim," and that since the answer to that question remained outstanding, remand to state court "for lack Entry Regarding Motion Page 6 of 8

of federal subject matter jurisdiction based upon complete preemption was proper." *Id.* at 688; *accord Maglioli v. Alliance HC Holdings LLC*, 16 F.4<sup>th</sup> 393, 409 (3<sup>rd</sup> Cir. 2021).

The fact that the *Saldana* court suggested that some of the plaintiffs' state law claims may proceed in state court does not help the Plaintiffs in this case. The *Saldana* plaintiffs basically alleged a "failure to protect" from COVID-19, which is not the same as alleging harm based upon receipt of a COVID-19 vaccination. "Courts addressing similar state law claims on removal have found that such failure to act does not implicate the PREP ACT and remanded those cases to state courts." *Padilla*, 2021 WL 1549689, slip op. at \*6. The reason is that an allegation that a defendant has failed to act, as compared to affirmatively administering a Covered Countermeasure vaccination, does not necessarily fall within the scope of the PREP Act. *See id.* 

Thus, "'[t]he majority of courts considering this issue have held that the PREP Act does not prohibit plaintiffs from bringing state-law tort claims based on the alleged failure to use covered countermeasures or failure to implement appropriate protocols related to COVID-19, including failure to provide adequate levels of staffing and training to staff." *Lollie v. Colonnades Health Care Center Ltd. Co.*, 2021 WL 4155805, slip op. at \* 3 (S.D. Tex. Sept. 13, 2021). Not only is this result harmonious with the PREP Act's provision of a federal cause of action for affirmative, "willful misconduct," but it also is in contrast to the instant Plaintiffs" attempt to pursue state law claims in this Court. It is impermissible because plaintiffs' claims are based upon the affirmative administration of a vaccine, and not on allegations such as the negligent failure to provide one. *See, e.g., Cagle v. NHC HealthCare-Maryland Heights, LLC*, 2022 WL 2833986, slip op. at 8 (E.D. Mo. July 20, 2022) (PREP Act not implicated by claims "premised on a failure to take preventative measures to stop the spread of COVID-19, and that none of the harm alleged was causally connected to the administration or use of any covered countermeasure…"). State law remedies are not covered by the PREP Act when they involve nonfeasance. They are covered by the Act when, as here, they involve misfeasance.

### III. Conclusion

Where a court dismisses a complaint pursuant to V.R.C.P. 12(b) prior to service of defendant's responsive pleading, the "proper course ... is to dismiss with leave to amend." *Neal v. Brockway*, 136 Vt. 119, 122, 385 A.2d 1069 (1978); *see Ondovchik Family Limited Partnership v. Agency of Transportation*, 2010 VT 35, ¶ 7, 187 Vt. 556. Similarly, citing "Vermont's extremely liberal pleading standards," the Supreme Court recently has indicated that "[t]he standard for granting a motion for judgment on the pleadings is an exacting one, [which it] will only uphold granting ... if the plaintiff's pleadings contain no allegations that if proven would permit recovery." *Huntington Ingalls Industries, Inc. v. Ace American Insurance Company*, 2022 VT 45, ¶ 17, \_\_\_\_ VT \_\_\_.

For the aforementioned reasons, the State Defendants' Motion to Dismiss (No. 2) and the School Defendants' Motion for Judgment on the Pleadings (No. 3) are both *granted*. In light of

the Vermont Supreme Court's directives, the Court grants both Defendants' motions, with leave to amend within 30 days of the date of this ruling. See V.R.C.P. 11(b)(2).

- Vaccination errors happen more often than you think, and yes, they do happen at schools too. <u>An Elementary School In Southern Maryland</u> <u>Mistakenly Vaccinated The Wrong 6-Year-Old Child - The BayNet</u>. Let's not add to the possibility of more things going wrong at schools and expose the taxpayers to liability problems.
- Even if nothing goes wrong at the school, vaccination day at school is very disruptive and causes unnecessary distractions from classwork.
- Would you drop your young child off at the doctor's office for his/her immunization shots? Is this a model for good parenting?

Honorable Chair and Members of the New Hampshire House Education Committee:

My name is Ann Marie Banfield. I am a parental rights advocate focused on academic excellence in education for all children in New Hampshire. I come here in support of HB539, a bill that prohibits a public elementary or secondary school from conducting a vaccination clinic during school hours.

As you will or have heard, we have two incidents where children in Rochester and Nashua were given a flu shot against their parents' wishes. They did not consent, and even indicated that they did not want this vaccine given to their children. In the case in Rochester the young child was also sick when she received the vaccine. Not only did her mother send the permission slip back saying DO NOT VACCINATE my child, her child was sick at the time.

This bill is very simple, it will eliminate the possibility of mistakes in the future. If a parent or guardian must be present, they would be overseeing the medical care they are receiving.

Offering these clinics during school hours caused these errors to occur. The parents thought that they could trust that if they did not consent, that would all that would be necessary.

Now parents are saying to keep their children home if they do not want their child vaccinated. The schools cannot be trusted with this task. Another day lost to receiving an education because this news has spread to parents across the state.

Schools have enough on their plate, when are we going to stop asking them to fix every problem that arises among children? We expect them to assess and treat their mental health. We expect them to solve their drug and alcohol problems. We expect them to teach them about sex. Now we expect them to administer vaccines to children. When do they have time to teach the academics?

\*Vaccination is a medical procedure, an elective medical procedure \*Schools are for educating, not for performing medical procedures

\*Vaccination clinics in schools, during school hours is an antiquated program that now presents more risks than benefits. It used to be that access to vaccines were limited and that there were only a couple vaccines routinely given. These days vaccines are available everywhere from corner drug stores, grocery stores, doctors of all kinds, hospitals, urgent care facilities, and even public health offices and clinics. There simply is no longer a need for schools to host vaccination clinics in schools, during school hours.

\*NH DHHS has public health clinics in various communities that provide vaccination clinics to the public for those who may not have a regular doctor or insurance coverage.

\*These days there are over 20 different vaccines that may be administered to children, including Covid shots, many calling for 4, 5, or 6 doses. It may be that a child has already received all desired vaccines, or has had a prior adverse reaction, or is protected by their natural immune system, or is not a risk for a particular illness. I have heard about parents whose children were "accidentally" vaccinated in school clinics, against parental written instruction to not vaccinate and have seen copies of the vaccination consent forms where it was clear that the parent did not want their child vaccinated, yet they were vaccinated at school.

\*Vaccines, all vaccines not just Covid shots, carry with them known and unknown risks of harm including illness, disability, and death. Some of these adverse effects are immediate, some occur hours, days, weeks, or months later.

\*There are many reports of harm and death from vaccination, but I'll point out a couple relevant to children. One is Kaylynne Matten from Vermont who died from myocarditis following a routine flu shot. She died on December 6, 2011. She was vaccinated with a flu shot on a Friday afternoon and died in her mothers arms on Tuesday morning. It was "only" 1 shot. The other child is a recent death of a 2 year old NH girl who was given a flu shot and a Covid shot on December 15, 2022 and died the very next day, December 16, 2016. It was "only" 2

shots. These shots were not given at a school clinic, but they are the very shots that are often administered at school clinics. Clearly there is risk of death.

\*Every child deserves the attention and comfort of a parent for every medical procedure, especially an elective medical procedure such as vaccination.

\*In reviewing the fiscal note methodology it greatly concerns me, and it should concern others as well, that DHHS admits that these school vaccination clinics are being utilized for "training and exercise requirements". Yes, children are being used for training. Do parents even know that? Did you know that? I believe that parents have an expectation that when vaccinations are given, they are given by fully trained professionals.

While this bill simply excludes vaccination clinics from school hours and school days and the hours surrounding the school day, it certainly does not prohibit use of schools at other times for vaccination clinics that could certainly provide the opportunity for training that DHHS seeks.

#### Good Afternoon,

My name is Allison Dyer, I am a divorced mother of one beautiful little 8 year old and a lifelong resident of Nashua NH.

I am here to today to ask that you support HB539, a bill that would prohibit conducting vaccination clinics during school hours.

The opponents of this bill would tell you its necessary because this has been a staple of health since the time of Polio vaccines, but the opponents of this bill will also be the first to tell you the world is changing and evolving so we must get with the times. And yes the times are forever changing. But Parents are and for the most part have always been capable of getting their children the medical care they need and require.

I believe schools are a place for education, not medical services, however I do believe schools can provide medical education in the form of DHHS contact & clinic information to the families of the children in their districts. > Good Afternoon, My name is Yari Perez, I am a single mother from Nashua NH.

I am here to today to ask that you support HB539, a bill that would prohibit conducting vaccination clinics during school hours.

My 7 year old daughter was given the flu vaccine without my consent at her Nashua Elementary school through one of these mobile vaccine clinics. My 7 year old daughter was traumatized, she was brought into a room, her arm held down, she cried, she screamed, then she was administered a dose of flu vaccine through a needle that was Never consented to.

She came home that day and presented me with a Nashua DHHS Vaccine Card, she did the best job a 7 year old could in explaining all that happened that morning ... I checked her bag, there was No Facts sheet or adverse reaction sheet sent with this vaccination card, I comforted her as best I could and in my panic I reviewed all my paperwork and emails to see if I could have possibly accidently consented to this. In my review of all my emails & papers, I did not sign the vaccine consent form, so this had been the worst kind of error. Not only did I not understand how this could have possibly happened, but my daughter did not understand how I could have allowed this, why I would do this to her without giving her a "heads up" and why I wasn't there to go through this scary moment with her.

No mother should have to care for an avoidable incident like this, AFTER the fact.

Since this has happened, my daughter has been fearful to be called anywhere in the school, the intercom announcements give her anxiety, she has been sick off and on since receiving the flu shot and I am unsure since she had never received this vaccine prior to this incident at school if the two could potentially be related.

I did not know how to address this atrocity, I am thankful for my friend and lifelong Nashua Resident Allison Dyer for aiding me in bringing this to light, had she not alerted everyone from the school to the state I do not believe they would have taken this issue seriously. I fall into a category, the opponents of this bill claim to care about, I am a single, latina mother who has struggled to provide all I can for my daughter since the death of her father. BUT I am not incapable of making appointments for my OWN child whether that be at the pharmacy or at her pediatrician's office for regular well visits or necessary vaccinations. But when this issue was brought to the attention of Nashua DHHS, they refused to answer my friend Allison and ask for my contact information, she is a polarized figure in my community due to her outspokenness and advocacy for the children of my city. To quote directly from Nashua DHHS Director Bobbie Bagley "I will Not Respond to Ms. Dyer" because my friend Allison had emailed on my behalf about the incident and asked that anyone wanting to speak with Me directly about my daughter, respond by email to Allison and she would provide my contact information. This is not how public appointed and tax payer paid and funded entities should deal with our children and families. I have seen what has happened to persons who speak out in Nashua, so in the throws of this traumatic moment, Allison supported me to take the brunt of how the machine of Nashua deals with mistakes.

This should have never happened

We need to make sure something like this never happens again

And the assumptions that persons like myself and so many who fall within an income bracket that some may consider less desirable, lack the ability to get to the doctors office or pharmacies with our own children must stop and does not justify these programs in our schools when we as parents are not present.

Dear Chair Ladd and Members of the Committee:

New Futures appreciates the opportunity to testify in opposition to **HB 539, relative vaccination** clinics at schools. New Futures is a nonpartisan, nonprofit organization that advocates, educates, and collaborates to improve the health and wellness of all New Hampshire residents. In this role, we work extensively with policy makers, health care providers and communities to improve overall public health and improve health equity across the Granite State. New Futures supports public health policy measures that decrease illness and disease, including immunizations and programs that ensure equitable and broad distribution of vaccines-especially for children.

The New Hampshire Immunization Program partners with eight Regional Public Health Networks to organize school-based influenza immunization clinics. The Public Health Networks work with the Medical Reserve Corps, volunteers, nursing school students and school nurses to schedule clinic times, distribute and collect consent forms, and ensure a safe clinic environment. <sup>1</sup> These Networks partner with local schools to vaccinate students and adults against seasonal influenza and prioritizes schools where children are less likely to be insured or have other barriers to being vaccinated. According to the New Hampshire Division of Public Health Services, over 4566 individuals were vaccinated at school based clinics in the fall of 2022.

HB 539 would prohibit public and charter elementary and secondary schools from conducting a vaccination clinic at any time during school hours, or within 2 hours of the beginning or end of the school day.

The well reported "Tripledemic" consisting of flu, RSV, and Covid-19 has put a strain on hospitals nationwide and here in New Hampshire.<sup>2</sup> School based clinics that provide influenza and Covid-19 vaccines are one tool in the toolbox for public health practitioners to keep our communities safe. This legislation would remove the state's ability to provide a vital public health service to its residents. For these reasons. New Futures strongly urges the committee members to vote Inexpedient to Legislate on HB539.

#### **METHODOLOGY:**

This bill prohibits public elementary, secondary, and charter schools from conducting vaccination clinics during school hours or within two hours of the beginning or end of the school day. In addition, the bill requires a parent or guardian to be present in order for a child to be immunized at a public school vaccination clinic. The Department of Health and Human Services assumes the bill will result in a reduction in the number of vaccination clinics conducted in public schools. This may have an indeterminable effect on Department expenditures, as direct and indirect costs related to vaccine and clinic operational costs fluctuate based on demand and access. Additionally, the Department states that school-based clinics satisfy federal Point of Distribution and Strategic National Stockpile training and exercise requirements. A reduction in the number of clinics may require the Department to secure alternative training and exercise solutions for the state's regional public health networks, at an indeterminable cost.

The Department of Education states the bill will have no fiscal impact.

#### AGENCIES CONTACTED:

Departments of Education and Health and Human Services
