9 3 Capital Projects; University System of New Hampshire.

10 I. The New Hampshire legislature recognizes the need for investment in university system
11 of New Hampshire projects primarily to renovate and expand facilities. The sum of \$42,000,000 is
12 hereby committed and appropriated to the university system of New Hampshire (USNH), effective
13 July 1, 2020 but limited to the drawdown of funds as stated in this section. The appropriation is for
14 the following capital projects:

- 15 A. Spaulding Hall renovation and expansion (UNH);
- 16 B. Hyde Hall Innovation and Entrepreneurship Center renovation (PSU); and
- 17 C. Elliot Student Service Success Center renovation (KSC).

18 II. The university system board of trustees will determine the timing of the projects and the
19 specific dollar allocation to each from the above sum available, while ensuring the respective
20 campus priorities are addressed. The board of trustees shall report on the progress of the projects
21 in paragraph I to the capital budget overview committee in October and April. The appropriation
22 shall be nonlapsing and in addition to any other appropriation to the university system; provided,
23 however, that the university system shall not receive actual cumulative payments from the state for
24 such purposes of more than:

- 25 A. \$10,000,000 through the biennium ending June 30, 2021.
- 26 B. \$25,000,000 through the biennium ending June 30, 2023 (\$15,000,000 in new
27 authorization for the biennium).
- 28 C. \$42,000,000 through the biennium ending June 30, 2025 (\$17,000,000 in new
