CURRENT STATUS OF ONGOING PERFORMANCE AUDITS:

Stephen Smith, Audit Division Director, informed the Committee members of two audits currently in process: the Department of Education (DOE), Bureau of Vocational Rehabilitation; and the Liquor Commission, Division of Enforcement and Licensing. Field work for the Bureau of Vocational Rehabilitation is still active. Completion is targeted for February. Planning is near completion and fieldwork has begun for the Liquor Commission, Division of Enforcement and Licensing. The scope statement was to be discussed momentarily, and the completion is targeted for February.

Mr. Smith reminded the Committee of the four audits in the queue: 1) the Department of Administrative Services, Office of Cost Containment; 2) the Department of Health and Human Services, Sununu Youth Service Center; the Board of Dental Examiners at OPLC; and 4) Department of Profession Licensure and Certification. No work had begun on the audits.

Representative Ober requested that of the four audit topics, the Sununu Center audit be moved to the top of the queue.

DISCUSSION AND APPROVAL OF PROPOSED SCOPE STATEMENT FOR THE LIQUOR COMMISSION, DIVISION OF ENFORCEMENT AND LICENSING:

Steven Grady; Senior Audit Manager and in-charge auditor of the Liquor Commission, Division of Enforcement and Licensing audit; briefed the Committee and responded to questions regarding the scope statement on the Liquor Commission, Division of Enforcement and Licensing audit.



PROPOSED PERFORMANCE AUDIT SCOPE BOARD OF DENTAL EXAMINERS

In August 2019, the Fiscal Committee of the General Court adopted a joint Legislative Performance Audit and Oversight Committee recommendation to conduct a performance audit of the Board of Dental Examiners (Board). We held an entrance conference with representatives of the Board and the Office of Professional Licensure and Certification (OPLC), in December 2020.

BACKGROUND

The Board was created to protect the public's health, safety, and welfare by licensing and regulating dentists and dental hygienists. To achieve this objective, the Board was required to establish licensure requirements and issue licenses to qualified applicants, establish rules to regulate dentistry and dental hygiene, and receive and adjudicate complaints against licensees.

Management Control Framework

The Board and the OPLC were responsible for designing integrated control systems to help achieve objectives, operate efficiently and effectively, report reliable information, and comply with laws and rules. Controls can help assure accountability and encompass the plans, methods, policies, and procedures used to fulfill the Board's purpose and accomplish strategic goals and objectives. However, preliminary analysis indicated the Board lacked control systems to manage its relationship with the OPLC, oversee its committees, manage and monitor its performance and compliance with laws and rules, manage information, and ensure transparency and consistency.

Organization

The Board's nine governor-appointed members served five-year terms. The Board included six dentists, two hygienists, and one public member. Several committees supported Board operations. The statutory Dental Hygienists Committee was to develop rules regulating the practice, discipline, education, examination, and licensure of hygienists. The rules-based Anesthesia and Sedation Evaluation Committee was to ensure dentists with general anesthesia or sedation permits conformed to applicable rules, and a subordinate advisory subcommittee, formed at the Board's request in calendar year (CY) 2017, was to provide advice on anesthesia-related issues.

The OPLC was created to provide the Board efficient administrative, clerical, business process, and recordkeeping support. Reportedly, administrative, clerical, and recordkeeping support included assistance with rulemaking and proposed revisions to laws, taking meeting minutes, and maintaining records. Business process support was reported to include processing licensing applications, maintaining a licensure database, processing and reviewing complaints, overseeing complaint investigations, and managing the disciplinary process.

Licensing

The Board held authority to establish substantive requirements for becoming licensed and retaining licensure, while the OPLC was responsible for efficient operation of licensing processes. Applications for initial licenses, which lasted two years, were processed manually. Applicants had to meet educational, examination, conduct, and other requirements to be eligible. Renewals were processed electronically starting in CY 2018, in alternating years for dentists and dental hygienists. Licenses

could be renewed by meeting professional conduct and other requirements, including continuing education. Late renewals were permissible with a fee, but if a license lapsed, it could be reinstated.

The Board also issued permits to qualified licensees for anesthesia-related procedures, some of which required both facility inspections and comprehensive evaluations. Additionally, the Board regulated aspects of dental assistants' practice, certified public health dental hygienists, and permitted expanded function dental auxiliaries.

There were reportedly 4,260 active Board licenses in State fiscal year (SFY) 2020. The numbers of permits and other certifications issued were not published. Board revenue in SFYs 2018 and 2019 totaled \$871,142, primarily obtained from licensing fees, while expenses totaled \$521,119.

The State's pandemic response affected the Board's operating environment. Emergency orders allowed for emergency licensing and telehealth, altered licensee continuing education requirements, and altered applicant examination requirements.

Monitoring And Enforcement

To regulate the practices of dentistry and dental hygiene, the Board was empowered to investigate potential professional misconduct among licensees and take necessary disciplinary action. The Board could receive complaints about potential misconduct, or, alternatively, the Board could initiate an investigation without a complaint if it had a reasonable basis for doing so. The Board then would conduct adjudicative and disciplinary proceedings, as needed. During SFY 2020, the Board reportedly received 41 complaints and took no disciplinary actions. The imposition of disciplinary action was not consistent year-to-year, however. In SFY 2018, the Board reportedly received 34 complaints and took disciplinary action in 11 cases.

AUDIT SCOPE

We will design the audit to answer the following question: How efficiently and effectively did the Board administer its responsibilities and operations regulating the professions of dentistry and dental hygiene during SFYs 2019 and 2020? To address this question, we plan to:

- review relevant State and federal laws, administrative rules, declaratory rulings, orders, plans, policies, procedures, guidance, and similar materials;
- review audits, guidance, and related materials from other states and national organizations;
- interview Board members and staff with relevant responsibilities;
- observe Board and committee meetings occurring during the audit;
- obtain perspectives from external stakeholders; and
- obtain, review, and analyze relevant Board records and data.

We will examine management controls and other relevant matters outside the audit period when they affect Board operations during and after the audit period. We will also examine OPLC and other agencies' management control systems when they directly affect Board operations.

We anticipate completing this audit and presenting the final report to the Fiscal Committee in early fall CY 2021.
