Dear Senator Reagan and Members of the Committee,

I am pleased to announce the National Conference of State Legislature (NCSI), through its National Legislative Program Evaluation Society, has awarded the LBA Audit Division with a 2022 Certificate of Impact for its 2019 performance audit on the Adult Parole Board. This topic was initiated by the Legislature Performance Audit and Oversight Committee and provided the Board and the Department of Corrections with 26 observations and corresponding recommendations covering Board access to inmate information, medical parole, revocations, reduction of sentences, and other administrative functions. Besides being presented at the Fiscal Committee, it was also heard by the House Judiciary and House Criminal Justice and Public Safety Committees.

The Adult Parole Board has begun the process of documenting its policies and procedures as recommended in various observations. We identified five subsequent statutory changes based on suggestions or recommends made in the audit report. The Board requested and received from the Legislature additional positions to address LBA audit findings including a full-time position to assist the Executive Assistant, a part-time position to assist with rulemaking, one additional full-time case manager position, and the Board Chair became a full-time employee.

Significant contributors to this report include Vilay Skidds, Paige Lorenz, Andrea Provost, Jay Henry, and Stephen Smith. This work not only recognizes the hard work of the LBA auditors, but also the actions taken by the Board, Department, and Legislature.

#### LEGISLATIVE PERFORMANCE AUDIT AND OVERSIGHT COMMITTEE MINUTES

May 10, 2022

The Legislative Performance Audit and Oversight Committee met on Tuesday, May 10, 2022 at 10:00 AM in the LOB Room 212.

The meeting was called to order by Senator Reagan at 10:00 AM.

#### VOTE ON ACCEPTANCE OF THE FEBRUARY 23, 2022 MEETING MINUTES

The motion to accept the February 23, 2022 meeting was accepted.

MOTION ADOPTED.

#### STATUS OF ONGOING PERFORMANCE AUDITS

Stephen Smith, Director of Audits, provided the Committee with brief updates of ongoing performance audits:

- The Board of Dental Examiners we are in the process of report writing and working with the Board and Office of Professional Licensure and Certification (OPLC). It has been a lengthy process, but the goal is to have a draft vetted by us, internally, to the Board and OPLC by the end of May. It will take approximately a couple of months for them to get through it, as they are volunteers and only meet once a month.
- Mental Health Workforce Requirements, Department of Energy, Weatherization Assistance Program and Special Education Dispute Resolution Processes we will present scope statements for the LAPOC's approval. We are continuing with planning and with the approval of scope statements, field work will soon begin. Senator Giuda stated that he would be interested in seeing if there are any disparities between New Hampshire and other states regarding licensing; he specified other states having "stair steps" to certification and where disparities were within those steps. Senator

D'Allesandro stated his interest in obtaining more information regarding reciprocity among the states.

Medical Subsidy – we have completed our work and drafted a letter, we're not calling it a
report, which we vetted through the Department of Administrative Services and the New
Hampshire Retirement System. We will give this to Mike Kane for his distribution to
legislative leadership.

#### VOTE ON PRE-SCOPE AND SCOPE STATMENTS:

On a motion by Representative Weber, seconded by Senator Hennessey, that the scope statements for the Mental Health Workforce Requirements and the Department of Energy, Weatherization Assistance Program performance audits be accepted.

#### MOTION ADOPTED.

Jay Henry, Performance Audit Supervisor, expressed his interest in beginning with the dispute resolution portion of the audit, and proceed with the Bureau of Special Education audit once auditors are freed up. After continued discussion, the Committee agreed to bifurcate the audit into two reports.

On a motion by Representative Weber, seconded by Senator Hennessey, that the pre-scope statement of Special Education Dispute Resolution Processes & Department of Education Oversight of Special Education performance audits be accepted.

MOTION ADOPTED.

#### IDENTIFY NEW TOPICS, OTHER BUSINESS AND PRIORITIZE AUDIT WORK:

The Committee discussed the HB 1135 requiring a performance audit of the Education Freedom Account Program. Senator Hennessey began discussion in regard to the effective date of this audit, and asked if the amended future date works better for audit purposes.

Stephen Smith, Director of Audits, informed the Committee that the new date of October 1, 2023 works well. The longer into the future, the more information and data we will have to evaluate. This is a house bill, and normally topics come from this Committee. In this case, it will be charged with statutorily, if and when it is approved.

Discussion followed regarding the Office of Professional Licensure and Certification, and various complaints from various boards that were received. The OPLC in currently in a state of significant transition, and an audit at this point would be premature. Senator Reagan informed the Committee that this topic would be placed on the next agenda.

Two other topics were mentioned by Representative Weber as potential audits. The first was a review of the Secretary of State's Archives and Records; the second was public lake access. A member mentioned that there is a committee on public water access.

#### DATE OF NEXT MEETING AND ADJOURNMENT:

Next meeting will be at the call of the Chair. Senator Reagan adjourned the meeting at 10:48 AM.
