### Interpretative Ruling 2007-#1 (October 29, 2007)

The Legislative Ethics Committee received a request for interpretative rulings regarding typical issues that have confronted legislators and legislative employees in complying with the new requirements of RSA 15-B, including the propriety of, and reporting requirements relating to, the acceptance of free admission or tickets to events sponsored by organizations and entities that appear before the General Court, or the acceptance of meals and/or other underwriting for various types of programs and events. In response to the following specific scenarios, the Committee issues the following rulings:

#### 1. Complimentary admission to sporting or performing arts events.

**Issue:** The University of New Hampshire has inquired as to whether it may extend and legislators may accept an invitation to attend, at no charge, a hockey game or performing arts production at UNH.

**Response:** If the value of the admission is less than \$25, as determined by its regular price, free admission to such events does not constitute a prohibited gift. See RSA 15-B:2, V(a)(2) and XI.

If the value of the admission is \$25 or greater, the admission would be a prohibited gift. No other exemption appears to apply. A hockey game or performing arts event does not appear to be a "charitable, ceremonial or political" event, and so is not qualified for exemption under RSA 15-B:2, V(b)(9).

#### 2. Complimentary admission to dinners or receptions at which food and beverages are provided.

**Issue A:** Tickets at no charge to an annual dinner sponsored by a chamber of commerce or similar organization.

**Response:** Complimentary admission may be accepted by a legislator or a legislative employee, even if the value of the admission is \$25 or greater, if (a) it is offered directly by the sponsoring organization, and (b) the event is charitable, ceremonial or political, and (c) the sponsoring organization is a charitable organization registered with the Division of Charitable Trusts of the NH Department of Justice, or is qualified as charitable under Section 501(c)(3) of the Internal Revenue Code. RSA 15-B:2, V(b)(9)(A) and (B). Note that some chambers of commerce may not qualify as charitable organizations.

Such admission is not “expense reimbursement” as defined in RSA 15-B:2, IV and need not be reported as such.

**Issue B: Receptions where free appetizers, drinks, and meals will be provided.**

**Response:** Attendance and consumption of complimentary food and beverages does not involve a prohibited gift, if:

- (a) the value of the complimentary food and beverages is less than \$25 (RSA 15-B:2, V(a)(2)); or
- (b) the reception is a political or ceremonial event which is published as an event open for attendance by any member of the general court in the calendar of the Senate or the House (RSA 15-B:2, V(b)(9)(C)); or
- (c) the primary significance of the event is ceremonial or celebratory and is public or, if by invitation only, it is planned to have an attendance greater than 50 people. RSA 15-B:2, V(b)(10)(A); or
- (d) the complimentary food and beverages are consumed at a meeting or event, the purpose of which is to discuss “official business.” RSA 15-B:2, V(b)(12). This is construed to mean that the purpose of the meeting or event is to discuss legislative business, that is, pending legislation or some issue of general policy which is or may be the subject of legislative attention. RSA 15-B:2, VIII-a. However, for meals and beverages whose value exceeds \$25 and qualify for acceptance only pursuant to this exception, legislators and legislative employees must file a report with the Secretary of State no later 10 days following the meeting or event. RSA 15-B:6, II.

**Issue C: Awards, Ceremonial Objects or Door Prizes.**

**Response:** Awards or ceremonial objects that are personally inscribed to the recipient may be offered to and accepted by legislators and legislative employees if the value is primarily personal to the legislator or legislative employee (for example, a personalized plaque, citation or trophy) and has a monetary value of \$150 or less. RSA 15-B:2, V (b)(4).

However, other items such as door prizes, that is, items other than personalized awards or ceremonial objects, may be offered and accepted only if their value is less than \$25. RSA 15-B:2, V(a)(2).

**3. Invitations to House or Senate committees by an interested party to a site-visit to view a particular business, location, hospital, natural area or park that is related to an issue upon which they are or will be deliberating, where the committee may be provided with transportation and a meal or refreshments as part of the site-visit. These site-visits are generally noticed in the calendar of the applicable legislative body.**

**Issue:** May committee members accept the transportation and food offered as part of these site visits and, if they may, must they file an expense reimbursement form?

**Response:** When an entire committee is invited to participate in a site-visit on an issue that is relevant to the committee’s business, they may accept the free transportation and meals provided. The site-visit by the committee constitutes an event where the members are attending in their official committee capacity representing the house or senate. As such the meals and transportation are not prohibited gifts. RSA 15-B:2, V(b)(10)(B).

This is not “expense reimbursement” within the meaning of the statute and, therefore, expense reports are not required for these items.

**4. A legislator has a private breakfast, lunch or dinner meeting with individuals interested in issues before the legislature, at which they discuss these issues.**

**Issue:** May the legislator accept an offer from these individuals to pay for the legislator’s meal?

**Response:** If the meal is consumed at a meeting or event, the purpose of which is official business, the meal would not be a prohibited gift but would have to be reported if the value of the meal exceeded \$25. RSA 15-B:2, V(b)(12) and RSA 15-B:6, II. In the case of a legislator or legislative employee, “official business” means

the discussion or transaction of legislative business, that is, any official action or non-action with regard to any pending or existing legislation, report or study, any matter pending or proposed in a committee or in either house of the general court, or any other matter which is within the official jurisdiction or cognizance of the general court. RSA 15-B:2, VIII-a. Nonetheless, Ethics Guidelines Section 4, VII(f), which establishes a \$250 annual limit from any given source, will still apply.

## 5. Expense reimbursements and other filings.

**Issue:** Under what circumstances must a legislator or legislative employee file an expense reimbursement report for the expense of meals, beverages, lodging or transportation associated with attendance at informational or educational conferences, seminars, or meetings? Must a legislator or legislative employee file an expense reimbursement report for accepting food and beverages valued at less than \$25 at such an event?

**Response:** An expense reimbursement report must be filed with the Secretary of State's office in the following circumstances:

**A) Someone else pays for your cost associated with attending a bona fide conference or seminar.** A legislator or legislative employee must file an "Honorarium or Expense Reimbursement Report" with the Secretary of State's office when he or she receives payment in any form as prepayment, underwriting, or reimbursement of the reasonable expenses of attendance, registration, travel, meals, or lodging related to a bona fide informational or educational conference, seminar, or meeting. RSA 15-B:2, IV. Such expense reimbursement is directly authorized by statute and may be accepted, provided that the recipient reports it and attaches to the report a copy of the agenda or an equivalent document which discloses the subjects addressed and the time schedule of all activities at the event. RSA 15-B:5.

However, no reporting is required when the source of such reimbursement is the state, a county, the United States of America or an organization to which the state pays dues and the reimbursement is provided because of the dues paid. RSA 15-B:2, IV and RSA 15-B:5.

**B) Meals and beverages, valued at more than \$25, consumed in the course of official business.** A legislator or legislative employee must file a report with the Secretary of State's office when she or he accepts meals and beverages with a value greater than \$25 consumed at a meeting or event pertaining to official business, unless the acceptance of the meals and beverages falls under any of the other exceptions to gifts set forth in RSA 15-B:2, V(b).

**C) Honorarium.** Legislators and legislative employees must report the receipt of honoraria. "Honorarium" means a payment in any form for an appearance, speech, written article or other document, service as a consultant or advisor, or participation in a discussion group or similar activities. Honorarium does not include a payment for such activities for which the person is being compensated by the state, a county, the United States of America, or by any other employer or client, where the activity giving rise to the honorarium is not related to or associated with any public office or government employment. RSA 15-B:6.
