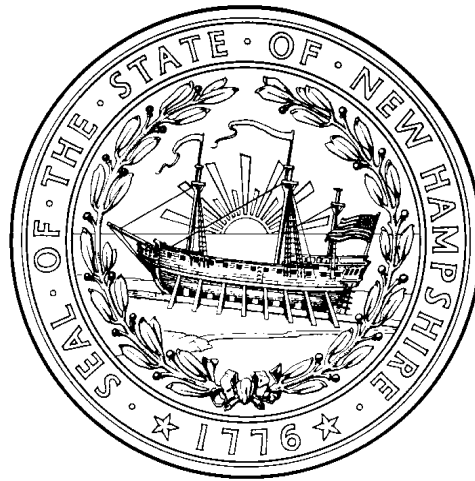

## LEGISLATIVE ETHICS COMMITTEE

The Legislative Ethics Committee has voted to issue the following advisory opinion, which is printed below in its entirety.

**Advisory Opinion 2013-3**  
**Response to a Request for an Advisory Opinion**  
**from Representative Susan W. Almy**  
**(October 2, 2013)**

Pursuant to RSA 14-B:3, I (c), Representative Susan Almy has requested an Advisory Opinion whether, consistent with applicable statutes and the Ethics Guidelines, she may accept a complimentary invitation from the Business and Industry Association of New Hampshire (BIA) to attend its Annual Dinner.

### Facts

According to information provided to the Committee by Rep. Almy, she and certain other members of the General Court have received such invitations to the Dinner, to be held October 23, 2013. Her Request states that “such invitations have been extended to chairs, vice chairs and senior minority members of key committees related to the BIA’s work.” Her Request further states that the “Commerce and Ways & Means committees in both houses regularly deal with [BIA], that it holds an annual meeting with considerable networking and with what I would consider celebratory goals in that it honors key people, business and other, around the state, this year being the NH Charitable Foundation, Donna Sytek, and a rural industry in my county.”

Further information about the event has been furnished on BIA’s behalf, in response to the Committee’s request. BIA’s response states that tickets to the event are regularly priced at \$125.00. BIA describes itself as classified under the federal Internal Revenue Code as a 501(c) (6) organization. BIA also states that it

“routinely invites all members of the New Hampshire Senate to the annual dinner, in their official capacities and regardless of party or position on issues. It also invites the chairs of various House committees and leadership, regardless of party or position on issues, in their official capacities. Due to the size of the dinner location, and the size of the New Hampshire House of Representatives, it is impossible to invite the entire House membership.”

BIA further states that the Dinner

“has evolved from one that mixed business with pleasure, to a celebration of business accomplishments in New Hampshire, especially recognizing a business leader each year with the BIA’s Lifetime Achievement Award,”

that the Dinner has also recognized distinguished members of the bar, governmental, community, and not-for-profit leaders, and that the New Hampshire Advantage Award is presented annually at the Dinner, “recognizing organizations that have added to the strength of New Hampshire.”

### Relevant Provisions of Applicable Law:

RSA 15-B:3, RSA 15-B:2, V(a), and (b) (9) and (10) (see text attached).

### Analysis

Under RSA 15-B:3, “Gifts” to legislators are generally prohibited, unless specifically exempted by law. Transfers by third persons to legislators of non-monetary items of value are prohibited, unless the item is worth less than \$25.00, or otherwise qualifies for a specific statutory exemption from the definition of “gift.” Since BIA has confirmed that the value of Annual Dinner tickets is \$125.00, the question becomes whether its complimentary invitations somehow qualify for a specific exemption.

BIA claims that its complimentary invitations to the Dinner should qualify for the following specific exemptions:

(1) RSA 15-B:2,V(b)(10)(A), meals associated with attendance at ceremonial or celebratory event, public, open to any member of the public purchasing a ticket ticket, and if by invitation, planned to have an attendance of more than 50 people;

(2) RSA 15-B:2,V(b)(10)(B), meals associated with attendance by legislators invited in their official capacities, as representatives of the state or legislative bodies;

(3) RSA 15-B:2,V(b)(9), free admission to a qualifying “ceremonial event.”

However, on the facts presented, the statutory requirements for exemptions (2) and (3) are not met.

RSA 15-B:2,V(b)(10)(B) specifies that legislative invitees be “attending in an official capacity, **representing the state and/or the senate [or] house....**” (emphasis added). In the context of direct invitations to the BIA Annual Dinner, we have presumed that the Senate President is representing the Senate when attending the event in an official capacity. (AO 2011-3). The same presumption would apply to the Speaker of the House. However, merely because other legislators might be invited to attend in their official capacity does not satisfy the additional requirement that in attending, they be “representing” the body they belong to, unless they have been granted specific authority to do so.

As to RSA 15-B:2,V(b)(9), while the exemption applies to a “ceremonial” event, there are additional requirements:

(A) The proceeds of the event are subject to the political contributions and expenditure reporting law, RSA 664; or

(B) The event is sponsored by a charitable organization that is registered with the division of charitable trusts, department of justice, or which is a charitable organization pursuant to section 501(c)(3) of the federal tax code; or

(C) The event is published as an event open for attendance by any member of the general court in the calendar of the senate or the house.

None of these additional requirements appear to be satisfied. In particular, the proceeds of the Dinner are not subject to RSA 664, BIA is not a charitable organization that is registered with the division of charitable trusts, nor a 501(c)(3) organization; nor is the Dinner published as an event open for attendance by any member of the general court in the calendar of the Senate or the House.

The remaining question is whether the invitation would qualify for exemption under RSA 15-B:2, V(b)(10)(A). The issue here is whether the “primary significance” of the BIA Annual Dinner is “ceremonial or celebratory.” These terms are not defined in the statute, and we have not previously interpreted or applied them in specific situations.

“*Ceremonial*” In common usage, the adjective “ceremonial” has been defined as “relating to or used for formal events of a religious or public nature.” (See *Oxford Dictionary of American English*, On-line Edition). Since the BIA dinner is not a religious event, is sponsored by a private organization, and is open only to ticket purchasers and special invitees, we conclude that it is not a “ceremonial” event within the meaning of the statute.

“*Celebratory*” In common usage, among other definitions, the adjective “celebratory” relates to an event which “honors or praises publicly.” (See definition of “celebrate” in *Oxford Dictionary of American English*, On-line Edition). This is a very broad definition which should be interpreted in light of the purpose of RSA 15-B, as stated in RSA 15-B:1: “to ensure that the performance of official duties does not give rise to a conflict of interest, by prohibiting certain gifts....” To apply the term “celebratory” to any event which “honors or praises publicly,” so long as it is open to the public or more than 50 invitees, would not serve that purpose, but would permit any sponsoring person or organization to claim the exemption, regardless of who is being honored or praised, or how closely the event relates to influencing the performance of legislative duties in the sponsor’s favor.

BIA makes no secret that it is a preeminent lobbying organization. It employs full time personnel whose task is to monitor and influence legislation of interest to the organization and its members. It provides weekly status reports to its members about such legislation. Any effective lobbying effort includes cultivating cordial relationships with legislators. There is little doubt that its Annual Dinner invitations to legislators are part of that effort. If BIA had no interest in legislation, there would be no point in offering free admission to legislators. Clearly, one of the purposes of the Dinner and the free invitations is to advance BIA’s legislative agenda.

But the “celebratory” exception does not necessarily exclude such events. It merely requires that the “primary significance” of such events be “celebratory.” To give that provision proper effect requires that the event primarily celebrate someone or something other than the organization itself, or its members, or its own accomplishments, or sitting legislators, legislative officers or legislative staff.

On the facts presented in Rep. Almy’s request and BIA’s response, this criterion appears to be met. No BIA business is conducted at the dinner. The program appears to include no discussion of BIA’s own legislative positions or accomplishments, but more generally seeks to be “a celebration of business accomplishments in New Hampshire,” publicly honoring not only leaders of business, but other community leaders and organizations as well.

Accordingly, as long as this remains the primary focus of BIA’s Annual Dinner, we advise that the event can reasonably be characterized as “primarily celebratory,” that as such, complimentary invitations to the event extended directly by BIA to legislators qualify for the exemption in RSA 15-B:2, V(b)(10)(A), and that therefore, such invitations are not gifts prohibited by RSA 15-B: 3.

## AO 2013-3—Applicable Law

**15-B:1 Purpose.** – The purpose of this chapter is to ensure that the performance of official duties does not give rise to a conflict of interest, by prohibiting certain gifts and by requiring certain persons to file with the secretary of state a report of any honorariums or expense reimbursements received. This chapter shall be liberally construed to effect this purpose

**15-B:2 Definitions.** – For the purposes of this chapter: \*\*\*

V. (a) “Gift” means: \*\*\*

(2) Any other tangible thing, intangible thing, service, or the use thereof having more than insignificant economic value. Any such item with a value of less than \$25 is presumed to be of insignificant economic value.

(b) Notwithstanding subparagraph (a), “gift” shall not include: \*\*\*

(9) Tickets or free admission to a charitable, ceremonial, or political event provided that:

(A) The proceeds of the event are subject to the political contributions and expenditure reporting law, RSA 664; or

(B) The event is sponsored by a charitable organization that is registered with the division of charitable trusts, department of justice, or which is a charitable organization pursuant to section 501(c)(3) of the federal tax code; or

(C) The event is published as an event open for attendance by any member of the general court in the calendar of the senate or the house.

(10) Meals, beverages, lodging, or transportation associated with attendance at:

(A) Any event for which the primary significance is ceremonial or celebratory, provided the event is public or, if by invitation only, is planned to have an attendance greater than 50 people; or

(B) Any event where the person is attending in an official capacity representing the state and/or the senate, house, or the agency of which the person is a member.

**15-B:3 Prohibition on Gifts.** –

I. It shall be unlawful to knowingly give any gift as defined in this chapter, directly or indirectly, to any elected official, public official, public employee, constitutional official, or legislative employee.

II. It shall be unlawful to knowingly give any gift as defined in this chapter, directly or indirectly, to any family member, as defined in this chapter, of any elected official, public official, public employee, constitutional official, or legislative employee, with a purpose of influencing or affecting the official conduct of such official or employee.

III. No elected official, public official, public employee, constitutional official, or legislative employee shall knowingly accept, directly or indirectly, any gift, as defined in this chapter.
