LEGISLATIVE ETHICS COMMITTEE

The Legislative Ethics Committee has voted to issue the following advisory opinion, which is printed below in its entirety.

Advisory Opinion 2016-3
Response to a Request for an Advisory Opinion
from Senate Legal Counsel Richard J. Lehmann
on Behalf of Senator Chuck W. Morse
(August 22, 2016)

Senate Legal Counsel Richard J. Lehmann has submitted a request for an Advisory Opinion on behalf of Senate President Chuck W. Morse about whether, consistent with applicable statutes and the Ethics Guidelines, the Senator may accept payment for the costs of travel, lodging, and meals related to attendance at the national meeting of the Republican Legislative Campaign Committee ("RLCC"), held in Pinehurst Resort, NC.

Relevant Provisions of Law

RSA 15-B:2, V(a)(2)

V. (a)"Gift" means: ***

(2) Any ... tangible thing, intangible thing, service, or the use thereof having more than insignificant economic value. Any such item with a value of less than \$25 is presumed to be of insignificant economic value.

RSA 15-B:2, V(b)(10)(B) and (11)

(b) Notwithstanding subparagraph (a), "gift" shall not include:***

10) Meals, beverages, lodging, or transportation associated with attendance at: ***

(B) Any event where the person is attending in an official capacity representing the state and/or the senate, house, or the agency of which the person is a member.

(11) Expense reimbursement or an honorarium.

RSA 15-B:2, IV

IV. "Expense reimbursement" shall mean any price, charge, fee, expense, or other cost which is waived, forgiven, reduced, prepaid, or reimbursed in any form for the reasonable expenses of attendance, registration, travel, meals, or lodging related to a bona fide conference, meeting, seminar or educational or informational program, when the source of such reimbursement is other than the state, a county, or the United States of America.

RSA 15-B:2, VI

VI. "Honorarium" means a payment in any form to an elected official, public official, public employee, constitutional official, or legislative employee for an appearance, speech, written article or other document, service as a consultant or advisor, or participation in a discussion group or similar activities. Honorarium does not include a payment for such activities for which the person is being compensated by the state, a county, the United States of America, or by any other employer or client, where the activity giving rise to the honorarium is not related to or associated with any public office or government employment.

Committee Analysis

The national meeting of the Republican Legislative Campaign Committee is hosted annually by the Republican State Leadership Committee for Republican Speakers, Presidents, and Leaders of the state legislatures. The agenda includes social functions, political updates, policy panels, and meetings with legislative leaders and donors to the host committee.

The Ethics Committee staff requested information about the topics to be discussed at the conference since they were not described in the brochure provided. Attorney Lehmann replied that Senator Morse would not be attending the policy panels, but would use the meeting to network with other legislative leaders. Based on this information the Committee concluded that his attendance would not meet the definition of a "bona fide conference... related to the (legislator's) office" under RSA 15-B:5. See Interpretive Ruling 2013-1.

Next the Committee considered whether the Senate President might attend this meeting under the exception in RSA 15-B:2, V(b)(10)(B) that permits acceptance of travel expenses for attendance at "any event where the person is attending in an official capacity *representing the state and/or the senate...*" (emphasis added). From the list of attendees provided to the Committee, it was clear that this was a meeting for Republican leaders invited by virtue of their office. Members were divided on whether the Senate President represented the entire Senate or only the Republican caucus at this clearly partisan event. Even after considerable discussion, the members could not reach consensus because of the lack of clarity of the language of the statute. It was suggested that remedial legislation should be filed to provide guidance in the future.

There was agreement, however, that payment of travel expenses, meals, and lodging could be considered an honorarium, “a payment in any form to an elected official... for an appearance” under RSA 15-B:2, VI.

Conclusion

Based on the information provided by Attorney Lehmann about Senator Morse’s activities at the event, the Committee advises that his acceptance of the costs of travel, lodging, and meals as payment for his appearance would fall within the exemption established for “honorarium” set forth in RSA 15-B:2, VI.

Senator Morse must report his acceptance of the complimentary travel, lodging, and meals as an honorarium in accordance with RSA 15-B:6.
