ANALYSIS

This bill:

I. Authorizes the department of education to adopt rules relative to federal funding available to schools under New Hampshire's Medicaid program.

II. Permits professionals certified by the department of education who are providing medical services in public schools to be licensed by medical and health care boards.

AN ACT relative to Medicaid to schools.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 6:1 Statement of Purpose and Intent. The general court acknowledges the critical importance of
2 ensuring the quality, accessibility, and sustainability of Medicaid services provided in the school
3 setting, as well as ensuring that billing under the program meets all state and federal requirements.
4 The purpose of this act is to strengthen the state's Medicaid to schools and Medicaid to schools for
5 Medical services programs consistent with the Social Security Act. Accordingly, this act shall
6 provide the department of health and human services with the additional authority to adopt
7 administrative rules that maximize the availability of federal financial aid to schools under New
8 Hampshire's Medicaid program. This act also provides a more efficient pathway to allow qualified
9 professionals certified and credentialed by the department of education who are currently providing
10 medical services in public schools to be licensed by medical and health care boards. Finally, this act
11 further facilitates the provision of medical services in the school setting to students who are enrolled
12 in participating public schools and Medicaid, thereby furthering the education and health of New
13 Hampshire's students.

14 6:2 Medicaid to Schools Program. RSA 186-C:25, I-III are repealed and reenacted to read as
15 follows:

16 I. The department of health and human services Medicaid reimbursement program shall be
17 known as the "Medicaid to schools" program, providing medical assistance for covered services
18 furnished to children with disabilities who are enrolled in Medicaid. The purpose of the program is
19 to seek any and all Medicaid reimbursement for medical and health-related services provided by
20 local school districts and school administrative units to children with disabilities which are
21 reimbursable under federal law but which were previously fully funded by such districts or
22 administrative units. The program shall be voluntary and is designed to assist children with
23 disabilities by maintaining them in their own homes and communities. The program shall be
24 administered in the same, or similar, manner as the Medicaid to schools for medical services
25 program established in RSA 167:3-k. This subdivision is intended to provide Medicaid funding for
26 services which, in the absence of such funding, nevertheless qualify as special education or related
27 services under this chapter. It is not the intention of this subdivision to increase school district
28 responsibility or liability beyond what is required by other sections of this chapter.

16 (b) Be in addition to any special education program as defined in the New Hampshire
17 rules for the education of children with disabilities.

18 III-a. Any provider who orders, refers, prescribes, renders, or provides services under this
19 section shall do so in accordance with the relevant health professional practice act and regulations
20 including, but not limited to, RSA 137-F, RSA 317-A, RSA 326-B, RSA 326-C, RSA 326-E, RSA 326-
21 F, RSA 326-H, RSA 327, RSA 328-A, RSA 328-D, RSA 328-F, RSA 329, RSA 329-B, RSA 330-A, and
22 RSA 330-C.

23 6:6:3 Medicaid to Schools for Medical Services Program. RSA 167:3-k is repealed and reenacted
24 to read as follows:

25 167:3-k Medicaid to Schools For Medical Services Program.

26 I. The department of health and human services Medicaid reimbursement program shall be
27 known as the "Medicaid to schools for medical services" program, providing medical assistance for
28 covered services furnished to children in public schools who are enrolled in Medicaid. The purpose of
29 the program is to seek any and all Medicaid reimbursement for medical or health-related services
30 provided by local school districts and school administrative units to children which are reimbursable
31 under federal law. General fund dollars allocated to the department of health and human services
32 shall not be used for matching the federal financial participation for Medicaid reimbursement. All
33 matching dollars for Medicaid to schools medical services shall come from the local school districts or
34 school administrative units. The program shall be voluntary and administered by the department in
35 the same, or similar, manner as the Medicaid to schools program established in RSA 186-C:25. This
36 section shall not be construed to increase school district responsibility or liability beyond what is
37 required by other state or federal law.

19 with the commissioner of the department of education, shall adopt rules, pursuant to RSA 541-A,
20 relative to:

21 (a) Further defining services eligible for Medicaid reimbursement under this section. In
22 defining such services, the commissioner shall, to the extent practicable, seek to maximize the
23 availability of federal financial assistance to local school districts and school administrative units.

24 (b) State plans and reimbursement procedures necessary for local school districts or
25 school administrative units to receive appropriate Medicaid reimbursement for eligible services
26 under paragraph II that are provided or paid for by school districts or school administrative units.

27 (c) Monitoring mechanisms to ensure that services provided under this section meet the
28 requirements of paragraph II. Monitoring responsibilities shall be consistent with the jurisdiction of
29 the different departments.

30 (d) A financial mechanism by which the federal mandatory matching requirement is met
31 through collection, or other means, of 50 percent of the cost of allowable services from local school
32 districts and/or school administrative units.

33 V. New Hampshire local school districts or school administrative units shall be the enrolled
34 Medicaid providers for the purpose of administration and billing.

35 6:4 Nurse Practice Act; Scope of Practice; Licensed Nursing Assistant. Amend RSA 326-B:14, II-
36 a(b) to read as follows:

1 (b) A licensed nurse delegates the task of medication administration to the LNA who is
2 employed in the home care, hospice, residential care, *public school*, or adult day care setting. The
3 board, in consultation with the commissioner of health and human services or a designee, shall
4 adopt rules under RSA 541-A establishing standards for such delegation of medication
5 administration which include, but are not limited to, limitations on the number of delegations per
6 assistive personnel, training and competency requirements, documentation requirements, and
7 medication administration error reporting requirements.

8 6:5 New Section; Licensed School Psychologist-Doctoral and Licensed School Psychologist-
9 Specialist. Amend RSA 329-B by inserting after section 15 the following new section:

10 329-B:15-a Licensed School Psychologist-Doctoral and Licensed School Psychologist-Specialist.

11 I. The board shall issue a license for the title of licensed school psychologist-doctoral to any
12 person who has a doctoral degree in psychology and:

13 (a) Is certified as a school psychologist by the New Hampshire department of education,
14 bureau of credentialing; and

15 (b) Has completed all of the following requirements:

16 (1) Has passed a satisfactory examination in psychology as determined by the board
17 including a national school psychologists' examination.

18 (2) Has met education and other requirements determined by the board.

19 (3) Is of good professional character.

20 (4) Has submitted a complete set of fingerprints and a criminal history records
21 release form in accordance with RSA 329-B:14-a.

22 (5) Has paid all fees established by the office of professional licensure and
23 certification established under RSA 310-A:1-a and collected by the board.

24 II. The board shall issue a license for the title of licensed school psychologist-specialist to
25 any person who does not have a doctoral degree and:

1 III. The following shall apply to those school psychologists who are certified by the
2 department of education on the effective date of this section:

3 (a) Each certified school psychologist in good standing who holds a doctoral degree in
4 psychology shall be licensed as licensed school psychologist-doctoral.

5 (b) Each certified school psychologist in good standing who does not hold a doctoral
6 degree in psychology shall be licensed as licensed school psychologist-specialist.

7 (c) Those certified school psychologists who are subject to discipline or are under review,
8 or who are under investigation shall be reviewed by the board which shall grant, deny, or issue a
9 license with conditions as determined by the board.

10 (d) Those school psychologists granted licenses under this paragraph shall be exempt
11 from fees for the initial license period which shall extend beyond that individual's certification in
12 school psychology by 3 months and shall include an additional year for those whose certifications
13 from the department of education would expire in June of 2020. Following that time, such
14 individual shall be eligible for renewal under the rules established by the board and upon payment
15 of the applicable fee.

16 IV. Examinations for applicants under this section shall be held by the board at least once
17 each year. The board shall determine the subject and scope of the examination, which may be
18 written, oral, or both. If an applicant fails the examination, the board shall deny the license or
19 specify conditions under which the applicant may be admitted to a future examination according to
20 board rules.

21 V. Unless otherwise licensed under another provision, a licensed school psychologist-doctoral
22 or licensed school psychologist-specialist licensure is for services provided in those settings that are
23 provided in an educational institution. No persons licensed under this section may provide services
24 outside such settings if the services are directly related to the client's improvement of school
25 functioning including but not limited to learning, development, social and emotional functioning, and
26 behavior, but any services provided outside of the school shall relate to such person's students and
27 his or her employment in a school. No persons licensed under this section shall hold themselves out
28 as psychologists, psychological examiners, or by any business name incorporating variations of those
29 titles other than school psychologists or nationally certified school psychologists unless they are
30 otherwise licensed under another provision.

31 VI. The board shall provide materials and information concerning licensed school
32 psychologists-doctoral and licensed school psychologists-specialist to the department of education
33 bureau of credentialing that will further the proper administration of the credentials of each
34 department.

35 6:6 New Paragraphs; Psychologists; Definitions; Licensed School Psychologist-Doctoral and
36 Licensed School Psychologist-Specialist. Amend RSA 329-B:2 by inserting after paragraph IV the
37 following new paragraphs:

7 ***psychologist-doctoral, or licensed school psychologist-specialist*** licensed by the board who
8 acts as the agent of the board under the guidance of the board investigator and is authorized to
9 discover facts and make reports to the board.

10 VII. "Psychology practice ***by a licensed psychologist***" means:

11 (a) The observation, description, evaluation, interpretation, prediction, and modification
12 of human behavior by the application of psychological principles, methods, and procedures, for the
13 purposes of:

14 (1) Preventing, eliminating, evaluating, assessing, or predicting symptomatic,
15 maladaptive, or undesired behavior;

16 (2) Evaluating, assessing, or facilitating the enhancement of individual, group, or
17 organizational effectiveness, including personal effectiveness, adaptive behavior, interpersonal
18 relationships, work and life adjustment, health, and individual, group, or organizational
19 performance; or

20 (3) Assisting in legal decision-making.

21 (b) Psychological testing and the evaluation or assessment of personal characteristics,
22 such as intelligence; personality; cognitive, physical, and emotional abilities; skills; interests;
23 aptitudes; and neuropsychological functioning;

24 (c) Counseling, consultation, psychoanalysis, psychotherapy, hypnosis, biofeedback, and
25 behavior analysis and therapy;

26 (d) Diagnosis, treatment, and management of mental and emotional disorder or
27 disability, alcoholism and substance abuse, disorders of habit or conduct, and the psychological and
28 behavioral aspects of medical/physical illness, accident, injury, or disability;

29 (e) Psycho-educational evaluation, therapy, and remediation;

30 (f) Consultation ***and coordination*** with other psychologists, physicians, other health
31 care professionals, and patients regarding all available treatment options, including medication,
32 with respect to provision of care for a specific client or patient or group;

33 (g) Provision of direct services to individuals or groups for the purpose of enhancing
34 individual and organizational effectiveness, or using psychological principles, methods, or procedures
35 to assess and evaluate individuals on personal characteristics for individual development or behavior
36 change, or for making decisions about the individual, such as selection;

1 (h) Provision of any of these services or activities by any means, including electronic or
2 telephonic; and

3 (i) The supervision, **ordering, referring, and prescribing** of any of these services or

5 The practice of psychology shall be construed within the meaning of this definition without regard to
6 whether payment is received for services rendered.

7 VIII. "Psychology services **by a licensed psychologist**" means the observation, description,
8 evaluation, interpretation, diagnosis, and modification of human behavior by the application of
9 psychological and systems principles, methods, and procedures for the purpose of preventing or
10 eliminating symptomatic, maladapted, or undesirable behavior and of enhancing interpersonal
11 relationships, work and life adjustments, personal effectiveness, behavioral health, and mental
12 health, as well as the diagnosis and treatment of the psychological and social aspects of physical
13 illness, accident, injury, or disability. Psychology services may include, but shall not be limited to,
14 those services based on diagnosis and treatment of mental and emotional disorders and psycho-
15 educational or consultative techniques integral to the treatment of such disorders when diagnosis is
16 specified in the most current edition of the Diagnostic and Statistical Manual of Mental Disorders,
17 published by the American Psychiatric Association, The International Classification of Disease
18 Manual (ICD), or an equivalent of such manual as determined by the board. Psychological services
19 may be rendered to individuals, families, groups, systems, or organizations.

20 IX. "Psychologist" means any person licensed as a psychologist under **RSA 329-B:15**.

21 X. "Psychology intern, resident, or fellow" means a person in training as a psychologist,
22 subject to the provisions of this chapter and regulation by the board.

23 XI. "Psychotherapist" means a psychologist, **licensed school psychologist-doctoral, or**
24 **licensed school psychologist-specialist** licensed under this chapter who performs or purports to
25 perform psychotherapy.

5 transition to post-secondary goals, including: the observation, description, evaluation, interpretation,
6 diagnosis, and modification of human behavior by the application of psychological and systems
7 principles, methods, and procedures for the purpose of preventing or eliminating symptomatic,
8 maladapted, or undesirable behavior and of enhancing interpersonal relationships, school and life
9 adjustments, personal effectiveness, behavioral health, and mental health, as well as the diagnosis
10 and treatment of the psychological and social aspects of physical illness, accident, injury, or
11 disability. School psychology services may include, but shall not be limited to, those services based
12 on diagnosis and treatment of mental and emotional disorders and psycho-educational or
13 consultative techniques integral to the treatment of such disorders when diagnosis is specified in the
14 most current edition of the Diagnostic and Statistical Manual of Mental Disorders, published by the
15 American Psychiatric Association, The International Classification of Disease Manual (ICD), or an
16 equivalent of such manual as determined by the board. School psychological services may be
17 rendered to individuals, families, groups, systems, or organizations within school settings and other
18 locations as provided in RSA 329-B:15-a, V.

19 6:9 Board of Psychologists. Amend RSA 329-B:3, I to read as follows:

20 I. There shall be a board of psychologists composed of 5 licensed psychologists, **one licensed**
21 **school psychologist-doctoral or licensed school psychologist-specialist**, and 3 public members.
22 The members shall be appointed to a term of 3 years by the governor with the approval of the
23 council. The members of the board shall elect a chairperson on an annual basis. Chairperson terms
24 shall alternate between [psychologist] **licensees** and public members.

25 6:10 New Paragraph; Board of Psychologists. Amend RSA 329-B:3 by inserting after paragraph
26 III the following new paragraph:

27 IV. On occasions when the licensed school psychologist board member is recused on a
28 matter, inquiry, or case concerning a licensed school psychologist-doctoral, licensed school
29 psychologist-specialist, or application for such before the board, then a licensed school psychologist-
30 doctoral or licensed school psychologist-specialist from the school psychologist advisory committee
31 shall be allowed to stand in to address the board business for the licensed school psychologist-
32 doctoral or licensed school psychologist-specialist board member for that matter only.

33 6:11 Psychologists; Board; Committees Established; Duties. RSA 329-B:4, I-III are repealed and
34 reenacted to read as follows:

35 I. The board shall create 2 advisory committees for the purpose of assisting the board in its
36 responsibilities under this chapter, including rulemaking under RSA 329-B:10.

1 (a) The psychologists advisory committee shall be chaired by a psychologist board
2 member appointed by the board which shall have a maximum of 12 members, including up to 9

5 the board and shall include: A licensed school psychologist-doctoral board member who shall be the
6 chairperson of the committee, up to 9 licensed school psychologist-doctoral or licensed school
7 psychologist-specialist members, and up to 3 consumer members who shall be school administrative
8 personnel and/or parents of students, and one representative from the department of education
9 bureau of credentialing. There shall be a maximum of 13 members.

10 II. The board shall create 2 committees for professional conduct investigations, one for
11 licensed psychologists, and one for licensed school psychologist-doctoral and licensed school
12 psychologist-specialists, for the purpose of assisting the board in its responsibilities under RSA 329-
13 B:22 and RSA 329-B:23. A board investigator, appointed by the chairperson of the board with the
14 advice and consent of the board, shall chair the professional conduct investigation committees. The
15 balance of the membership of the professional conduct investigation committees shall be composed of
16 persons licensed by the board for the committee's respective profession to a maximum of 12
17 members.

18 III. The board shall create a professional's health committee to administer the professional's
19 health program which shall address issues that may impinge on a practitioner's ability to practice.
20 A board member, appointed by the chairperson of the board with the advice and consent of the
21 board, shall chair the professional's health committee. The balance of the membership of the
22 professional's health committee shall be composed of persons licensed by the board to a maximum of
23 12 members.
