

Amendment to SB 3

1 Amend the bill by replacing all after the enacting clause with the following:

3 1 Voters; Temporary Absence or Presence. Amend RSA 654:2 to read as follows:

4 654:2 Temporary Absence **or Presence**.

5 **I.** A domicile for voting purposes acquired by any person in any town shall not be
6 interrupted or lost by a temporary absence therefrom with the intention of returning thereto as his
7 or her domicile. Domicile for the purpose of voting as defined in RSA 654:1, once existing, continues
8 to exist until another such domicile is gained. Domicile for purposes of voting is a question of fact
9 and intention ***coupled with a verifiable act or acts carrying out that intent***. A voter can have
10 only one domicile for ~~[these]~~ **voting** purposes. No person shall be deemed to have lost a domicile by
11 reason of his or her presence or absence while the voter or his or her spouse is employed in the
12 service of the United States; nor while engaged in the navigation of the waters of the United States
13 or of the high seas; nor while a teacher in or student of any seminary of learning; nor while confined
14 in any public prison or other penal institution; nor while a patient or confined for any reason in any
15 nursing, convalescent home or hospital, old folks or old age home, or like institution or private
16 facility.

17 **II.(a)** *A person present in New Hampshire for temporary purposes shall not gain a*
18 *domicile for voting purposes. A person who maintains a voting domicile where he or she*
19 *came from, to which he or she intends to return to as his or her voting domicile after a*
20 *temporary presence in New Hampshire, does not gain a domicile in New Hampshire*
21 *regardless of the duration of his or her presence in New Hampshire.*

22 **(b)** *A person who has been present and residing at one place in one town or*
23 *ward in New Hampshire for 30 or fewer days is deemed to be present for temporary*
24 *purposes unless that person has the intention of making the place in which the person*
25 *residing his or her one place, more than any other, from which he or she engages in the*
26 *domestic, social, and civil activities of participating in democratic self-government*
27 *including voting, has acted to carry out that intent, and can during the voter registration*
28 *process report and provide evidence a verifiable action has been taken.*

29 **(c)** *For the purposes of this chapter, temporary purposes shall include, but are*
30 *not limited to, being present in New Hampshire for 30 or fewer days for the purposes of*
31 *tourism, visiting family or friends, performing short-term work, or volunteering or*
32 *working to influence voters in an upcoming election.*

33 **(d)** *For the purposes of voter registration, acts demonstrating an intent to make*

1 *a place an individual's domicile for purposes of participating in self-government as a*
2 *voter shall include, but are not limited to:*

3 *(1) Verification of residency at an institution of higher learning;*

4 *(2) Renting or leasing an abode at that place for a period of more than 30*
5 *days;*

6 *(3) Purchasing an abode at that place;*

7 *(4) Obtaining a New Hampshire resident motor vehicle registration,*
8 *driver's license, or official nondriver's picture identification card listing that place as his*
9 *or her residence;*

10 *(5) Enrolling the person's dependent minor child in a publicly funded*
11 *elementary or secondary school which serves the town or ward of that place;*

12 *(6) Listing that place as the person's physical residence address on state or*
13 *federal tax forms, a United States passport, other government identification, or other*
14 *government forms;*

15 *(7) Providing the address of that place to the United States Post Office as*
16 *the person's permanent address, provided it is not a postal service or commercial post*
17 *office box;*

18 *(8) Obtaining a New Hampshire resident hunting or fishing license, listing*
19 *that place as his or her residence;*

20 *(9) Obtaining utility services for an indefinite period at that place; or*

21 *(10) Arranging for a homeless shelter or similar service provider located in*
22 *the town or ward to receive United States mail on behalf of the individual using that*
23 *facility's address as the individual's domicile address for voting purposes.*

24 *(e) An applicant whose domicile is at an abode rented, leased, or owned by*
25 *another and whose name is not listed on the rental agreement, lease, or deed may provide*
26 *a written statement from a person who is listed on the rental agreement, lease, or deed, or*
27 *other reasonable proof of ownership or control of the property or his or her agent who*
28 *manages the property that the applicant resides at that address, signed by the owner or*
29 *manager of the property under penalty of voting fraud if false information is provided.*
30 *The statement shall be on the form prescribed by the secretary of state for that purpose or*
31 *contain all the information set forth on that official form.*

32 *III. An individual applying for registration as a voter 30 or fewer days before an*
33 *election shall use the election day registration form required by RSA 654:7, which shall*
34 *require the applicant to provide the date he or she established his or her voting domicile*
35 *in New Hampshire, and identify and provide evidence of a verifiable action he or she has*
36 *taken carrying out his or her intent to make the place claimed as domicile the one place,*
37 *more than any other, where he or she will participate in democratic self-government.*

1 *IV. A person may register on election day through use of a domicile affidavit and*
2 *vote if he or she does not have any document in his or her possession at the polls providing*
3 *evidence of and reporting an action carrying out his or her intent to make the address*
4 *claimed as his or her voting domicile. A person relying on an affidavit to register must*
5 *mail or present evidence of an action taken before registering to vote to carry out his or*
6 *her intent to make the address claimed his or her domicile to the town or city clerk within*
7 *10 days following the election, or within 30 days in towns where the clerk's office is open*
8 *fewer than 20 hours weekly.*

9 *V. The supervisors of the checklist shall as soon as practical following the first*
10 *election at which a person relies solely on a domicile affidavit to register and vote, and*
11 *fails to mail or present evidence of having taken some action to carry out his or her intent*
12 *to establish domicile at the address listed on his or her voter registration application to*
13 *the clerk by the deadline, verify that the person was domiciled at the address claimed on*
14 *election day by:*

15 *(a) Requesting local law enforcement during their routine patrols to visit the*
16 *address and verify that the individual was domiciled there on election day;*

17 *(b) Requesting the secretary of state to send a letter of domicile verification,*
18 *which the secretary of state shall send in the same manner as provided in RSA 654:12, V(b)*
19 *and RSA 659:13, IV (a); or*

20 *(c) Requesting 2 or more supervisors or other municipal officials to visit the*
21 *address and verify that the individual was domiciled there on election day.*

22 *VI. If an applicant fails to mail or present evidence to the clerk by the deadline*
23 *and the supervisors are unable to verify the applicant's domicile or where evidence exists*
24 *of voting fraud, the supervisors shall promptly report this to the secretary of state and to*
25 *the attorney general, who shall cause such further investigation as is warranted. The*
26 *supervisors shall also initiate removing the person from the checklist by sending the*
27 *person the notice required by RSA 654:44.*

28 2 Voter Registration Form; Day of General Election. Amend RSA 654:7, IV(c) to read as
29 follows:

30 (c) The secretary of state shall prescribe the form of the voter registration form to be
31 used only for voter registrations, transfers, or updates ***starting 30 days before each election and***
32 ***at the polling place on the date of a state general election, which shall be in substantially the***

6 supervisor of the checklist is available to address my questions or concerns.

7 *I understand that to make the address I have entered above my domicile for voting I*
8 *must have an intent to make this the one place from which I participate in democratic*
9 *self-government and must have acted to carry out that intent. While a person need not*
10 *have taken any particular verifiable action listed below to register to vote, you must report*
11 *and provide evidence of an action if you have taken one. Failing to report and provide*
12 *evidence of a verifiable action will prompt a visit by government officials or official mail*

14 *address. I understand I must present evidence of my actions carrying out my intent to be*

Notary Public/Justice of the Peace/Official Authorized by RSA 659:30

In accordance with RSA 659:34, the penalty for knowingly or purposefully providing false information when registering to vote or voting is a class A misdemeanor with a maximum sentence of imprisonment not to exceed one year and a fine not to exceed \$2,000. Fraudulently registering to vote or voting is subject to a civil penalty not to exceed \$5,000. ***In accordance with RSA 659:34-a voting in more than one state in the same election is a class B felony with a maximum sentence of imprisonment not to exceed 7 years and a fine not to exceed \$4,000.***

3 Determining Qualifications of Applicant; Domicile. Amend RSA 654:12, I(c) to read as follows:

(c) DOMICILE.

(1) Registering in advance of an election.

(A) A person who possesses one of the following qualified documents listing the applicant's name and the address claimed as domicile must present that document when applying for registration prior to election day: (i) New Hampshire driver's license or nondriver's picture identification card (ii) New Hampshire resident vehicle registration; (iii) armed services identification, or other photo identification issued by the United States government, (iv) government issued check, benefit statement, or tax document. A person who possess such a document, but failed to bring it with the person when seeking to register to vote shall be required to return when he or she can present one of these documents or to bring the document and register on election day.

(B) A person who attests under penalty of voter fraud that he or she does not possess any of the qualified documents listed in subparagraph (A) may present any reasonable documentation [which indicates] of having established a physical presence at the place claimed as domicile, having an intent to make that place his or her domicile, and having taken a verifiable act to carry out that intent. The documentation must establish that it is more likely than not that the applicant has a domicile and intends to maintain [a] that domicile, as defined in this chapter, at least until election day in the town[-city,] or ward in which he or she desires to vote[-or-]. Reasonable documentation includes, but is not limited to evidence of:

(i) Residency at an institution of higher learning;

(ii) Renting or leasing an abode at that place for a period of more than 30 days;

(iii) Evidence of purchasing an abode at that place;

(iv) Enrolling the applicant's dependent minor child in a publicly funded elementary or secondary school which serves the town or ward of that place;

(v) Listing that place as the person's physical residence address on state or federal tax forms, a United States passport, other government identification, or

2 *(vi) Providing the address of that place to the United States Post*
3 *Office as the person's permanent address, provided it is not a postal service or commercial*
4 *post office box;*

5 *(vii) Obtaining a New Hampshire resident hunting or fishing license*
6 *listing that place as residence;*

7 *(viii) Obtaining utility services for an indefinite period at that place;*
8 *or*

9 *(ix) Arranging for a homeless shelter or similar service provider*
10 *located in the town or ward to receive United States mail on behalf of the individual.*

11 *An applicant whose domicile is at an abode of another and whose name is not listed on the*
12 *document offered as proof of domicile may provide a written statement from a person who*
13 *is listed as owner, property manager, or tenant on the document that the applicant resides*
14 *at that address, signed by that person under penalty of voting fraud if false information is*
15 *provided. The statement shall be on the form prescribed by the secretary of state for that*
16 *purpose or must contain all the information set forth on the official form.*

17 *(2) Registering on election day.*

18 *(A) When registering on election day as provided in RSA 654:7-a, if the*
19 *applicant does not have in his or her possession at the polls one of the qualified documents*
20 *listed in subparagraph (1) nor other reasonable documentation which establishes that it*
21 *is more likely than not that the applicant has a domicile at the address claimed in the*
22 *town or ward in which he or she desires to vote [if the applicant does not have reasonable*
23 *documentation in his or her possession at the place and time of voter registration], he or she may*
24 *execute a sworn statement on the general election day voter registration form, or an affidavit as*
25 *provided in subparagraph (3). If the applicant identifies on his or her application and*
26 *affidavit action taken to establish his or her domicile, which he or she has documentation*
27 *of, he or she must agree to mail a copy of or present the document in person to the city or*
28 *town clerk within 10 days, or where the town clerk's office is open fewer than 20 hours*
29 *weekly, within 30 days. Copies of documents provided in compliance with this section are*
30 *exempt from the public disclosure required by RSA 91-A. The clerk shall document receipt*
31 *of a copy or completion of verification of a document presented in person and report*
32 *receipt or verification to the supervisors of the checklist. An applicant whose voter*
33 *registration is approved based on a domicile affidavit who fails to provide a document to*
34 *the city or town clerk as required by this paragraph shall be subject to the penalties of*
35 *wrongful voting as established in RSA 659:34. The supervisors of the checklist shall*
36 *initiate removing the name from the checklist of any such person who fails to provide*
37 *proof of domicile by the deadline by sending the person the notice required by RSA 654:44.*

(B) A person registering on election day who does not possess reasonable documentation of establishing domicile and has taken no verifiable action to carry out his or her intent to establish domicile at the address claimed on the voter registration application may nonetheless use an affidavit to prove domicile. The supervisors of the checklist shall as soon as practical following the first election at which such a person relies solely on a domicile affidavit to register and vote verify that the person was domiciled at the address claimed on election day by:

(i) Requesting local law enforcement during their routine patrols to visit the address and verify that the individual was domiciled there on election day;

(ii) Requesting the secretary of state to send a letter of domicile verification to be sent in the same manner as provided in RSA 654:12, V(b) and RSA 659:13, IV(a); or

(iii) Two or more supervisors or other municipal officials visiting the address and verifying that the individual was domiciled there on election day.

(C) Any case where supervisors are unable to verify the applicant's domicile or where evidence exists of voting fraud shall be promptly reported to the secretary of state and to the attorney general, who shall cause such further investigation as is warranted.

4 Wrongful Voting; Penalties for Voter Fraud. Amend RSA 659:34, I(f)-(g) to read as follows:

(f) Gives a false name or answer if under examination as to his or her qualifications as a voter before the supervisors of the checklist or moderator; [or]

(g) Presents falsified proof of identity at any election;

(h) Registers to vote on election day using an affidavit to satisfy proof of being qualified, represents on the affidavit that the person possess proof that he or she does not have in his or her possession at the polling place, and fails to provide a copy of the document by mail or to present the document in person to the town or city clerk by the deadline established in RSA 654:12; or

(i) Provides false information in a written and signed statement or other documentation that another person is domiciled at an address that is owned, leased, rented, or managed by the individual providing the statement for the purposes of voter registration and that statement is used for voter registration purposes.

5 Effective Date. This act shall take effect January 1, 2018.
