

Amendment to SB 206-FN

1 Amend the bill by inserting after section 6 the following and renumbering the original sections 7-9  
2 to read as 11-13, respectively:

4 7 Pari-Mutuel Pools on Simulcast Racing. Amend RSA 284:22-a, II(d) to read as follows:

5 (d) Notwithstanding subparagraph II(a), an individual, association, partnership, joint  
6 venture, corporation, or other organization or entity may be issued a license to conduct simulcasting  
7 without conducting live horse racing at a location in Cheshire county, provided such person or  
8 entity applies for, and is issued, a license to conduct live horse racing at such location in Cheshire  
9 county, complies with other provisions of this chapter with regard to application and issuance of  
10 such license, makes such election with the approval of the commission, and such person or entity  
11 has submitted an economic development plan to the commission to conduct a live horse racing meet  
12 in Cheshire county within [36] 48 months of the granting of a license. If no live horse racing is  
13 conducted within the [36-] 48-month period the license to receive simulcast wagers shall be revoked.  
14 The commission shall adopt regulations regarding the criteria of the proposed economic  
15 development plan prior to issuance of any approval.

16 8 Pari-Mutuel Pools; Tax. Amend RSA 284:23, I(c) to read as follows:

17 (c) Any amounts so paid to the state treasurer by any person, association, or corporation  
18 licensed to simulcast a running horse race or running horse meet under this chapter collected in  
19 Cheshire county shall be held in escrow for a period of not more than [36] 48 months by the state  
20 treasurer. If any person, association, or corporation licensed under this chapter has commenced to  
21 hold a live race meet within the [36-] 48-month period the escrowed amounts shall be paid to the  
22 lottery commission to offset any expenses incurred for the services required to hold such meet. If  
23 there is no live race meet within the [36-] 48-month period all sums so escrowed shall be for the use  
24 of the state.

25 9 Pari-Mutuel Pools; Tax. Amend RSA 284:23, II(c) to read as follows:

26 (c) Any amounts so paid to the state treasurer by any person, association, or corporation  
27 licensed to simulcast a harness horse race or harness horse race meet under this chapter collected  
28 in Cheshire county shall be held in escrow for a period of not more than [36] 48 months by the state  
29 treasurer. If any person, association, or corporation licensed under this chapter has commenced to  
30 hold a live race meet within the [36-] 48-month period the escrowed amounts shall be paid to the  
31 lottery commission to offset any expenses incurred for the services required to hold such meet. If  
32 there is no live race meet within the [36-] 48-month period all sums so escrowed shall be for the use

2 10 Pari-Mutuel Pools; Tax. Amend RSA 284:23, III(c) to read as follows:

3 (c) Any amounts so paid to the state treasurer by any person, association, or corporation  
4 licensed to simulcast a dog race or meet under this chapter collected in Cheshire county shall be  
5 held in escrow for a period of not more than ~~[36]~~ **48** months by the state treasurer. If any person,  
6 association, or corporation licensed under this chapter has commenced to hold a live race meet  
7 within the ~~[36-]~~ **48**-month period the escrowed amounts shall be paid to the lottery commission to  
8 offset any expenses incurred for the services required to hold such meet. If there is no live race  
9 meet within the ~~[36-]~~ **48**-month period all sums so escrowed shall be for the use of the state.
