

Amendment to SB 3

1 Amend the bill by replacing all after the enacting clause with the following:

2
3 1 Voters; Temporary Absence or Presence. Amend RSA 654:2 to read as follows:

4 654:2 Temporary Absence **or Presence**.

5 **I.** A domicile for voting purposes acquired by any person in any town shall not be
6 interrupted or lost by a temporary absence therefrom with the intention of returning thereto as his
7 or her domicile. Domicile for the purpose of voting as defined in RSA 654:1, once existing, continues
8 to exist until another such domicile is gained. Domicile for purposes of voting is a question of fact
9 and intention ***coupled with a verifiable act or acts carrying out that intent***. A voter can have
10 only one domicile for ~~[these]~~ **voting** purposes. No person shall be deemed to have lost a domicile by
11 reason of his or her presence or absence while the voter or his or her spouse is employed in the
12 service of the United States; nor while engaged in the navigation of the waters of the United States
13 or of the high seas; nor while a teacher in or student of any seminary of learning; nor while confined
14 in any public prison or other penal institution; nor while a patient or confined for any reason in any
15 nursing, convalescent home or hospital, old folks or old age home, or like institution or private
16 facility.

17 **II.(a)** *A person present in New Hampshire for temporary purposes shall not gain a*
18 *domicile for voting purposes. A person who maintains a voting domicile where he or she*
19 *came from, to which he or she intends to return to as his or her voting domicile after a*
20 *temporary presence in New Hampshire, does not gain a domicile in New Hampshire*
21 *regardless of the duration of his or her presence in New Hampshire.*

22 **(b)** *A person who has been present and residing in one town or ward in New*
23 *Hampshire for 30 or fewer days is presumed to be present for temporary purposes unless*
24 *that person has the intention of making the place in which the person resides his or her*
25 *one place, more than any other, from which he or she engages in the domestic, social, and*
26 *civil activities of participating in democratic self-government including voting, and has*
27 *acted to carry out that intent.*

28 **(c)** *For the purposes of this chapter, temporary purposes shall include, but are*
29 *not limited to, being present in New Hampshire for 30 or fewer days for the purposes of*
30 *tourism, visiting family or friends, performing short-term work, or volunteering or*
31 *working to influence voters in an upcoming election.*

32 **(d)** *For the purposes of voter registration, acts demonstrating an intent to make*

1 *a place an individual's domicile shall include, but are not limited to:*

2 *(1) Residency at an institution of higher learning;*

3 *(2) Renting or leasing an abode at that place for a period of more than 30*
4 *days;*

5 *(3) Purchasing an abode at that place;*

6 *(4) Obtaining a New Hampshire resident motor vehicle registration,*
7 *driver's license, or official nondriver's picture identification card listing that place as his*
8 *or her residence;*

9 *(5) Enrolling the person's dependent minor child in a publicly funded*
10 *elementary or secondary school which serves the town or ward of that place;*

11 *(6) Listing that place as the person's physical residence address on state or*
12 *federal tax forms, other government identification, or other government forms that show*
13 *the domicile address;*

14 *(7) Providing the address of that place to the United States Post Office as*
15 *the person's permanent address, provided it is not a postal service or commercial post*
16 *office box;*

17 *(8) Obtaining a New Hampshire resident hunting or fishing license, listing*
18 *that place as his or her residence;*

19 *(9) Obtaining utility services for an indefinite period at that place; or*

20 *(10) Arranging for a homeless shelter or similar service provider located in*
21 *the town or ward to receive United States mail on behalf of the individual using that*
22 *facility's address as the individual's domicile address for voting purposes.*

23 *(e) An applicant whose domicile is at an abode rented, leased, or owned by*
24 *another and whose name is not listed on the rental agreement, lease, or deed may provide*
25 *a written statement from a person who is listed on the rental agreement, lease, or deed, or*
26 *other reasonable proof of ownership or control of the property or his or her agent who*
27 *manages the property that the applicant resides at that address, signed by the owner or*
28 *manager of the property under penalty of voting fraud if false information is provided.*
29 *The statement shall be on the form prescribed by the secretary of state for that purpose or*
30 *contain all the information set forth on that official form.*

31 *III. An individual applying for registration as a voter 30 or fewer days before an*
32 *election shall use the election day registration form required by RSA 654:7, IV(c) which*
33 *shall require the applicant to provide the date he or she established his or her voting*
34 *domicile in New Hampshire. The registration form shall require the voter to identify and*
35 *provide evidence of a verifiable action he or she has taken carrying out his or her intent to*
36 *make the place claimed on the voter registration form his or her domicile.*

37 *IV. A person may register on election day through use of an acknowledgment of*

1 *domicile evidence obligation on the registration form and vote if he or she does not have*
2 *any document in his or her possession at the polls providing evidence of an action*
3 *carrying out his or her intent to make the address claimed as his or her voting domicile. A*
4 *person relying on an acknowledgment of domicile evidence obligation to register must*
5 *mail or present evidence of an action taken before registering to vote to carry out his or*
6 *her intent to make the address claimed his or her domicile to the town or city clerk within*
7 *10 days following the election, or within 30 days in towns where the clerk's office is open*
8 *fewer than 20 hours weekly.*

9 *V. The supervisors of the checklist shall as soon as practical following the first*
10 *election at which a person who relied solely on an acknowledgment of domicile evidence*
11 *obligation to register and vote, but who fails to mail or present evidence of having taken*
12 *some action to carry out his or her intent to establish domicile at the address listed on his*
13 *or her voter registration application to the clerk by the deadline, verify that the person*
14 *was domiciled at the address claimed on election day by means including, but not limited*
15 *to:*

16 *(a) Examining public records held by the town or city clerk, municipal*
17 *assessing and planning offices, tax collector, or other municipal office that may house*
18 *public records containing domicile confirmation; or*

19 *(b) Requesting 2 or more supervisors or municipal, county, or state election*
20 *officers or their agents to visit the address and verify that the individual was domiciled*
21 *there on election day.*

22 *VI. The supervisors shall promptly report to the secretary of state, the name of any*
23 *applicant who fails to mail or present evidence of a verifiable act to the clerk. The*
24 *supervisors shall also initiate removal of the person from the checklist by sending the*
25 *person the notice required by RSA 654:44.*

26 *2 Voter Registration Form; Day of General Election. Amend RSA 654:7, IV(c) to read as*
27 *follows:*

28 *(c) The secretary of state shall prescribe the form of the voter registration form to be*
29 *used only for voter registrations, transfers, or updates **starting 30 days before each election and***
30 *at the polling place on the date of a state general election, which shall be in substantially the*
31 *following form:*

3 Determining Qualifications of Applicant; Domicile. Amend RSA 654:12, I(c) to read as follows:

(c) DOMICILE.

(1) Registering in advance of an election.

(A) A person who possesses one of the following qualified documents listing the applicant's name and the address claimed as domicile must present that document when applying for registration prior to election day: (i) New Hampshire driver's license or picture identification card (ii) New Hampshire resident vehicle registration; (iii) a picture identification issued by the United States government that contains a current address, (iv) government issued check, benefit statement, or tax document. A person who possess such a document, but failed to bring it with the person when seeking to register to vote shall be required to return when he or she can present one of these documents or to bring the document and register on election day.

(B) A person who attests under penalty of voter fraud that he or she does not possess any of the qualified documents listed in subparagraph (A) may present any reasonable documentation [which indicates] of having established a physical presence at the place claimed as domicile, having an intent to make that place his or her domicile, and having taken a verifiable act to carry out that intent. The documentation must establish that it is more likely than not that the applicant has a domicile and intends to maintain [a] that domicile, as defined in this chapter, at least until election day in the town[-city,] or ward in which he or she desires to vote[-or,]. Reasonable documentation includes, but is not limited to evidence of:

- 1 (i) *Residency at an institution of higher learning;*
2 (ii) *Renting or leasing an abode at that place for a period of more*
3 *than 30 days;*
4 (iii) *Evidence of purchasing an abode at that place;*
5 (iv) *Enrolling the applicant's dependent minor child in a publicly*
6 *funded elementary or secondary school which serves the town or ward of that place;*
7 (v) *Listing that place as the person's physical residence address on*
8 *state or federal tax forms, a United States passport, other government identification, or*
9 *other government forms;*
10 (vi) *Providing the address of that place to the United States Post*
11 *Office as the person's permanent address, provided it is not a postal service or commercial*
12 *post office box;*
13 (vii) *Obtaining a New Hampshire resident hunting or fishing license*
14 *listing that place as residence;*
15 (viii) *Obtaining utility services for an indefinite period at that place;*
16 *or*
17 (ix) *Arranging for a homeless shelter or similar service provider*
18 *located in the town or ward to receive United States mail on behalf of the individual.*
19 *An applicant whose domicile is at an abode of another and whose name is not listed on the*
20 *document offered as proof of domicile may provide a written statement from a person who*
21 *is listed as owner, property manager, or tenant on the document that the applicant resides*
22 *at that address, signed by that person under penalty of voting fraud if false information is*
23 *provided. The statement shall be on the form prescribed by the secretary of state for that*
24 *purpose or must contain all the information set forth on the official form.*

25 (2) *Registering on election day.*

26 (A) *When registering on election day as provided in RSA 654:7-a, if the*
27 *applicant does not have in his or her possession at the polls one of the qualified documents*
28 *listed in subparagraph (1) nor other reasonable documentation which establishes that it*
29 *is more likely than not that the applicant has a domicile at the address claimed in the*
30 *town or ward in which he or she desires to vote* [~~if the applicant does not have reasonable~~
31 ~~documentation in his or her possession at the place and time of voter registration~~], *he or she may*
32 *execute a sworn statement on the general election day voter registration form* [~~, or an affidavit~~] *and*
33 *initial the acknowledgment of domicile evidence obligation. If the applicant identifies on*
34 *his or her application action taken to establish his or her domicile, which he or she has*
35 *documentation of, he or she must agree to mail a copy of or present the document in*
36 *person to the city or town clerk within 10 days, or where the town clerk's office is open*
37 *fewer than 20 hours weekly, within 30 days. Copies of documents provided in compliance*

1 *with this section are exempt from the public disclosure required by RSA 91-A. The clerk*
2 *shall document receipt of a copy or completion of verification of a document presented in*
3 *person and report receipt or verification to the supervisors of the checklist. An applicant*
4 *whose voter registration is approved based on an acknowledgment of domicile evidence*
5 *obligation who fails to provide a document to the city or town clerk as required by this*
6 *paragraph shall be subject to the penalties of wrongful voting as established in RSA*
7 *659:34. The supervisors of the checklist shall initiate removing the name from the*
8 *checklist of any such person who fails to provide proof of domicile by the deadline by*
9 *sending the person the notice required by RSA 654:44.*

10 (B) *A person registering on election day who does not possess reasonable*
11 *documentation of establishing domicile and has taken no verifiable action to carry out his*
12 *or her intent to establish domicile at the address claimed on the voter registration*
13 *application may nonetheless register to vote by initialing the paragraph on the*
14 *registration form acknowledging that domicile may be verified. The supervisors of the*
15 *checklist shall as soon as practical following the first election at which the person initials*
16 *such paragraph to register and vote verify that the person was domiciled at the address*
17 *claimed on election day by:*

18 (i) *Examining public records held by the town or city clerk,*
19 *municipal assessing and planning offices, tax collector, or other municipal office that*
20 *may house public records containing domicile confirmation;*

21 (ii) *Requesting 2 or more supervisors or municipal, county, or state*
22 *election officers or their agents to visit the address and verify that the individual was*
23 *domiciled there on election day.*

24 (C) *Any case where supervisors are unable to verify the applicant's*
25 *domicile or where evidence exists of voting fraud shall be promptly reported to the*
26 *secretary of state and to the attorney general, who shall cause such further investigation*

30 4 Determining Qualifications of Applicant. Amend RSA 654:12, V(a) to read as follows:

31 V.(a) The election official approving the application for registration as voter of a person who
32 does not present an approved form of photo identification as proof of identity when registering, shall
33 mark the voter registration form to indicate that no photo identification was presented and shall
34 inform the person that, if he or she is a first-time election day registrant in New Hampshire, he or
35 she will receive a letter of identity verification. The person entering the voter information into the
36 centralized voter registration database shall determine if the person is listed in the system as
37 having been previously registered in the town or ward reported by the applicant on the voter

1 registration form. If the person is a new registrant who has not been previously registered
2 anywhere in New Hampshire or if the centralized voter registration database does not confirm a
3 previous registration claimed on the voter registration form, the election official shall cause the

5 applicant in New Hampshire and that no photo identification was presented. When municipalities
6 enter information on people who register on election day into the centralized voter registration
7 database, to the extent practical applicants who are registering for the first time in New Hampshire
8 and who also register without presenting an approved photo identification shall be entered first.
9 The person entering the voter information of election day residents into the centralized voter
10 registration database shall cause the records to indicate if the voter executed ~~[a domicile affidavit~~
11 ~~or]~~ a sworn statement on the general election day voter registration form.

12 5 Determining Qualifications of Applicant. Amend RSA 654:12, V(d) to read as follows:

13 (d) Within 90 days of each election, the secretary of state shall cause a list of persons
14 executing ~~[domicile affidavits and]~~ sworn statements on the general election day voter registration
15 form since the prior election to be forwarded to the attorney general and the division of motor
16 vehicles. The secretary of state shall send a letter to each such person informing him or her of a
17 driver's obligation to obtain a New Hampshire driver's license within 60 days of becoming a New
18 Hampshire resident. The letter shall be mailed within 60 days after the election, except that if the
19 election is a state primary election, the letter shall be mailed 60 days after the general election, and
20 if the election is a regularly scheduled municipal election, the letter shall be mailed by the July 1 or
21 January 1 next following the election. The secretary of state shall mark the envelope with
22 instructions to the United States Post Office not to forward the letter and to provide address
23 correction information.

24 6 References Deleted. Amend RSA 654:31-a to read as follows:

25 654:31-a Right to Know Exemption. The information contained on the checklist of a town or
26 city, specifically, the name, domicile address, mailing address, town or city, and party affiliation, if
27 any, of registered voters, except as otherwise provided by statute, is public information subject to
28 RSA 91-A. All other information on the voter registration form, absentee registration affidavit,
29 qualified voter ~~[and domicile]~~ affidavits, affidavit of religious exemption, and application for
30 absentee ballot shall be treated as confidential information and the records containing this
31 information shall be exempt from the public disclosure provisions of RSA 91-A, except as provided
32 by statutes other than RSA 91-A. Notwithstanding the foregoing, qualified voter ~~[and domicile]~~
