MINUTES LEGISLATIVE ETHICS COMMITTEE MARCH 24, 2015 MEETING {Approved: September 21, 2015}

The Legislative Ethics Committee (RSA 14-B:2) met on Tuesday, March 24, 2015, at 3:00 P.M. in Room 104 of the Legislative Office Building.

The following members were present: the Honorable Donna Sytek, Chairman, Senator Sharon M. Carson, Vice Chairman, Senator Martha Fuller Clark, Representative Janet G. Wall, Representative David A. Welch, the Honorable John A. Graham, and Attorney David H. Bradley. Also present: Richard M. Lambert, Executive Administrator. Chairman Sytek introduced the newest member of the Committee, Attorney Bradley, and then asked each member to say a few words of introduction about themselves.

Chairman Sytek then made the following statement about former Committee members Martin L. Gross, Esq. and Kimon S. Zachos, Esq.:

"At the prior meeting I should have noted the service of the previous chair of the committee, Martin Gross, whom I guess all of us know, who was on the Committee for 4 full terms, and chairman for 3 terms. During his time, I am told... there was a conflict between the statute and the Ethics Guidelines and it took several years to get that straightened out without any clear directive from the House or the Senate. Under Martin's leadership, they were able to sort that out so that at least the Guidelines reflected what was in the statute.

"Serving on the Committee at that time was the late Kim Zachos, and many of you may know him. I served on many non-profit boards with Kimon. He was once the House Majority Leader and a real bottom line kind of guy who looked to get a group to a decision quickly... Kimon died recently but I didn't want it to go unnoted that he had been a member of the Legislative Ethics Committee for 3 full terms. And they had some really thorny issues to deal with. And I hope that our term is uneventful and we don't have anything to deal with like they did."
