The Committee's meeting consisted of the following items:

ITEM #1

Chairman Gordon stated: "The Committee has voted to come out of nonpublic session. Having discussed *Complaint 2019-5*, a newly-filed complaint to the committee, and the Committee has elected to continue the initial review on that complaint until our next meeting."

ITEM #5

Discussion about whether a legislator who serves as a member of a board of directors may raise money for the board.

Mr. Lambert said that Senator Carson had asked him to include the item on the agenda. He said that, although Senator Carson wasn't able to attend, Senate Legal Counsel Greg Silverman would be able to briefly discuss the issue.

Attorney Silverman said the issue relates to the annual conference of the Council of State Governments (CSG) that will be held in Manchester next year and is about the solicitation of funds for that conference. He said that he, House Legal Counsel James Cianci, and potentially others will have more information about the issue for a discussion with the Committee at its next meeting.

Vice Chairman Sytek asked if the question is, "Can the legislators raise money for this conference?"

Attorney Silverman said "yes."

Senator Fuller Clark said, "Just as we gave permission for staff."

Vice Chairman Sytek said, "We gave permission for staff, but we specifically limited it to staff... and we said this means legislators can't."

Senator Fuller Clark agreed.

Chairman Gordon said, "That's what's in the legislation."

After further brief discussion, Chairman Gordon "We look forward to our discussion at the next meeting."

ITEM #6

New/Other Business.

Chairman Gordon asked if there was any new or other business.

Mr. Lambert responded that he had an update on the effort to have an electronic version of the Financial Disclosure Form. He said, "Our IT department tells me that they are very confident that the electronic version of the Financial Disclosure Form will be ready for early December."

Vice Chairman Sytek said that was great and she asked about what happened to the Committee's recommendation last year to amend the law so that legislators would have to file the form only every 2 years instead of annually.

Senator Fuller Clark recalled why that didn't happen but offered to submit an LSR for 2020. She asked Mr. Lambert to help her craft the language for a bill to accomplish that.
