Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 State Senate Districts. RSA 662:3 is repealed and reenacted to read as follows:

- by this act shall be in effect for the purpose of electing senators at the 2022 state general election. If
- 2 there shall be a vacancy in a state senate district for any reason prior to the 2022 state general
- 3 election, the vacancy shall be filled by and from the same state senate district that existed for the
- 4 2020 state general election. No provision of this act shall affect in any manner any of the
- 5 proceedings of the membership of the senate of the general court that assembled for a biennial
- 6 session in January 2021.

3 Effective Date. This act shall take effect upon its passage.
