

Draft C of C Amendment to HB 2-FN-A-LOCAL

1 Amend the bill by replacing section 387 with the following:

3 387 Substance Abuse Enforcement Program; Appropriations.

4 I. The sum of \$618,632 for the fiscal year ending June 30, 2021 is hereby appropriated to the
5 department of safety. This sum shall be expended as follows:

6 (a) \$180,632 shall be expended for the purpose of funding overtime at the state forensic
7 laboratory as a result of increased caseloads attributable to narcotics related enforcement and
8 investigations, with no more than 50 percent of the appropriation expended in each fiscal year of the
9 biennium ending June 30, 2023.

10 (b) \$438,000 shall be expended for the purpose of funding overtime at the state police for
11 narcotics related enforcement and investigations, with no more than 50 percent of the appropriation
12 expended in each fiscal year of the biennium ending June 30, 2023.

13 II. The sum of \$2,526,315 for the fiscal year ending June 30, 2021 is hereby appropriated to
14 the department of safety to disburse grants to county and local law enforcement agencies for the
15 purpose of funding overtime costs for county and local law enforcement officers performing law
16 enforcement activities attributable to the substance abuse enforcement program established in RSA
17 21-P:66. No more than 50 percent of the appropriation shall be expended in each fiscal year of the
18 biennium ending June 30, 2023.

19 III. The governor is authorized to draw a warrant for said sums out of any money in the
20 treasury not otherwise appropriated.

21 IV. No appropriation made in this section shall lapse until June 30, 2023.

24 1 Additional Funding from State Department and Agencies. Amend RSA 604-A:1-c to read as
25 follows:

26 604-A:1-c Additional Funding From State Departments and Agencies.

27 I. Every state department, board, institution, commission, or agency which receives general
28 fund grants or supplemental appropriations outside of the state biennial operating budget for the
29 purpose of conducting law enforcement activities that may result in increased costs for indigent
30 defense as determined by the court, shall transfer 5 percent of such funds received to the judicial
31 council to be used to pay for indigent defense costs resulting from such law enforcement activities.
32 Payment for expenses of indigent representation under this section shall be made pursuant to RSA

1 604-A:8.

2 *II. The department of safety shall transfer 5 percent of any additional funds*
3 *appropriated for the substance abuse enforcement program established in RSA 21-P:66 to*
4 *the judicial council to be used to pay for indigent defense costs resulting from such law*
5 *enforcement activities. Payment for expenses of indigent representation under this section*
6 *shall be made pursuant to RSA 604-A:8.*
