ESSER I: \$37,641,372

GEER I: \$8,891,470

Preventing, preparing for, and responding to COVID-19 to support LEAs, IHEs, and education-related entities deems essential for carrying out emergency educational services.

GEER II: \$3,799,848

Similar to GEER I.

EANS: \$7,069,209

Emergency Assistance to Non-Public Schools. Supplies to sanitize, disinfect, and clean school; Personal protective equipment; Improving ventilation systems; Training and professional development on sanitation, the use of personal protective equipment, and minimizing the spread of infectious diseases; Physical barriers to facilitate social distancing; Materials, supplies, or equipment to implement public health protocols; Coronavirus testing; Educational technology; Redeveloping instructional plans; Leasing of sites or spaces to ensure safe social distancing; Reasonable transportation costs; Initiating and maintaining remote learning, hybrid learning, or to address learning loss.

EANS expenditures must be paid by the department on behalf of the non-public school.
