6. (a) Summary of what the rule says and of any proposed amendments:

The Office of Professional Licensure and Certification (OPLC) is proposing to readopt Plc 1003.02 with amendments to revise the definition of "reimbursable expenses" to accommodate reimbursing members of the Board of Registration of Funeral Directors and Embalmers (Board) for inspections and examinations, and to adopt a new section, Plc 1003.06, to establish the reimbursement rates and payment mechanism for Board members.

RSA 325 promotes public health, safety, and welfare by safeguarding the people of New Hampshire against incompetent and unauthorized embalming and funeral practices, and established the Board to ensure proper implementation of the statute.

RSA 325:17 authorizes the Board to conduct inspections of funeral homes and related sites, and is implemented through rules adopted by the Board as Frl 603. RSA 325:18 authorizes the Board to conduct examinations for the purpose of licensure of embalmers and funeral directors, and is implemented through rules adopted by the Board as Frl 302 relative to embalming, Frl 303 relative to funeral directors, and Frl 403 relative to reinstatement.

Inspections and examinations are conducted by members of the Board. Until the repeal of RSA 325:6 by Laws of 2021, 197:56, I (eff. 7-1-21), Board members received a per diem for conducting inspections and examinations. However, the per diem rules adopted by the OPLC only authorize per diems for attendance at meetings, not for other activities. Board members will not conduct the inspections and examinations without any reimbursement, which means that inspections and examinations are not being conducted and so licenses cannot be issued or renewed. By adopting the proposed rules, the OPLC will ensure that Board members can be compensated at least in part for their conduct of inspections and examination.

6. (b) Brief description of the groups affected:

These rules directly affect members of the Board who are authorized to conduct inspections and examinations and indirectly affect funeral homes that need to be inspected and applicants for licensure as a funeral home director or embalmer who need to take and pass an examination.

There will be no cost to the facilities or applicants as the inspection fees and examination fees are not being changed.

# FP 2022-42, Plc 1003 Reimbursable Expenses for Board of Registration of Funeral Directors & Embalmers Summary of Comments on Initial Proposal with OPLC Responses April 27, 2022

#### **Background**

The Office of Professional Licensure and Certification (OPLC) is proposing to readopt Plc 1003.02 with amendments to revise the definition of "reimbursable expenses" to accommodate reimbursing members of the Board of Registration of Funeral Directors and Embalmers (Board) for inspections and examinations, and to adopt a new section, Plc 1003.06, to establish the reimbursement rates and payment mechanism for Board members. More information about the proposed changes was provided in the Rulemaking Notice published in the March 17, 2022 *Rulemaking Register*.

No one from the public attended the public hearing held on April 12, 2022. A comment was received from the Board and is addressed below. One editorial comment was received from OLS/Administrative Rules; the noted edit (to Plc 1003.02(a)) has been made.

The OPLC made the following revision on its own initiative:

Plc 1003.06(a): changed "ensure proper reimbursement" to "provide for reimbursement".

#### Plc 1003.06 re: reimbursement of board members

<u>Comment</u>: We do not see anything that allows the board members to be paid for administering the written exam as it does for the practical exam administration and inspections.

Response: This was an oversight; the rule is intended to apply to all examinations. The OPLC has inserted "written or" before "practical examination" to clarify that both are eligible for reimbursement.

Readopt with amendment Plc 1003.02, eff. 12-22-21 (doc. #13316), to read as follows:

Plc 1003.02 <u>Definitions</u>. For purposes of this part and for reimbursement, the following definitions shall apply:

- (a) "Meeting" means a convening of a quorum of a supported board, commission, or council for the purpose of conducting official business within the jurisdiction of the body, whether conducted inperson or, if authorized by law to do so, held via electronic means or conducted in-person with participation via electronic means by one or more members of the body or the public, or both, provided that if a meeting is continued so as to occur on more than one calendar day, each day that any part of the meeting occurs is a separate meeting for purposes of per diem and expense reimbursement. The term includes meetings of a quorum of a statutorily-created committee or subcommittee of a supported board, commission, or council.
- (b) "Member" means an individual who has been appointed as required by applicable law to serve on a supported board, commission, or council or on a subunit.
  - (c) "Reimbursable expenses" means:
    - (1) Mileage, parking, and tolls as determined pursuant to Plc 1003.05 for all supported boards, commissions, and councils; and
    - (2) For the board of registration of funeral directors and embalmers, expenses of examinations and inspections as determined pursuant to Plc 1003.06.
- (d) "Sub-unit" means a statutorily-created committee or subcommittee of a supported board, commission, or council.

Adopt Plc 1003.06 to read as follows:

Plc 1003.06 <u>Reimbursable Expenses for Board of Registration of Funeral Directors and</u> Embalmers.

- (a) The purpose of this section is to provide for reimbursement for members of the board of registration of funeral directors and embalmers (board) who:
  - (1) Perform inspections pursuant to RSA 325:17 and Frl 603; and
  - (2) Conduct practical examinations pursuant to RSA 325:18 and Frl 302 relative to embalming, Frl 303 relative to funeral directors, or Frl 403 relative to reinstatement.
- (b) A member of the board who has been duly authorized by the board to conduct an inspection shall be reimbursed the amount specified in Table 1003-1, below, as applicable to the type of inspection conducted:

Table 1003-1: Reimbursement Rates for Inspections

Type of Inspection	Reimbursement Rate
New facility funeral home or chapel	\$250 per inspection
Funeral home reinspection (every 3 years)	\$200 per inspection
Funeral home reinspection (deficiencies)	\$100 per inspection
Chapel reinspection (every 3 years)	\$100 per inspection

(c) A member of the board who has been duly authorized by the board to conduct a written or practical examination shall be reimbursed \$150 for each examination conducted.

- (d) To receive reimbursement, the board member shall submit to the OPLC an invoice that identifies the total amount of reimbursement sought and, for each activity for which reimbursement is sought:
  - (1) The date the activity occurred;
  - (2) The location of the activity;
  - (3) Whether the activity was an inspection or an examination;
  - (4) If the activity was an inspection:
    - a. The name of the facility inspected;
    - b. The type of inspection conducted using the categories listed in Table 1003-1, above; and
    - c. The reimbursement rate, from Table 1003-1, above; and
  - (5) If the activity was an examination:
    - a. The name of the individual to whom the examination was administered;
    - b. The type of examination conducted; and
    - c. The reimbursement rate from (c), above.
- (e) The board member shall sign and date the invoice to certify that the information submitted is true, complete, and not misleading to the best knowledge and belief of the board member.
