**Footnotes:**

- Release Hearings:
  - A release hearing may not result in a physical release from the facility. A client may parole to consecutive charge(s).
  - The Hearing number indicates the number of actual hearings, not number of clients. One client may have multiple hearings in a month.
- Release Hearing Outcome Reasons: Release hearings that end in a denial may have more than one reason for denial. This number represents the total number of reasons, not denials.
- Revocation Hearings: The Hearing number indicates the number of actual hearings, not number of clients. One client may have multiple hearings in a month.
- Revocation Hearing Outcome Reasons: Revocation hearings may have multiple reasons for release or revocation. This number represents the total number of reasons, not hearings.
- Detention Hearings: Detention hearings are held in conjunction with SB 52 which indicates a parole violator's term of revocation may be extended for various reasons.
- Detention Hearing Outcome Reasons: Revocations/Detentions that are extended may be so because of multiple reasons. This number represents the total number of reasons, not hearings.
- Review Hearings: Hearing number indicate number of actual hearings, not number of clients. One client may have multiple hearings in a month.
