

Choices For Independence (CFI)

- > Community programs for seniors and adults with chronic illness
- Certified as "Nursing Home Level of Care" by DHHS
- > CFI permits seniors to live in their home, rather than a nursing home.
- > Nearly 4000 people are served in CFI.



Choices For Independence (CFI)

- Budget Line: 05-95-48-482010-2152
 - > Account #'s 506 and 529
- > Only 70-74% of eligible services are being delivered
- Services are undelivered because providers cannot hire staff due to low reimbursement rates.
- > But millions of dollars are being lapsed form these accounts.

CFI


- > Waypoint is losing nearly \$400K per year on CFI
- > To continue providing CFI services, rates must be raised to reflect actual cost of providing CFI services.
- > This can be done within the existing budgeted amounts, by converting lapse into rate increases.

Sununu Youth Services Center(SYSC)

- > Planned during crime increase during 1990's.
- > Opened in 2006 for \$29M with more than 100 children incarcerated.
- > The number of children incarcerated has decreased since 2006
- > Since 2016, Waypoint and other providers have worked to reform the system.
- > SB517(2017) only permits certain offenders be committed or detained at SYSC
- Required these children be treated in more appropriate community care.


Sununu Youth Services Center (SYSC)

SYSC

- > Through the years, children were sent to SYSC because beds were available.
- DHHS argues these children are "too violent"
 - > The same children are being treated in the community today.
- > SYSC staffing remains at pre- 2017 levels,
- > SYSC budget continues to increase each budget, but
- Census is significantly lower (2017=64; today =8)
- Moving children to a rehabilitative facility will provide better care, for less and maintain safety of children and the community
