 - Section II in House Bill 2. For funding the Division of Pesticide Control and reduce the

need of general funds.

- 3. Established a budget around funding all positions within the Department of Agriculture, while maintaining programs within each of the agencies. (Positions that could not be filled if FY 20 & 21)
 - a. Marketing Representative for the Division of Agricultural Development
 - b. Environmentalist Position for the Division of Pesticide Control
 - c. Inspector for the Division of Weights and Measures
 - d. Program Planner III for Food Safety Modern Act. (FSMA) part time position
- 4. Prioritizing needs based on urgency for each agency and programs by redistributing funds responsibly:
 - a. Upgrading to a new version of Micro Soft Access or replacing current MS Access with a new platform, Current version is no longer supported by Information Technology. This affects Agriculture Development, Animal Industry, Office of the Commissioner, Pesticide Control, and Weights and Measure. Funding divided up between the Agencies.

- b. Increase the funding for Agriculture in the Classroom by \$4,000 per year
- c. Future Farmers of America for program development by \$4,000 per year

- e. Assessed equipment needs to ensure safety for employees and protection of the consumers. Maintaining existing equipment such as vehicles, and testing equipment, which reduces the cost of new purchases and extends the life of current equipment.
- 5. *New as of March 2021 -Federal Government will no longer enter data for animal health records. Issue that we would face if we do not comply with the requirement to enter the data is that no milk would be allowed to be shipped out of the State of NH and other things that the legislature has tasked us with doing would be added to the list of things that we are not able to fully accomplish.
