The reason we have this is it was within -- it's greater than the 10% that we had authorized previously. But, certainly, it appears this is probably the best we are going to do. But I would ask the Commissioner if you could -- I had a conversation with you yesterday regarding the proceeds.

GEORGE COPADIS, Commissioner, Department of Employment Security: Sure.

CHAIRMAN CHANDLER: Just so we have it in the record, could you explain the status of the proceeds of this money? Maybe they all know it, I don't know.

MR. COPADIS: Yeah. Within the Capital Budget what had happened was is when we moved into the Tobey Building, any of the proceeds from any of the sales of the buildings, and we have — so far we have sold one building, this is the second building we sold, the administration building at 32 South Main, but any and all the proceeds go back in to pay off the Tobey Building debt. And the Tobey Building debt is about \$10 million right now. The original approval was \$22 million for the building, and the actual cost was \$20 million so we paid off about 10 million of the debt, and we still owe another ten. And the 1.3 would go towards the 10 million that's owed on the Tobey Building.

CHAIRMAN CHANDLER: Thank you. Just want to get that in the record.

MR. COPADIS: Sure.

<u>CHAIRMAN CHANDLER</u>: Okay. Thank you. Any other questions? Any other discussion? If not, all those in favor of the item? Any opposed? Motion carries.
