All those in favor to accept the *Guidelines and Procedures* for the Long Range Capital Planning and Utilization Committee signify by saying aye? All those opposed say nay? The ayes have it. Motion carries. Thank you.

CHAIRMAN CLOUTIER: Now the next thing on our agenda is to take up and I would like to -- any other Old Business? Okay. I will go to New Business. And I'd like to first take up the item under the Department of Administrative Services, because they came to our last meeting. We weren't able to organize. So I'd like them to go first, please, and then the Department of Transportation, please. Okay. Please. Thank you very much for coming, and for the record could you please identify yourself.

SARAH LINEBERRY, Administrator, Bureau of Court Facilities, Department of Administrative Services: Yes, my name is Sarah Lineberry, and I'm the Administrator for the Bureau of Court Facilities for the State.

CHAIRMAN CLOUTIER: Okay. All right. Welcome.

MS. LINEBERRY: Thank you.

CHAIRMAN CLOUTIER: Please proceed.

<u>MS. LINEBERRY</u>: So we're looking for approval on a three-year lease -- a Use of Premises Agreement for our Rockingham County Courthouse. We rent space to the County for deeds and for the County Attorney space. It's roughly 18,000 square feet. And they have been tenants with us since the building was constructed in '96. And it's, I think, about 18,000 square feet, like I said. Our rate is based on current operating expenses and 2% of the original construction, which is our typical practice.

CHAIRMAN CLOUTIER: Okay.

**\*\*** REP. GRAHAM: I would move LRCP 19-002 for approval.

SEN. GIUDA: Second.

<u>CHAIRMAN CLOUTIER</u>: Okay. And thank you, Representative Graham made the motion, Senator Giuda seconded. Are there any other questions on this item before we take a vote?

SEN. GIUDA: I do.

CHAIRMAN CLOUTIER: Yes, Senator Giuda, go ahead, please.

SEN. GIUDA: Thank you for coming today.

MS. LINEBERRY: Sure.

SEN. GIUDA: Is there an increase in cost for this? In other words, relative to the last lease, this is a renewal.

MS. LINEBERRY: I think -- let's see. We're

currently -- there typically is an increase and it really is guided by what our actual costs are. This is 10.34 per square foot in the first year. As you can see it goes to 10.45 in the second year, and then it's up to 10.55 in the third year. I would have to go back and look at what we are currently. I don't have that information off the top of my head.

SEN. GIUDA: Okay. Thank you.

<u>CHAIRMAN CLOUTIER</u>: Okay. Thank you. Any other further questions from the Committee on this item, please? Any other questions? Seeing none, are we ready for the vote?

All those in favor of accepting -- of approving item 19-002, from the Department of Administrative Services, signify by saying aye? All those opposed say nay? The ayes have it. The item is approved. Thank you.

MS. LINEBERRY: Thank you very much.

<u>CHAIRMAN CLOUTIER</u>: I appreciate you coming in and your patience.

# MS. LINEBERRY: Thank you.

<u>CHAIRMAN CLOUTIER</u>: You're welcome. Now I next will call upon the Department of Transportation for Disposal of Highway or Turnpike Funded Real Estate. There are two items. So if you could please come up front and for the record, please identify yourself.

PHILLIP MILES, Chief of Property Management, Department of Transportation: Good morning. My name is Phillip Miles. I'm the Chief of Property Management with the Department of Transportation, Bureau of Right-of-Way. The first item today is to request authorization to sell a 10.95-acre parcel of State-owned land located on the easterly side of U.S. Route 4 in the Town of Andover directly to the Town of Andover for \$50,100, which includes an administrative fee of \$1,100.

Concerning a brief history of this piece, this was a piece that was purchased back in 1959 as part of the U.S. Route 4 Project, and another portion of it was purchased in 1995 as part of the Rail Trail Corridor. It's an ancillary piece outside the corridor part of the Rail Trail Area. So inspection of the area deemed that the -- it seemed that the Town of Andover was

encroaching onto the parcel and on the parcel they built their maintenance facility.

So we did some title research and determined that to be the case. We met with the Town of Andover, shared our information with them. Their legal team looked at the information and agreed that that was the case. Unfortunately, they were swayed that they received a deed for the property in the nineties and thought they did have ownership of it. So we are working with them to -- to deed them the property. So we are coming forward to start the process.

On the second page there are several conditions that are going to be part of the sale. There are representatives here from the Town of Andover in attendance if there's any questions of the Committee.

<u>CHAIRMAN CLOUTIER</u>: Okay, all right. Thank you, Mr. Miles. Okay. Any questions of Mr. Miles from the Committee? Are there any questions on this item? Any questions from the Town of Andover, the officials that are here? Again, I want to thank you very much, Town Officials, for coming in and taking time out of your busy schedules to come here.

\*\* REP. GRAHAM: Move approval of Item 19-006.

<u>CHAIRMAN CLOUTIER</u>: Okay, thank you, Representative Graham. Representative Graham has made a motion. Do I have a second on that motion?

#### SEN. CAVANAUGH: Second.

<u>CHAIRMAN CLOUTIER</u>: Second by Senator Cavanaugh. Thank you, Senator. Are we ready for the vote? No other further questions or comments? All those in favor of adopting item 19-006, signify by saying aye? All those opposed say nay? The ayes have it. Motion carries.

<u>CHAIRMAN CLOUTIER</u>: Thank you. Next item. Please continue, Mr. Miles.

<u>MR. MILES</u>: The second item is authorization to sell a parcel of State-owned land totaling eleven hundredths of an acre located near the westerly side of Harris Road in the Town of Windham by a sealed bid process to the abutters with the minimum bid of \$11,725, which includes an administrative fee of \$1,100.

So this was a parcel that we brought in front of the Committee back in 2017 concerning selling this parcel. It's a small triangular parcel that was purchased as part of the construction of the New Hampshire Route 111 Bypass Projects in Salem and Windham. So the thought would be that one of the abutters would have an interest in it.

So we put it out to bid at that time for \$16,100. We did not receive a bid at the time. Excuse me. We did receive bids; however, they were below the minimum we could accept. So we did receive a call recently from one of the abutters who was developing their parcel, spoke to us about the appraisal, and asked us if we took certain things into consideration when we did the appraisal. We reappraised it and felt that some of the points that they had were valid and came up with a new value of 11,725. So the hope is that we could put it out to bid and get a, you know, a bid on this property. And, again, as it's only good to the three abutters, it would only be put out to those three property owners.

CHAIRMAN CLOUTIER: Okay. Thank you, Mr. Miles. Representative Graham, please.

<u>REP. GRAHAM</u>: Thank you. You said you did receive one bid from our initial offering?

MR. MILES: Correct.

REP. GRAHAM: Can you share what that was, that bid was?

MR. MILES: It was \$5,000.

REP. GRAHAM: Okay. Thank you.

<u>CHAIRMAN CLOUTIER</u>: Okay. Thank you, Representative Graham. Further questions from the Committee on this item, please? Are there any further questions? All right. Seeing none. I will entertain a motion to adopt item 19-008.

**\*\*** SEN. GIUDA: Move.

<u>CHAIRMAN CLOUTIER</u>: Motion by Senator Giuda. Do I have a second on that motion?

REP. EDGAR: Second.

<u>CHAIRMAN CLOUTIER</u>: Second by Representative Edgar, again, to adopt Item 19-008. Are we ready for the vote? All those in favor signify by saying aye? All those opposed say nay? The ayes have it. Motion carries.

# \*\*\* {MOTION ADOPTED}

CHAIRMAN CLOUTIER: Thank you. Thank you, Mr. Miles. I appreciate you coming before us.

# (6) Miscellaneous:

<u>CHAIRMAN CLOUTIER</u>: The other thing is Miscellaneous. The Community College System in informational letter of February 26<sup>th</sup> of this year, request for discussion regarding the future sale of real property located at White Mountains Community College. So -- yeah, okay. You could come forward, and welcome to the Committee. And, again, for the record, could you please identify yourselves? And I think everybody should have this letter; again, dated February 26<sup>th</sup>, 2019, and if you had a chance to review it. So if you could, again, first identify yourselves and then go over the letter and then answer any questions the Committee has.

CHUCK LLOYD, President, White Mountains Community College: Thank you, and good morning. Chuck Lloyd, President of White Mountains Community College.

JEAN HARRIGAN, Legal Counsel, Community College System of <u>New Hampshire</u>: And Jean Harrigan. I'm Legal Counsel for the Community College System of New Hampshire.

<u>MR. LLOYD</u>: We are here this morning as an informational just around some property in Berlin, New Hampshire, as part of White Mountains Community College property. Coming down the road will be an approval around sale of a wooded lot and a facility that is currently not being used; but more important, for today's conversation, is around a child care facility. More immediate because we are looking to transition the property to a non-profit organization to operate the child care facility no longer being financially tenable for the college to operate it.

The building itself was given on or about 2004 for a dollar from Northern Human Services, originally constructed by the State of New Hampshire. But we are looking not to make a profit on the building, but to have the child care center still operate as it is a direct relationship with the college and services a lab school for our early childhood care facility. Obviously, very important for the families in the area as well. We'd love to entertain some questions and answer anything I could.

<u>CHAIRMAN CLOUTIER</u>: Okay. Thank you. Questions from the Committee? Yes, go ahead, please, Senator Giuda.

<u>SEN. GIUDA</u>: Thank you, Mr. Chair. Can you tell us about the non-profit is looking, I'm assuming, that's the one that's going to purchase it?

<u>MR. LLOYD</u>: Yeah. We would put it out as an RFP. We have two non-profits we believe are interested. However, they would not be able to financially purchase the building, hence the reason we'd like the ability to donate the building for a dollar. That's really what's keeping those two non-profits taking over the operation at the moment. There's the valuation

of \$118,000 for the building. That's then a question that's really going to keep people from bidding on it at the moment, just because as you're probably well aware child care facilities do not make a lot of money. So that would be a game changer, unfortunately.

# SEN. GIUDA: Thank you.

<u>CHAIRMAN CLOUTIER</u>: Okay. Further questions of the White Mountains Community College from the Committee? Are there any further questions? Okay. So you are going to -- you intend to bring three agenda items for our next meeting, which I've got to talk with the Committee in a few minutes about for April. Okay. And these items are all related to the sale; is that correct?

# MR. LLOYD: Correct.

<u>CHAIRMAN CLOUTIER</u>: Okay. You, of course, will bring in all the detailed information. All right.

#### MR. LLOYD: Yes.

CHAIRMAN CLOUTIER: All right. Thank you for giving us that heads-up. Are there any further questions? Yes, Senator Giuda.

<u>SEN. GIUDA</u>: Any consideration for a long-term lease for a dollar?

<u>MR. LLOYD</u>: I think there would be consideration for that. However, the college maintaining the building would be an additional expense and what we're trying to do as a college is reduce expenses --

SEN. GIUDA: Right.

# MR. LLOYD: -- overall.

SEN. GIUDA: I would say you wouldn't have to if you write the lease right. But, you know, \$118,000 worth of value that we're giving away with no reclaim down the road. We're also

responsible stewards for the State's property so it might be something to consider. I would certainly like to entertain that. 17

MR. LLOYD: I think the college and the System would entertain that; but also looking at, you know, having something, if it is a sale, that if it is not used specifically for child care that right of first refusal would come back to the college. So we may get to the same place that way as well. But we'd certainly entertain either way the Committee felt.

CHAIRMAN CLOUTIER: Okay.

MR. ZELLEM: Just a point of clarification.

CHAIRMAN CLOUTIER: Yes, Mr. Zellem.

<u>MR. ZELLEM</u>: I'm sorry, point of clarification. This building was gifted to the Community College for \$1?

MR. LLOYD: Right.

MR. ZELLEM: Taxpayers dollars were not expended.

 $\underline{\text{MR. LLOYD}}$ : Correct, we wouldn't want to make a profit on that item.

<u>CHAIRMAN CLOUTIER</u>: Okay. Representative Edgar? Okay. Any other questions from the Committee? And remember that's -- the alternates, too. Even though you may not be voting all the time, I want to make sure our alternate members are well-informed. So I would welcome questions from all -- of course, Representative Jack is actually filling in now and Representative Hennessey. So any other questions from the Committee? All right. Seeing none, thank you very much for coming in. Appreciate that.

MR. LLOYD: Thanks for your time.

CHAIRMAN CLOUTIER: Next item we have more informational, the Biennial Report of the Long Range Committee dated December 1<sup>st</sup>, 2018. I don't know if you have any quick questions. We do have a few more minutes. But this is a report the previous Committee under Representative Graham's chairmanship had prepared.

We also have New Hampshire Council on Resources and Development, also known as CORD, which is about their surplus land review. And then similar -- okay, yeah, same thing, New Hampshire Council on Resources, and also an informational letter from the Department of Transportation dated February 19<sup>th</sup>, 2018, on the proposed transfer of management responsibility to the Department of Environmental Services for a 6.56-acre portion of Interstate 89 Limited Access Way located on the southerly side of Interstate 89 along Silk Farm Road in the City of Concord. Are there any questions or discussion on any of these informational items?

(Senator Giuda leaves the Committee Room.)

<u>CHAIRMAN CLOUTIER</u>: Nothing for today. Okay. I just wanted to be sure. Thank you.

<u>CHAIRMAN CLOUTIER</u>: I mean, I can always change it. I will survey all the Senators and Mr. Zellem. I know we're all busy and sometimes hard to make these meetings. But, you know, we do have some important business and I appreciate you all serving on this Committee. I know it's extra work. But it's work that we are asked to get done. I, frankly, didn't like getting up at 5:30 in order to be here at 8:30, but I somehow made it. So I know some of you have even further to travel and other obligations. But thank you very much for coming and I think, unless there's something else.
