#### RSA 4:39-b Approval of State Agency Leases Exceeding 5 Years:

<u>LRCP 19-033 Department of Health and Human Services</u> – request approval of a ten-year term renewal lease agreement with Berlin Falls Real Estate, LLC, 244 Denmark Street, Berlin, NH 03570, for approximately 14,500 square feet of space located at 650 Main Street, Berlin, NH, effective December 1, 2019 with an end date of November 30, 2029, with a total lease cost of \$3,323,316.96, subject to the schedule of annual rent and conditions as specified in the request dated October 14, 2019

LRCP 19-036 Department of Corrections – request approval to enter into a twelve (12) month hold-over amendment lease with Belknap County, 34 County Drive, Laconia, NH 03246, for approximately 2,200 square feet of office space located at 64 Court Street, 1<sup>st</sup> Floor Suite, Laconia, NH for the period of January 1, 2020 through December 31, 2020, for an amount not to exceed \$32,318.04, subject to the schedule of annual rent and conditions as specified in the request dated October 16, 2019

LRCP 19-037 Department of Education – request approval of a ten-year lease agreement with Berlin Falls Real Estate, LLC, 244 Denmark Street, Berlin, NH 03570, for approximately 2,900 square feet of space located at 650 Main Street, Berlin, NH, effective December 1, 2019, with occupancy and rental payments commencing immediately, and expiring November 30, 2029, with a total lease cost of \$664,680, subject to the schedule of annual rent and conditions as specified in the request dated October 24, 2019

#### RSA 4:39-c Disposal of Highway or Turnpike Funded Real Estate:

<u>LRCP 19-032 Department of Transportation</u> – requests authorization to sell a parcel of State owned land consisting of a 4.67 +/- acre parcel located on the southerly side of NH Route 103 in the Town of Warner directly to the Town of Warner for \$14,600, which includes a \$1,100 Administrative Fee, subject to the conditions as specified in the request dated October 14, 2019

LRCP 19-034 Department of Transportation – requests authorization to retroactively extend the listing agreement with Berkshire Hathaway Verani Realty for a term of one (1) year for the period of June 20, 2019 to June 19, 2020, and amend the listing price from \$450,000 to \$333,000, and allow negotiations within the Committee's current policy guidelines, and assess an Administrative Fee of \$1,100, for the sale of a 2 +/- acre parcel of State owned land located at the northeasterly corner of NH Route 111 and NH Route 28 in the Town of Windham, subject to the conditions as specified in the request dated October 21, 2019 (Originally approved (LRCP 17-019) September 19, 2017 and subsequently amended (LRCP 18-044) on November 29, 2018)
