RSA 4:39-b APPROVAL OF STATE AGENCY LEASES EXCEEDING 5 YEARS:

<u>LRCP 20-061 Department of Corrections</u> – Helen Hanks, Commissioner, Department of Corrections was present.

On a motion by Representative Graham, seconded by Representative Rogers, that the Committee approve the request of the Department of Corrections for approval of a two-year amendment lease to extend the original lease term beyond the five-year limitation with Belknap County, 34 County Drive, Laconia, NH 03246, for approximately 2,200 square feet of probation and parole office space located at 64 Court Street, 1st Floor Suite, Laconia, NH, effective for the period of January 1, 2021 to December 31, 2022, for an amount not to exceed \$66,572, subject to the schedule of annual rent and conditions as specified in the request dated November 12, 2020.

This request (LRCP 19-036) was originally approved by the Long Range Capital Planning and Utilization Committee on November 6, 2019.

<u>LRCP 20-063 Department of Transportation</u> – On a motion by Senator Giuda, seconded by Senator Birdsell, that the Committee remove the item from consideration as submitted by the Department of Transportation requesting approval to dispose of approximately 8 +/- acre parcel of State owned land, with improvements, located on NH Route 25 in the Town of Rumney, by entering into a listing agreement for a term of one year with Coldwell Banker for the sale price of \$172,700 and assess an Administrative Fee of \$1,100, allowing negations within the Committee's current policy guidelines, subject to the conditions as specified in the request dated November 18, 2020.

[LRCP 20-057 Department of Transportation – requests approval to dispose of a 1.3 +/- acre parcel of State owned land, with improvements, located at 9 Tracy Drive in the Town of Derry, by entering into a listing agreement for a term of one year with NAI Norwood Group for the sale price of \$275,000 and assess an Administrative Fee of \$1,100, allowing negotiations within the Committee's current policy guidelines, subject to the conditions as specified in the request dated October 22, 2020; LRCP 20-058 Department of Transportation – requests approval to dispose of a 2.04 +/- acre parcel of State owned land, with improvements, located at 23 Spinnaker Drive in the Town of Derry, by entering into a listing agreement for a term of one year with Coldwell Banker for the sale price of \$300,000 and assess an Administrative Fee of \$1,100, allowing negotiations within

the Committee's current policy guidelines, subject to the conditions as specified in the request dated October 22, 2020; <u>LRCP 20-059 Department of Transportation</u> – request approval to dispose of a 0.28 +/-acre parcel of State owned land abutting 169 DW Highway located in Nashua for the sale price of \$70,000 and assess an Administrative Fee of \$1,100, allowing negotiations within the Committee's current policy guidelines, subject to the conditions as specified in the request dated October 14, 2020; and <u>LRCP 20-064 Department of Transportation</u> – request authorization to sell 0.15 +/- of an acre of State owned land within the Limited Access Right of Way (LAROW) located on the northwesterly side of NH Route 132 in the Town of Northfield directly to the Tilton-Northfield Fire and EMS in the amount of \$6,100, which includes an \$1,100 Administrative Fee, subject to the conditions as specified in the request dated November 18, 2020.]
