STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty One

AN ACT naming a courtroom in the second circuit courthouse in Plymouth in honor of Judge Edwin W. Kelly and naming a roundabout in New London in honor of Jessie Levine.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 89:1 Second Circuit Courthouse; Courtroom 1 Named in Honor of Judge Edwin W. Kelly.
2 Courtroom 1 at the second circuit courthouse in the town of Plymouth is hereby renamed the Edwin
3 W. Kelly Courtroom in honor of Judge Edwin W. Kelly who is retiring after 35 years of service to the
4 New Hampshire judicial system, most of which was as an administrative justice in the district and
5 circuit courts. Judge Kelly has worked diligently throughout his career to ensure fair and efficient
6 access to justice to all people.

7 89:2 Jessie Levine Roundabout. Pursuant to RSA 4:43, the roundabout located at N.H. route 11,
8 also known as the intersection of Newport Road and County Road in the town of New London, is
9 hereby named the Jessie Levine Roundabout in honor of municipal and county government leader
10 and New London resident, Jessie W. Levine. Among her many career achievements in the pursuit of
11 good local government, Ms. Levine advocated for and oversaw the roundabout construction while
12 serving as New London's town administrator. An appropriate marker may be placed on the center
13 island of the roundabout.

14 89:3 Signage. The cost of design, construction, maintenance, and installation of any signage,
15 replacement signage, or other markers authorized under section 2 of this act shall not be a charge to
16 the state. However, the design, construction, and installation of any signage or other markers
17 authorized shall be approved by the department of transportation.

89:4 Effective Date. This act shall take effect 60 days after its passage.
