ANALYSIS

This bill prohibits the sale and use of adhesive-based rodent traps.

HB 1351 - AS INTRODUCED

STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Four

AN ACT prohibiting the sale and use of adhesive-based rodent traps.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Section; Adhesive-Based Rodent Traps. Amend RSA 430 by inserting after section 41 the $\mathbf{2}$ following new section:

- 3 430:41-a Adhesive-Based Rodent Traps.
- 4 I. In this section:

(a) "Adhesive-based trap" means any device that is designed or is capable of being used $\mathbf{5}$ 6 to capture a rodent by means of an adhesive substance, including devices commonly known as glue 7traps, glue boards and any similar rodent trap.

8 (b) "Distributor" means any person who delivers to a person other than a purchaser, for 9 the purpose of retail sale.

10 (c) "Exterminator" means a person or entity that is licensed, certified, permitted or 11 otherwise authorized under the laws of this state to provide rodent and pest control services and any 12employee or agent thereof engaging in the provision of such services.

13(d) "Manufacturer" means any person, firm, association, partnership, limited liability 14company, or corporation that produces, prepares, formulates, or compounds an adhesive-based trap as defined in this section. In the case of an adhesive-based trap imported into the United States, 1516"manufacturer" means the importer or first domestic distributor of such product if the entity that 17manufactures the product or whose brand name is affixed to the product does not have a presence in 18the United States.

19(e) "Retailer" means any person or entity who offers adhesive-based traps for sale for use 20or consumption by persons in this state.

21II.(a) Adhesive-based traps shall not be shipped into this state. Such prohibition shall apply 22to all shipments of adhesive-based traps into New Hampshire and includes importation or 23distribution for commercial purposes or personal use.

(b) No manufacturer, distributor, retailer, common carrier, or other person shall bring or 25carry into the state any adhesive-based trap, nor shall any manufacturer, distributor, retailer, 26common carrier, or any other person accept for delivery, deliver or transport any adhesive-based trap 27to any distributor, retailer, or any other person.

28(c) No manufacturer or distributor shall sell, offer for sale, or deliver to a retailer for 29subsequent sale an adhesive-based trap, nor shall any retailer or exterminator purchase, accept, 30 obtain or otherwise acquire any such adhesive-based trap.

1 III.(a) No person, or any agent or employee thereof, shall sell or offer for sale, hold for sale or $\mathbf{2}$ distribute to another person any adhesive-based trap as defined in this section, nor shall any person 3 or any agent or employee thereof purchase, acquire, or possess any such adhesive-based trap for 4 commercial or personal use.

 $\mathbf{5}$ (b) No person or any agent or employee thereof shall set, place, or otherwise use any 6 such adhesive-based trap or permit another person to set, place or use any such adhesive-based trap 7to capture or destroy a rat, mouse or other rodent.

(c)(1) A retailer having in its possession any adhesive-based traps purchased or acquired 9 by such retailer prior to the effective date of this section shall be authorized to sell such adhesive-10based traps for one year after the effective date of this section; and

11 (2) An exterminator having in its possession any adhesive-based traps purchased or 12acquired by such exterminator prior to the effective date of this section shall be authorized to set or 13place such adhesive-based traps while providing rodent control services for one year after the 14effective date of this section.
