3 2 Application. The changes in state representative districts established by this act shall not
4 affect constituencies or terms of office of representatives presently in office. The state representative
5 districts established by this act shall be in effect for the purpose of electing representatives at the
6 2022 state general election. If there shall be a vacancy in a state representatives district for any
7 reason prior to the 2022 state general election, the vacancy shall be filled by and from the same state
8 representative district that existed for the 2020 state general election. No provision of this act shall
9 affect in any manner any of the proceedings of the membership of the house of representatives of the
10 general court that assembled for a biennial session in January 2021.

11 3 Effective Date. This act shall take effect upon its passage.
