Amendment to HB 54

1 Amend the bill by replacing all after the enacting clause with the following:

2

3 1 County Commissioner Districts. RSA 662:4 is repealed and reenacted to read as follows:

4 662:4 County Commissioner Districts. Except for Strafford county where 3 county
5 commissioners shall be elected at large, for the purposes of choosing county commissioners, the
6 counties shall be divided into districts as follows:

7 I. Belknap: District 1, the towns of Center Harbor and Meredith and the city of Laconia,
8 Wards 1, 3, 4, 5, and 6; District 2, the towns of Belmont, Gilmanton, New Hampton, Sanbornton, and
9 Tilton; District 3, the towns of Alton, Barnstead, and Gilford and the city of Laconia, Ward 2.

10 II. Carroll: District 1, the towns of Albany, Bartlett, Chatham, Conway, Hart's Location,
11 Jackson, and Sandwich, and the unincorporated place of Hale's Location; District 2, the towns of
12 Madison, Moultonborough, Ossipee, Tamworth, and Tuftonboro; District 3, the towns of Brookfield,
13 Eaton, Effingham, Freedom, Wakefield, and Wolfeboro;

14 III. Cheshire: District 1, the towns of Chesterfield, Fitzwilliam, Hinsdale, Richmond,
15 Swanzey, Troy, and Winchester; District 2, the towns of Marlborough and Roxbury and the city of
16 Keene; District 3, the towns of Alstead, Dublin, Gilsun, Harrisville, Jaffrey, Marlow, Nelson,
17 Rindge, Stoddard, Sullivan, Surry, Walpole, and Westmoreland.

18 IV. Coos: District 1, the city of Berlin and the town of Milan; District 2, the unincorporated
19 place of Kilkenny and the towns of Dalton, Jefferson, Lancaster, Northumberland, Randolph and
20 Whitefield; District 3, the unincorporated places of Atkinson and Gilmanton Academy Grant, Bean's
21 Grant, Bean's Purchase, Cambridge, Chandler's Purchase, Crawford's Purchase, Cutt's Grant, Dix's
22 Grant, Dixville, Erving's Location, Green's Grant, Hadley's Purchase, Low and Burbank's Grant,
23 Martin's Location, Odell, Pinkham's Grant, Sargent's Purchase, Second College Grant, Success, and
24 Thompson and Meserve's Purchase, and the towns of Carroll, Clarksville, Colebrook, Columbia,
25 Dummer, Errol, Gorham, Millsfield, Pittsburg, Shelburne, Stark, Stewartstown, Stratford, and
26 Wentworth's Location.

4 Sugar Hill, Thornton, Waterville Valley, and Woodstock; District 3, the towns of Alexandria,
5 Ashland, Bridgewater, Bristol, Campton, Canaan, Dorchester, Ellsworth, Grafton, Groton, Hebron,

7 VI. Hillsborough: District 1, the towns of Bedford and New Boston and the city of
8 Manchester; District 2, the towns of Hudson, Litchfield, and Pelham and the city of Nashua; District
9 3, the towns of Amherst, Antrim, Bennington, Brookline, Deering, Frankestown, Goffstown,
10 Greenfield, Greenville, Hancock, Hillsborough, Hollis, Lyndeborough, Mason, Merrimack, Milford,
11 Mont Vernon, New Ipswich, Peterborough, Sharon, Temple, Weare, Wilton, and Windsor.

12 VII. Merrimack: District 1, the town of Bow and the city of Concord; District 2 the towns of
13 Andover, Boscawen, Bradford, Canterbury, Chichester, Danbury, Hill, Loudon, New London,
14 Newbury, Northfield, Salisbury, Sutton, Warner, Webster, and Wilmot, and the city of Franklin;
15 District 3, the towns of Allenstown, Dunbarton, Epsom, Henniker, Hooksett, Hopkinton, Pembroke,
16 Pittsfield.

17 VIII. Rockingham: District 1, the towns of Epping, Exeter, Greenland, Hampton, Hampton
18 Falls, Kensington, New Castle, Newfields, Newington, Newmarket, North Hampton, Rye, and
19 Stratham and the city of Portsmouth; District 2, the towns of Atkinson, Derry, Newton, Plaistow,
20 Salem, Seabrook, South Hampton, and Windham; District 3, the towns of Auburn, Brentwood,
21 Candia, Chester, Danville, Deerfield, East Kingston, Fremont, Hampstead, Kingston, Londonderry,
22 Northwood, Nottingham, Raymond, and Sandown.

23 IX. Sullivan: District 1, the town of Cornish and the city of Claremont; District 2, the towns
24 of Croydon, Grantham, Newport, Plainfield, and Springfield; District 3, the towns of Acworth,
25 Charlestown, Goshen, Langdon, Lempster, Sunapee, Unity, and Washington.

26 2 Application. No provision of this act shall be construed as affecting the constituencies or
27 terms of office of county commissioners presently in office. If there shall be a vacancy in a county
28 commissioner district for any reason prior to the 2022 state general election, the vacancy shall be
29 filled under the terms of RSA 661:9 from the same county commissioner district that existed for the
30 2020 state general election. The nomination and election of county commissioners at the 2022 state
31 general election shall be by districts as provided in this act.

32 3 Effective Date. This act shall take effect upon its passage.
