Readopt Saf-C 3600, effective May 14, 2014 (Document #10591), to read as follows:

CHAPTER Saf-C 3600 TOLL-FREE HOTLINE FOR DRUG-FREE SCHOOL ZONE

Statutory Authority: RSA 193-B:5, I

PART Saf-C 3601 PURPOSE

Saf-C 3601.01 <u>Purpose</u>. The purpose of this chapter is for the establishment and operation of a toll-free hotline for reporting information on drug activity within drug-free school zones.

PART Saf-C 3602 DEFINITIONS

Saf-C 3602.01 "Department" means the New Hampshire department of safety.

Saf-C 3602.02 "Division of state police" means "division of state police" as described in RSA 21-P:7.

Saf-C 3602.03 "Drug-free school zone" means "drug-free school zone" as defined in RSA 193-B:1, II.

Saf-C 3602.04 "School" means "school" as defined in RSA 193-B:1, III.

PART Saf-C 3603 TOLL-FREE HOTLINE

Saf-C 3603.01 <u>Hotline Telephone Number</u>. The telephone number of the department's statewide toll-free hotline for reporting drug activity within drug-free school zones shall be 1-800-NAB-DOPE or 1-800-622-3673.

Saf-C 3603.02 <u>Hours of Hotline Operation</u>. The hotline shall be answered by the division of state police 24 hours a day.

Saf-C 3603.03 <u>Publication of Hotline Telephone Number</u>. The statewide toll-free hotline telephone number shall be displayed on drug-free school zone signs pursuant to RSA 193-B:5, II.

Saf-C 3603.04 <u>Caller Information</u>. Any person who utilizes the toll-free hotline to report drug activity shall be asked for the following information:

- (a) Whether the activity is taking place within a school zone, and if so, the name of the school zone;
- (b) Whether the caller wishes to remain anonymous, and if not, the name, address, and telephone number of the caller;
- (c) Name, address and telephone number of the individual who may be possessing, manufacturing, selling, dispensing or possessing with an intent to sell, any controlled drug or analog, if known;
- (d) Physical description of the individual who may be possessing, manufacturing, selling, dispensing or possessing with an intent to sell, any controlled drug or analog; and
 - (e) Any other information the caller may wish to report.

Saf-C 3603.05 Dissemination of Information.

- (a) The chief of the law enforcement agency with jurisdiction over a school zone shall receive the information relative to drug activity within a drug-free school zone.
 - (b) Notification of the drug activity shall be by telephone.
