5. Short Title: Housing Champion Program

6. (a) Summary of what the rule says and of any proposed amendments including whether the rule implements a state statute for the first time:

The Department of Business and Economic Affairs (BEA) proposes to adopt Chapter Bea 500 on the New Hampshire Housing Champion (HC) Designation and Grant Program, which was established pursuant to 2023, 79:462, effective 7-1-23, in RSA 12-O:71-76, and whose purpose is to incentivize communities to create housing-friendly regulations and infrastructure by providing new funding sources for compliance. The Housing Champion Designation and Grant Program enables municipalities to voluntarily engage in the Housing Champion Designation process by creating housing-friendly regulations and infrastructure. Once designated, these municipalities will gain access to funding resources. The HC program in Chapter Bea 500 includes 4 components intended to reward towns for promoting and approving affordable, workforce housing. These components include:

- 1. <u>HOUSING PLANNING AND REGULATION MUNICIPAL GRANT PROGRAM</u> is designed to help municipalities meet the requirement of the program by establishing and/or revising land use regulations;
- 2. <u>HOUSING PRODUCTION MUNICIPAL (HPM) GRANT PROGRAM</u> awards grants for actual production on a per-unit basis for workforce housing units;
- 3. <u>HOUSING INFRASTRUCTURE MUNICIPAL (HIM) GRANT PROGRAM</u> awards grants for new construction on capacity increases for drinking water, sanitary sewer, stormwater, highway infrastructure, telecommunication, and electrical distribution infrastructure; and
- 4<u>. HOUSING INFRASTRUCTURE MUNICIPAL (HIM) LOAN PROGRAM</u> provides loans to HC Designation municipalities for new construction or capacity increases for drinking water, sanitary sewer, stormwater, highway infrastructure, telecommunications, and electrical distribution infrastructure.

The Housing Champion Designation and Grant Program shall be administered by the New Hampshire Department of BEA, contingent upon availability of funding.

6. (b) Brief description of the groups affected:

Groups affected by the rules adoption Bea 501 may include municipalities within the state of New Hampshire, for profit and nonprofit housing developers, private citizens affected by housing shortages within the state of New Hampshire. Involvement in the InvestNH Program is voluntary.
