Henry Lipman reported on Medical Expansion Financials – Medicaid Expansion DD and ABD Waitlist Quarterly Report – Associate Commissioner Chris Santaniello, Division of Long Term Supports and Services (DLTSS), and Jessica D. Gorton, Director, DLTSS-Bureau of Developmental Services, New Hampshire Department of Health and Human Services. (10:50 a.m. – 20 minutes)

Jessica Gorton explained presented the quarterly report (Fiscal Year 2024 Quarter 1):

- NH LEADS Data system ceased at the end of 2023
- NH Easy started July 1, 2023, and has since expanded
- Developmental Disabilities waiver, Home Supports waiver and Acquired Brain Disorder waivers were all fully funded in Q1.
- Service coordination is qualified, but not receiving funds at this time of this report

HB 2, Chapter 79:547 Laws of 2024, Developmental Services Pilot Program Semi-annual Report – Associate Commissioner Chris Santaniello, Division of Long Term Supports and Services (DLTSS), and Jessica D. Gorton, Director, DLTSS-Bureau of Developmental Services, New Hampshire Department of Health and Human Services. (11:10 a.m. – 20 minutes)

The semi-annual report was presented to the committee:

- 12 individuals applied for services in the pilot program
 - 6 were approved and granted service
 - It was mentioned the cost presented, \$545,903 was a lot of money and Rep Edwards asked for a breakdown
 - o 5 individuals were provided "Enhanced Family Care"
 - 1 was denied, but funding from another source was available

SB 118 (2019) Child Fatality Review Committee Annual Report – Marc Clement, PhD, Colby Sawyer College, Co-Chair, New Hampshire Child Fatality Review Committee, and Rhonda N. Siegel, MSEd, Section Administrator, Maternal and Child Health, Bureau of Family Health and Nutrition, Division of Public Health Services, New Hampshire Department of Health and Human Services. (11:30 a.m. – 20 minutes)

Rhonda Siegel presented the annual (2023) report from the Child Facility Review Committee:

- The purpose of this committee is to look at data and collective experiences to help answer how these deaths may have been avoided.
- Rep Merchant asked about any correlation between lack of facilities and child fatalities No data currently available and we hope to gather this over the next year
- The committee looks at deaths resulting from motor vehicles, poisoning/overdose, drowning, fire, falls and suffocation
- The report also looked at 191 infant (less than a year old) deaths in NH.
 - Ms. Siegel will look into the particulars associated with "Other Medical Causes" and "Unranked" accounting for 75 of the 191 infant deaths.
 - Deaths were primarily ruled "natural"
